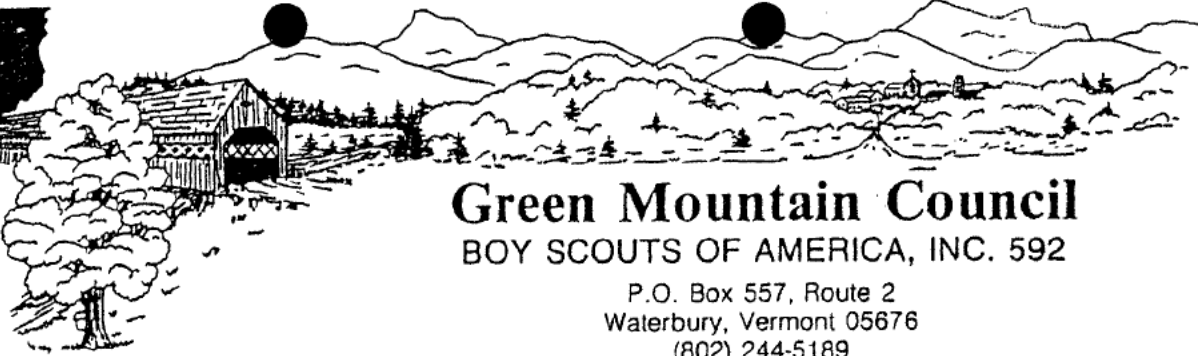

## Rutland Man, 36, Pleads Innocent To Lewd Conduct

A Rutland man, twice convicted of lewd assaults on Florida children, pleaded innocent Friday to lewd activities with four Rutland boys.

Robert L. Dewey, 36, of 16 Evelyn St. was jailed for lack of \$10,000 cash bail after pleading innocent to four counts of lewd and lascivious conduct with two 12-year-old boys and two 15-year-old boys.

Dewey was employed as a desk clerk at Howard Johnson's Motor Lodge.

Because there was no judge sitting in Rutland District Court Friday, Dewey was arraigned in Bennington District Court.

In addition to the \$10,000 bail requirement, Judge Francis B. McCaffrey set conditions of release which would require Dewey, if released, to report to the Rutland Police Department daily and would prevent him from associating with any male under the age of 16.

Dewey presents an "extreme danger" to the children of Rutland, Bennington County State's Attorney Raymond Bolton told McCaffrey during the arraignment.

All four boys involved were interviewed by Richard A. Fitzsimmons, a juvenile officer with the Rutland Police Department, and Michael Gray of the state Department of Social and Rehabilitation Services.

In each case, the boys were in Dewey's apartment when the alleged incidents took place, according to an affidavit written by Fitzsimmons.

The affidavit said the first youth, a 12-year-old designated "Juvenile A," said he had sexual contact with Dewey three or four times during July, August and September of this year.

Two of the alleged incidents began while "Juvenile A" was on the couch watching television with Dewey, according to Fitzsimmons. Another incident was allegedly initiated by Dewey while the boy was playing at Dewey's computer, the affidavit said.

During some of the alleged incidents described in the four affidavits, one boy would watch while Dewey engaged in sexual contact with another boy, according

to Fitzsimmons.

In the case of a 15-year-old boy described as "Juvenile B," Fitzsimmons said the alleged incidents began in the late summer of 1982 and continued until about September.

In addition to watching Dewey perform lewd acts in front of him "at least a hundred times," the affidavit said, "Juvenile B" said he had seen Dewey involved in sexual activity with three other boys.

"Juvenile B advised that he lived a great deal of the time with Mr. Dewey in the last year. Dewey provided a place to stay, food, cigarettes and a new bicycle.

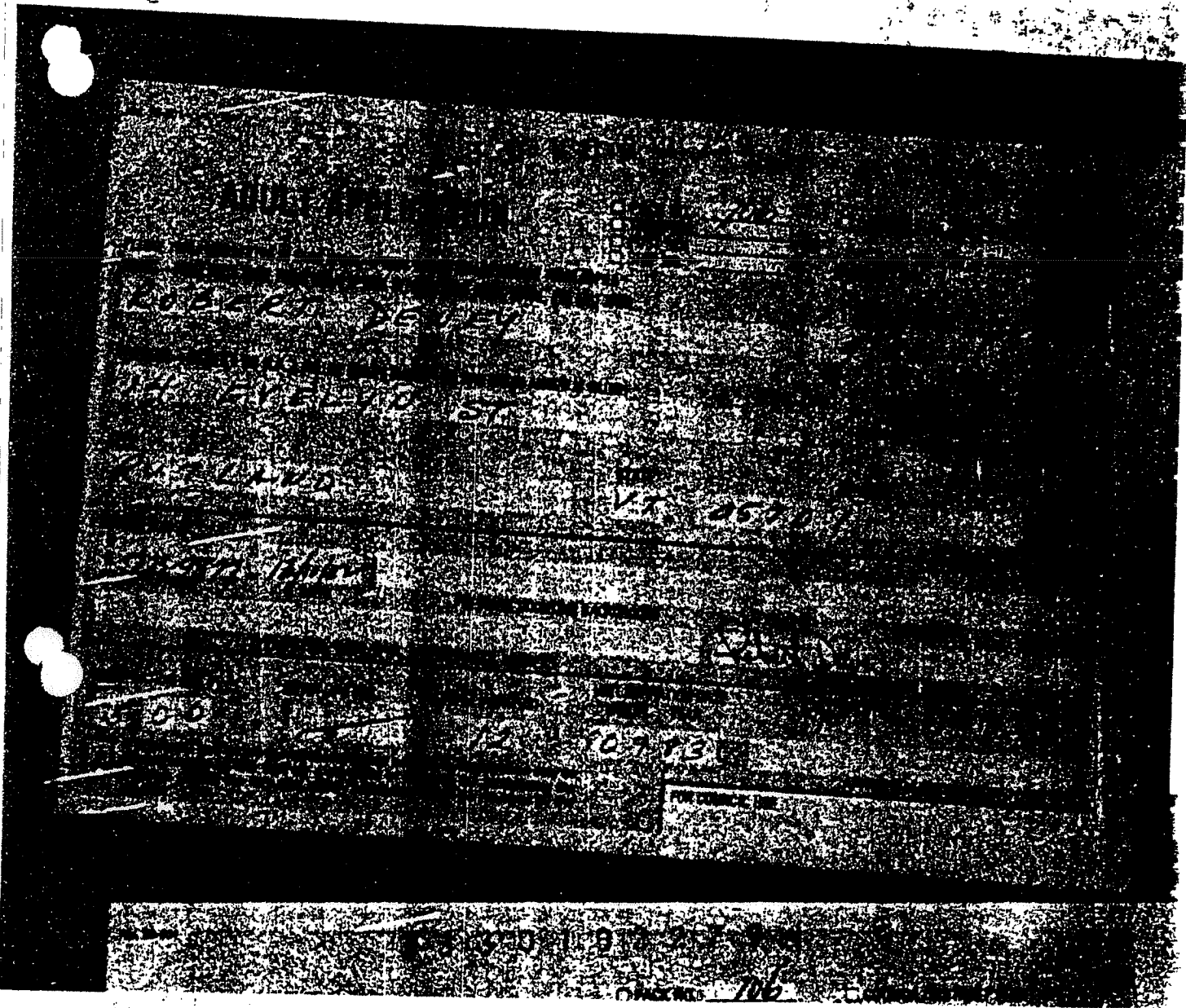
"Dewey also allowed Juvenile B to keep and look at sexually explicit magazines," the affidavit said.

The second 12-year-old boy told Fitzsimmons and Gray that he had sexual contact with Dewey three or four times this past spring, the affidavit said.

The boy, called "Juvenile C," said Dewey told him not to tell the police or his father of the incidents, the affidavit said.

The second 15-year-old youth, called "Juvenile D," told the investigators he had sexual contact with Dewey approximately three times in July and August of 1982.

Dewey faces total maximum penalties of 20 years on the four counts.

I trust this will suffice.

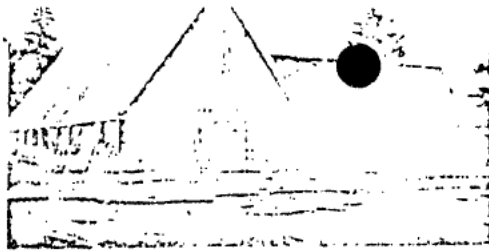

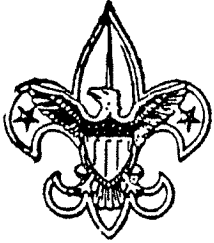
