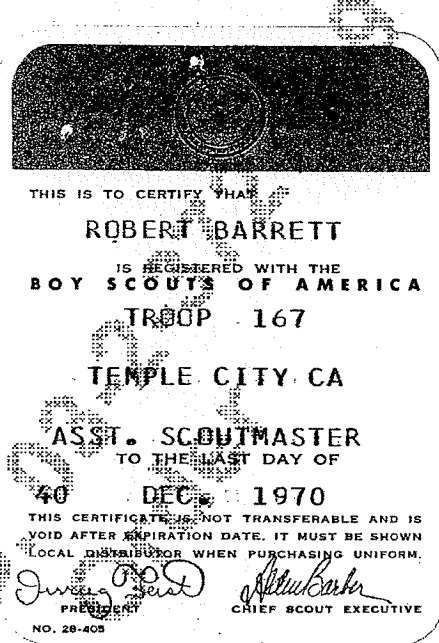



Dear Mr. McAdams:

Pursuant to our conversation on or about the 15th of August, 1969, the purpose of this letter is to relate to you the results of my personal inquiry into the reports of alleged fondling of two young scouts by Mr. Robert Barrett, Assistant Scout Master of Troop 801, Coronado, California.

On or about the 9th of June, information was relayed to me by Mr. [REDACTED], Scout Master of Troop 801, Coronado, California, presently on duty with the United States Navy and stationed at the Naval Amphibious Base, Coronado, California, that certain acts of an sexually aberrant nature had occurred between Mr. Barrett and two youngsters of Troop 801, [REDACTED] and [REDACTED]. In view of the serious nature of the charges alleged against Mr. Barrett, I felt it my duty to talk to both boys involved and to the Troop Committee Chairman, Mr. [REDACTED], Sr., and then communicate with Mr. Barrett.

On or about the 19th of June, 1969, I met with [REDACTED] at the Sacred Heart Parish Hall just prior to the Thursday night Troop Meeting and discussed the matter with him. [REDACTED] indicated to me that Mr. Barrett had on two occasions put his hands on or about [REDACTED]'s groin area and placed his hands inside [REDACTED]'s pants and then fondled his penis. The first of these occasions allegedly occurred on the last day of Summer Camp at Camp Hual-ca-culish in July, 1968. The second occasion occurred during a camp-out in March, 1969.

On or about the 23rd of June, I contacted Mrs. [REDACTED] and she brought her son [REDACTED] to my office for an interview. I spoke at length to [REDACTED] about Mr. Barrett and [REDACTED] stated to me that on a camp-out in March of 1969, (the same previously mentioned by [REDACTED]) Mr. Barrett had at that time, "pantsexed him." When I asked [REDACTED] what he meant by this term, he explained that four of them had been sleeping in Mr. Barrett's car together due to the cold rainy weather, and during the course of the night, Mr. Barrett had undone [REDACTED]'s pants and fondled him by placing his hand inside [REDACTED]'s pants and on his penis.
