Thanks for your help in this matter.

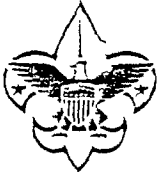

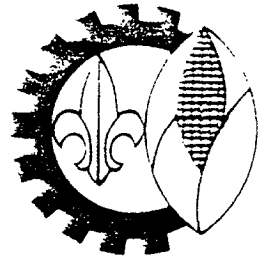

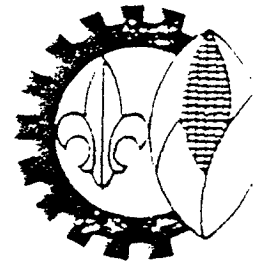
Dear Al:

Thanks for your help in securing a statement related to this matter.

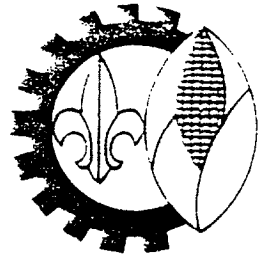



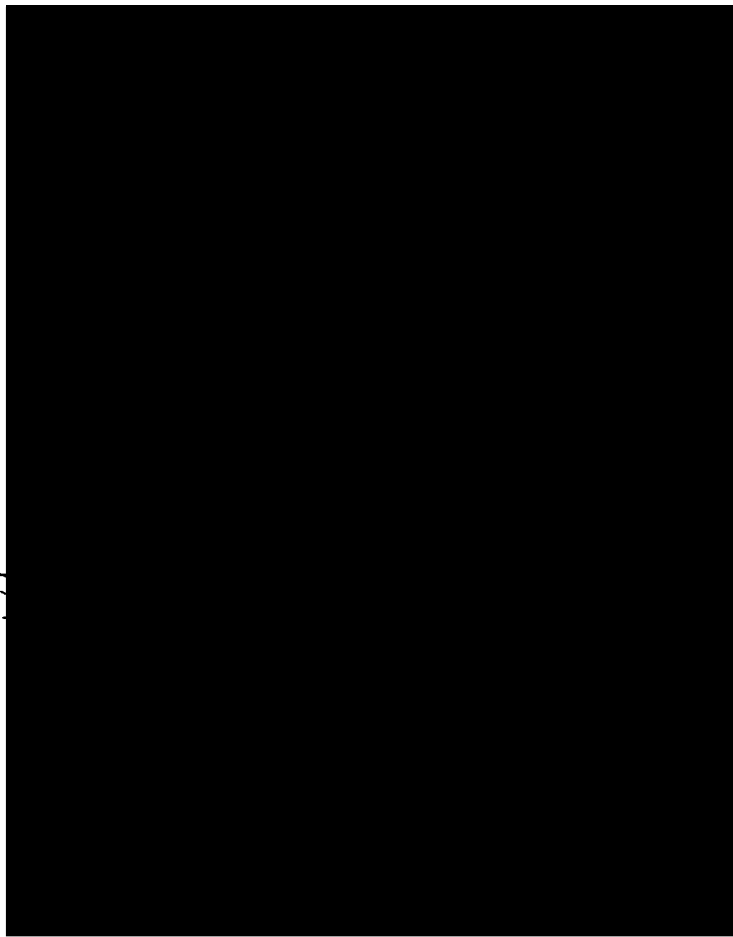
Subject: Your conduct at the Oct.1 campout.
