In regards to Bob Pine activities while on the radult staff of Camp Thunderbird, Tumwater Area Council:

We were conducting a week-long Jr. Leader Treihing Gourse at Camp, and Bob was to become an Assistant Program Director will be this summer, so he was assisting us with the program this week of June 13 - 20, 1005.

Bob would ask a boy if he wanted to go an a nature nike and then when away from the group, would start wrestling with them and and up playing with them. His other approach was to ask a boy to go winning, and in such a hurry that the boy was instructed to bring his swimming sult along the change later, and when the boy was changing, he would start wrestling playfully; then start assulting them. He worked this three times each, that we know all for sure.

We found out about these acts as one boywes telling another and a staff member overheard them and reported it to be, the Camp Director. When I investigated, I found the boys scared to the because they were afraid Bob Fine would beat them up. We also found out that this had happened within the broop he was working with before camp.

He claimed to be a student at Texas Western and to have grown up in Sen Deigo, California. He was in Hewhii before coming to this area in early March, 1965. While here, he lived with a friend by the mane of Dr. Iyman A. Fleetwood, dentist, and found work as partition help with the Lacey Fire Department. We found out later that he had been asked to leave because of a run in with other boys of college age.

He claimed to have worked in YMCA camps and Boy's Club Camps before, but we never checked his references. He was always mentioning that he would be a good person to take the boxs on a canoe trip or hike, and could not understand it when we said that was a thit leadership responsibility.

When I fired it and took him to town, he admitted being a queer. I asked him why and he shrugged his shoulders and the look on his face was that of a kid with him hand callest behind the candy counter.

This is all I know of Bob Pine, and hope that this is the information you need.


