Today in Savannah, Georgia, I met privately with former Scout in the BSA council headquartered here. The meeting was arranged by Council President J. Stephen Lewis who is an Attorney at Law with Beckman & Lewis, in Savannah. is now 22 years of age and preparing to enter graduate school at

described his three-year relationship with Robert R. Pomeroy who was at that time Scout executive of the council here. The relationship began when was about eleven and continued until he was fourteen. It ended when Pomeroy moved away, which was approximately seven years ago.

According to periodically would be invited to share the same tent with Pomeroy on camping trips and at outdoor events. Over time there was increasing physical contact such as hugging and stroking, and eventually Pomeroy would massage the boys's genitalia. After masturbating for the boy, Pomeroy would then do the same himself. There was never any oral copulation.

stated that Mr. Pomeroy gave special attention to about five other boys, but he could not be sure that they had similar experiences, except for one incident. One of the boys came to him in tears while at camp and described a similar experience with Pomeroy.

stated that this three-year relationship "messed up his life" and that he is currently undergoing counseling. Based on our frank discussion and from my observation, I believe is telling the truth. I asked for a signed statement and he is giving this consideration.
