The accompanying article was published in the Independent Journal on Monday, March 19, 1970.

On Tuesday afternoon, March 20, 1990, Mr. Martinelli called the Council Service Center and spoke with the Scout Executive and verbally gave his resignation from the Council Executive Board of the Marin Council, Boy Scouts of America and as a Trustee Member of the Marin Council Trust Fund.

Mr. Martinelli requested that his resignation also be announced to the members of the Council Executive Board at their regularly scheduled meeting on the evening of March 20, 1990. The resignation was announced at the Board Meeting by President-Elect William Bell, who was presiding in the absence of President Denman K. McNear, and accepted by the membership.

On March 20, 1990, Richard Parker, Assistant Regional Director of the Western Region was also notified by telephone by Area Director Steve Perry following discussion with the Marin Council Scout Executive and Paul Ernst, National Director of Registration, was then notified by telephone on March 22, 1990.

Marin attorney arrested in sex case

Independent Journal report

SAN RAFAEL — Roderick Patrick Martinelli, a prominent San Rafael attorney and former school board member, was arrested Sunday on suspicion of child molesting, sexual battery and drunken driving.

Police said Martinelli, 62, of San Rafael, was arrested after a 17-year-old Marin City boy complained that he made sexual advances to him.

Lt. Ken Hommen said the boy told officers he was at the bus station at Fourth and Heberton streets at 2 a.m. Sunday when a man drove up, tried to entice him into his car and asked for sexual favors.

After declining, the boy called police and the suspect's car was stopped a few blocks away.

Officers said Martinelli had apparently driven down the block and picked up a 21-year-old Hispanic man, offering him a ride. The young man told officers that Martinelli had fondled him sexually.

POLICEWATCH

Hommen said officers found Martinelli to be driving under the influence of alcohol. He was booked into Marin County Jail on suspicion of child molesting, sexual battery and drunken driving.

Martinelli, a longtime San Rafael attorney, was appointed to the San Rafael Board of Education in 1958 and was elected on his own three years later. He served as board president in 1961 and 1962.

He has long been associated with the law firm of Bagshaw, Martinelli, Corrigan and Jordan in San Rafael.

His father, the late Jordan Martinelli, was a longtime Marin superior court judge. The Martinelli House, a senior citizens housing development in San Rafael, is named in his honor.

Martinelli was released from jail after posting \$5,000 bail and was scheduled for arraignment April 4 in

Marin Municipal Court. He was sentenced to 30 days in jail.
