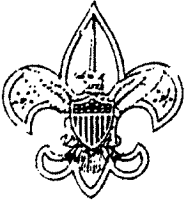

## Faces Charge

A 23-year-old Akron man who was acting as a leader for an Akron Boy Scout troop has been charged with sodomy involving troop members, according to sheriff's deputies.

Charged was Roger D. Vannoy, of 875 Beardley st. He is free on \$1,000 bond and is scheduled to appear Wednesday in Akron Municipal Court.

Deputies said the offense took place June 9 and was believed to involve 10 troop members aged 9 to 13.

The youths have been advised informally to see Juvenile Court psychologists, deputies said.

Vannoy was arrested after deputies interviewed the boys and their families.
