McMurry Pleads Guilty To Charge

Roger McMurry, 45-year-old former Municipal Court judge here, entered a plea of guilty to felony sodomy in 64th District Court Thursday and was assessed a three-year term in the Texas Department of Corrections at Huntsville.

District Judge John T. Boyd, hearing the plea at 3:30 p.m., assessed McMurry's penalty.

Formal sentencing will come within the next 10 days.

McMurry was charged specifically with sodomy — deviant sexual intercourse with a minor, in connection with some 13 incidents occurring in Plainview during the past year.

In other action in 64th District Court, Judge Boyd denied a motion asked by Cowboy Country club owners to rescind a ruling by the Texas Alcoholic Beverages Commission. The

Hale County Grand Jury Indicts 17

PLAINVIEW—The Hale County Grand Jury Monday returned 17 felony indictments including a charge of voluntary manslaughter against the proprietor of a private club here. The charge stemmed from a shooting incident late Sunday.

Jurors also renewed their investigation of a list of about 200 county residents whom Dist. Atty. Tom Hamilton alleges have made illegal application for welfare funds and are not qualified to receive the checks being delivered them.

No indictments were returned in the welfare investigation, in which Hamilton is seeking misdemeanor and felony charges of non-support against family heads who are illegally receiving checks.

Hamilton said he plans to file charges against 13 persons this week and will present their cases to the next grand jury session May 13. Approximately 15

cases will be considered at each session for the remainder of the year, Hamilton indicated. At the first session in February, Hamilton reported that only one of 15 cases investigated reflected cases of "valid" receipt of welfare. Charges were lodged against four persons.

Hamilton said he is unable to estimate the amount of money involved but hinted following the February session that it could mount into "thousands of dollars."

Jack Jackson, 38, of 126 Bullcock St. Plainview, was indicted Monday for voluntary manslaughter in the fatal shooting of Mrs. Alma Johnson, 27.

The incident occurred about 11:30 p.m. Monday at J. J.'s Club on N. Columbia St. where Jackson is the proprietor and Mrs. Johnson was an employe.

Plainview police were called to the club about 11:30 p.m. by a caller who reported an argument at the business.

When officers arrived, Mrs. Johnson was laying in front of the club with bullet wounds in the head, arm and hip.

She was taken to Central Plains General Hospital where she died at 4 a.m. Monday in the intensive care unit. Jackson was arrested early Tuesday and later released on \$2,500 bond.

Jurors returned an indictment against former Plainview Municipal Court Judge, Roger McMurry, 45, of Lubbock, on charges of deviant sexual intercourse with a minor. McMurry resigned his position with the city on FEB 26. Bond was set at \$1,500.

Two Lubbock men, Ober Lee Roberts, 23, and Robert J. Roberts, 21, were indicted on charges of breaking and entering in connection with the ransacking Feb. 23 of the home of Mrs. O. A. Stout southwest of Hale Center. Officers said Mrs. Stout reported being held hostage in the incident until she escaped. Both suspects are being held in lieu of \$25,000 bond each.

Jurors re-indicted two persons after earlier charges were invalidated. Al Thornton of Hale Center was indicted for voluntary manslaughter in the Jan. 1 shooting of Melvin Roberts, 21, of Hale Center. Roy Gene Booer, 22, of 1608 W. 22nd, Plainview, was indicted for rape in the Oct. 12, 1973, assault of an elderly Plainview woman. Booer remains in jail in lieu of \$25,000 bond.

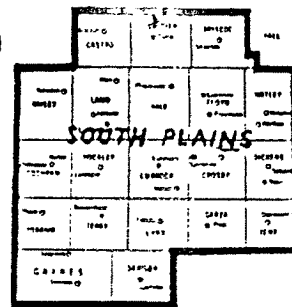


