The undersigned Deputy County Attorney of Cascade County, Montana, being first duly sworn upon her oath, moves the Court for Leave to File Information charging the above-named Defendant with the crime of SEXUAL ASSAULT, A FELONY, as specified in MCA section 45-5-502 (1985), committed at Great Falls, Cascade County, State of Montana, on or about October 4, 1985, and for said Motion deposes and says:

The Court is informed that on or about October 4, 1985, [REDACTED] spent the night with Roger Maddox. Roger Maddox lives south of Great Falls in Cascade County. Roger picked up [REDACTED] at the [REDACTED] home about 9:15 p.m. and took him to Roger's home. After arriving, [REDACTED] played video games upstairs while Maddox watched television. At about 10:00 p.m. [REDACTED] was getting ready for bed and Maddox came upstairs and also undressed, leaving on his undershorts. Maddox helped [REDACTED] undress also. Maddox then picked up [REDACTED] and put him in bed. [REDACTED] is fourteen years old.

[REDACTED] asked why Maddox had picked him up and Maddox said it was just to put him in bed. Maddox then got into bed with [REDACTED] and lay on top of him. Maddox then started rubbing [REDACTED] buttocks and legs. Maddox then went to sleep. [REDACTED] also went to sleep. Later [REDACTED] was awakened by Maddox again rubbing his buttocks and legs and kissing him. These advances occurred several times during the night.

the physical evidence recovered, that the Defendant, ROGER MADDOX,

did commit the crime of SEXUAL ASSAULT, A FELONY, in violation of MCA section 45-5-502 (1985); that said Deputy County Attorney has investigated the facts surrounding the charges against said Defendant and believes there is probable cause to believe that the Defendant committed the offense here charged; and all of which was done contrary to the form, force and effect of the statute in such case made and provided, and against the peace and dignity of the State of Montana.

Paul, County Attorney of Cascade County, Montana, states: that an Affidavit having been filed and Leave of Court having been granted for the filing of an Information and before the filing of this Information, the above-named Defendant, ROGER MADDOX, on or about the day October 4, 1985, at Great Falls, Cascade County, Montana, committed the offense of SEXUAL ASSAULT, A FELONY, as specified in MCA section 45-5-502 (1985).

The facts constituting the offense are: That the above-named defendant then and there being knowingly subjected [REDACTED] who was not his spouse, to sexual contact without consent, by rubbing [REDACTED] buttocks and legs and kissing him. The victim was less than 16 years and defendant was three or more years older, all of which is contrary to the form, force and effect of the statute in such case made and provided, and against the peace and dignity of the State of Montana.



Defendant.)

This deferred prosecution agreement entered into by and between the Cascade County Attorney and Roger Maddox, defendant, in the above-captioned cause, on this 29th day of April, 1987, with the following terms and conditions:

1. That during the term of this agreement defendant will comply with all laws of the State of Montana.
2. That the defendant herein agrees and admits that on or about October 4, 1985, in Cascade County, Montana, the State had sufficient probable cause to charge defendant with a violation of §45-5-502, MCA.
3. That said defendant, agrees to the deferment of his prosecution under said Information for a period of three (3) years.
4. That said defendant, agrees that for violation of the terms of this agreement he may be forthwith arrested and thereafter prosecuted and sentenced, and if convicted of the charges contained in said Information agrees that any delay in prosecution or sentencing by reason of this Agreement shall not constitute grounds for asserting that his Constitutional right to a speedy trial has been violated since such delay has arisen only at the specific request of

1 defendant by voluntarily executing this Agreement, and
2 defendant so agrees and stipulates.

3 5. That defendant agrees to enroll in an
4 appropriate course of counseling with a qualified
5 psychologist or psychiatrist of his choosing and complete
6 said course of counseling, the nature and duration of which
7 shall be determined by the chosen counselor. Defendant
8 agrees that the County Attorney shall be entitled to receive
9 reports from said counsel, and defendant further agrees to
10 provide to the County Attorney proof of his completion of
11 said course of counseling.

12 6. That this matter involves an allegation of
13 inappropriate behavior by defendant towards a young person,
14 which allegation defendant has denied. As a condition of
15 this agreement defendant agrees to maintain, in his
16 possession, a form which will be mutually approved by the
17 parties hereto. Said form will, in general terms, inform
18 the parents of young people who regularly come into
19 defendant's home of the fact that an allegation has been
20 made which places defendant under suspicion of wrongdoing,
21 even though defendant denies the allegation. Said form
22 shall be presented to, and executed by, the parent or
23 guardian of those children with whom defendant has regular
24 contact. Defendant agrees to answer questions, in a
25 forthright manner, which said parents may raise.

26 In addition, defendant agrees to maintain a list
27 of young people who visit his home together with the dates
28 of their visits. Both the forms and lists will be available
29 to the County Attorney upon request. They will not be
30 disseminated by the County Attorney's Office or used except
31 to monitor defendant's compliance with the terms of this
32 agreement.

1 No child shall stay overnight at defendant's
2 resident without written consent of said child's
3 parent/guardian until such time as overnight visits are
4 authorized by the counselor, above-referenced.

5 7. That the County Attorney, in consideration of
6 defendant not violating any of the above terms of this
7 agreement agrees that for a period of three (3) years from
8 the date hereof he will defer the prosecution of the
9 Defendant on the charge contained in the Information.


10 8. That it is further agreed that in
11 consideration of the defendant not violating any of the
12 terms of this agreement, and that his conduct during the
13 term of this agreement is such that his conduct warrants
14 such action, the County Attorney shall dismiss the charge on
15 file herein with prejudice.

16 9. That, it is further agreed by the County
17 Attorney that he shall not cause publicity of this agreement
18 to be made.
