PORTAGE — The Portage Township YMCA has adopted the following schedule for the fall programs. Participants can register at the YMCA office at 2712 Willowcreek Road. The phone number is 762-2012.

All swimming for the fall will take place at Portage High School West pool. If school is not in session, for whatever reason, the pool will be closed that day.

There is a maximum of four students per class and only two classes per time period. Enrollment is limited and early registration is suggested.

Fees are \$8 for full YMCA members, \$14 for full youth members and \$20 for primary members.

Aquasize will be offered in monthly sessions from 4 to 5 p.m. Mondays through Fridays. The fee is \$15 for full YMCA member and \$32 for primary members.

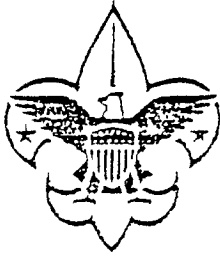

Dear Mr. Parker:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.
