

In addition to the statements, a telephone call was received yesterday from Detective Daniel Collhardt, Child Services Unit, Fairfax County Police Department. Detective Collhardt confirmed the indictment and conviction of Ronald Beard as charged.

## RONALD BEARD INFO

- 18 Dec 1987 Rob Chase(Scoutmaster of Troop 993) made Tom
  Jansen(District Executive) aware of child sexual
  abuse charges involving Ronald Beard(committee
  member of Troop 993). Bob Chase provided this info
  in person at the Marriott Scout Service Center and
  provided Tom Jansen with a letter relating details
  of the case(Attachment 1).
- 18 Dec 1987 Tom Jansen forwarded Chase letter and cover memo (Attachemnt 2) to Paul Davis (Scout Executive).
- 21 Dec 1987 Paul Davis requested Tom Jansen to obtain reports from the Court House (Attachment 3).
- 22 Dec 1987 Bob Chase telephoned Tom Jansen. He has the current membership card of Ronald Beard(this card was never given to Mr. Beard) and will mail it to Tom Jansen at the Marriott Scout Service Center. Chase confirmed the court date of Mr. Beard as being Feb. 23, 1987 and also reported that the county investigator of the case was Bill Wildon
- Tom Jansen visited Juvenile and Domestic Relations 23 Dec 1987 District Court, Nineteenth Judical District, Fairfax County, Virginia. He identified himself as a district executive of the Boy Scouts of America and requested information on the Ronald Beard case, but was denied. He completed a Request To Inspect Record(Attachment 4) of Ronald Beard, but was denied. Mr. Jansen then talked in person with the presiding judge of the case of Feb. 23, 1987, Michael J. Valentine(Chief Judge, Juveni<u>le &</u> Domestic Relations Court, 19th Circuit, Fairfax, VA 22030; Mr. Valentine confirmed that on Feb. 23, 1987, he instructed Ronald Beard in court that Mr. Beard is to have no contact with any juvenile other than. his own. Mr. Valentine also reported that the defense lawyer for Mr. Beard was Stewart Economou Alexandria, VA . Please note that requests to determine the nature of the charges against Mr. Beard and information on what charges he was found guilty of were denied. Apparently,
