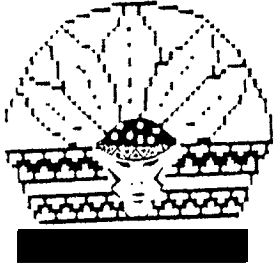

RE: State v. Ronald Christopher Scott

I have recently spoken with the prosecuting witness in the above titled case. Based upon this, we are prepared to recommend an active Youthful Offender sentence not to exceed six (6) years imprisonment. We do not feel probation is appropriate due to the nature of the offense. Also, I have spoken with the Solicitor's Office in Columbia who presently hold a criminal charge on Mr. Scott; and, they might be willing to run any sentence on their charge concurrent with a Youthful Offender Act sentence on our case.

Please discuss this with your client and let me know. We will not be able to try this case next week; but, if we can work out a plea, we can find the time to do the plea next week.

Please call me if you have any questions. If the plea cannot be worked out, the case may be called for trial during the week of July 8, 1991, before Judge C. Victor Pyle.

Thanks so much for your diligent help.

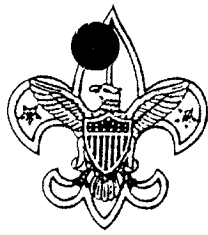

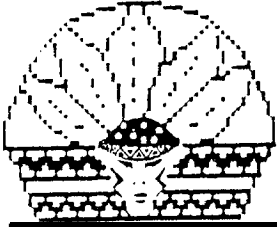

Thank you for your help in this matter.

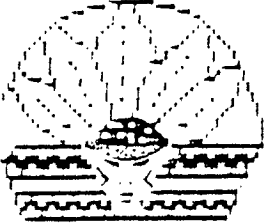

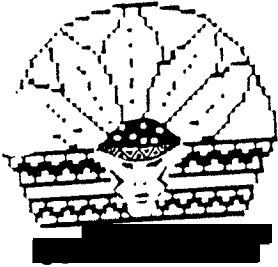

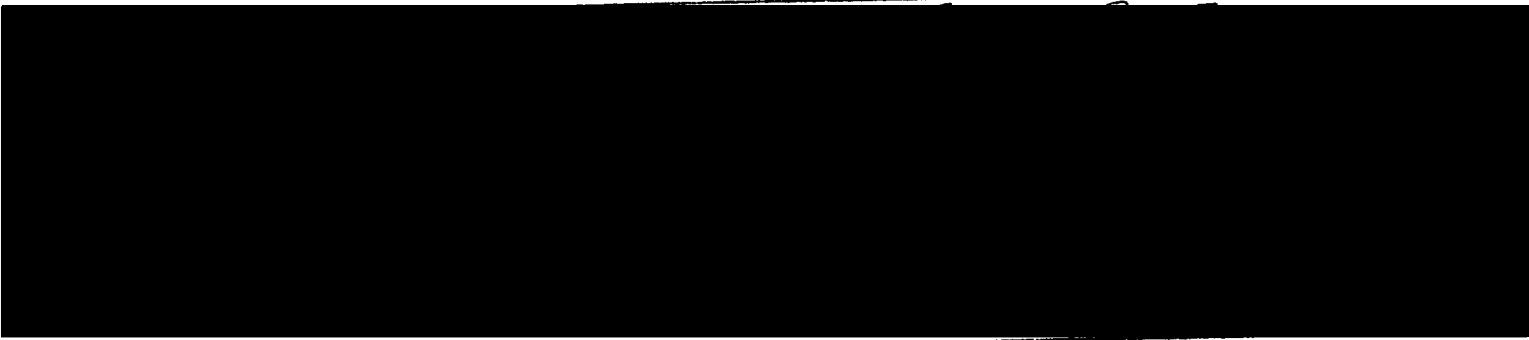

I proceeded to take his pants off and when I was about to start he threw up in the seat [redacted] it was blood. Statement of Suzanne F. Colbert

On June 23, 1990, around noon, Johnny Ray Marshall came to me and stated that some of the Explorers were concerned about Chris Scott. He stated that some of the boys had come to him about Chris getting too close to them and they were uncomfortable about it. They didn't want him sleeping in the same room with them. I told Johnny, we would take a look at the sleeping arrangements that night and make changes if we had to.

A short while later Howard Cook came and stated that some of the boys had said that Chris told them that he (Chris) might be bisexual and that he was confused. I told Howard we would talk to Chris and find out what was going on when we got back from the next competition that we had to go to.

At approximately 5:30 to 6:30PM Howard came to my room and told me that we had a very big problem and to sit down. He then told me that Chris had sexually assaulted [REDACTED] on Thursday night, Friday morning at around 2:00AM in room 418 at the Comfort Inn in Clemson, SC where we were all staying. Howard said that Chris had made the other 4 boys that were staying in the room leave. At this point we went back up to Howard's room and had Chris come to that room (410).

Present in the room were Johnny Ray Marshall, Rodney Gonzalez, Howard Cook and myself. As soon as Chris was brought in we told him to sit in a chair and I read him his rights from a Miranda card. Chris got upset and asked what he did. We told him that we knew everything about what he had done to the other boys and to tell us in his own words what he had done, when he had done it and how he had done it.

I am not sure in exactly what order of events that Chris admitted to and confessed to the assaults, but I will try to put them in the order as he stated them.

Chris stated that sometime in early April when [REDACTED] was taking him home he had him pull over behind a gas station on either Farrow or Fontaine Rd. He then coerced, and intimidated [REDACTED] into allowing him (Chris) to unzip his [REDACTED] pants, fondle his penis and then give him [REDACTED] a "blow-job".

Chris said that he told [REDACTED] if he ever told anyone, he would hurt him. Chris stated on another occasion when [REDACTED] was in the with [REDACTED] and Chris, that he had [REDACTED] pull over behind a Columbia Mall. Chris told [REDACTED] that he was going to have a girl that he (Chris) knew come and give [REDACTED] a "blow-job". Chris said he put a blindfold on [REDACTED] and got out of the car to "get the girl". Chris then stated that he waited a few minutes and himself returned to the car and car [REDACTED] a "blow-job". Chris stated that [REDACTED] realized after it was over that Chris had done it. Chris said he told [REDACTED] not to ever tell anyone or he would get back at him.

Chris stated he used intimidation, threats and scare tactics against the boys to keep them from telling anyone what happened. He said he also told them that he was very confused about himself. He told the boys that he thought he was a bisexual. Chris talked to the other boys individually and used the same lines and tactics with all of them.

Chris told us about assaulting [REDACTED] while he was staying at [REDACTED] apartment at Ravenwood. Chris stated that he had [REDACTED] call [REDACTED] and ask him if he could come over and stay at the apartment the night before Easter. [REDACTED] came over. Chris said that after [REDACTED] had gone to bed he and [REDACTED] were talking and Chris told [REDACTED] that he had a girl coming over to give him [REDACTED] a "blow-job". Chris told [REDACTED] that he needed to wear a blindfold or she wouldn't do it. Chris then put a blindfold on [REDACTED] and left the room. Chris said he returned to the room, sat down on the bed and gave [REDACTED] a "blow-job" himself. Halfway through Chris said that [REDACTED] pulled off the blindfold and made him stop. Chris said he then told [REDACTED] that he was confused, the he thought he was bisexual and not to tell anyone "or else."

Chris stated that he attempted to get [REDACTED] in a car one night, but that at that point [REDACTED] became upset and punched Chris and told him to leave him alone. Chris told him not to tell anyone, because he was very confused and thought he was bisexual.

Chris told us of another incident with [REDACTED] behind a building. He grabbed [REDACTED] and told him that he could never tell anyone or else he would hurt him. Chris told us that he forced four of the boys staying at the Comfort Inn in room 418 on the 22nd of June at 2:00AM to leave. Staying in the room were Chris Scott, [REDACTED], [REDACTED], [REDACTED], [REDACTED] and [REDACTED]. Chris told them all to get out. Chris said he acted mad and just told them to leave. When all the boys except [REDACTED], had left, Chris proceeded to get on the bed with [REDACTED], telling him "its only this time, no one will know, I don't want to hurt you". Chris then took [REDACTED] shirt off and removed his ([REDACTED]) pants. Chris then held [REDACTED] down and gave him a "blow-job". Chris said [REDACTED] got so upset that he threw up before Chris could finish. Chris then cleaned up part of the mess. Chris said he then sat on top of [REDACTED] and forced [REDACTED] to give Chris a "blow-job". Chris said that he threatened [REDACTED] not to tell anyone about what happened.

On June 23, 1990 at approximately 7:45 am, I, Johnny Ray Marshall was approached by [REDACTED] and [REDACTED] in the hallway on the fourth floor of Comfort Inn Hotel in Clemson, S.C. Both [REDACTED] and [REDACTED] said they were having problems with Chris Scott. I asked them what kind of problems were they having and [REDACTED] stated that Chris Scott came up to her, grabbed both of her wrists, held her close to his body and said something to her. I told [REDACTED] that maybe he was being too authoritative since he became Lieutenant. She also said that this has also happened to the others where he would get right up to their face and give them an order. I explained to both of the girls that the matter would be taken up with Chris Scott as soon as I told the other two Associate Advisors (Howard Cook and Gonzalez) about the incident. I also explained to them that if this sort of incident happened again, that they were to walk away and immediately tell one of the advisors. As I was walking down the hallway to room 410 where Howard Cook and Gonzalez were, Suzanne Colbert came out and told everybody to get down to the van.

It wasn't until approximately 6:30 pm that day after all the events at SCALE were completed that we were back at the hotel when I was confronted again in the hallway about another incident. This time it was [REDACTED], [REDACTED] and [REDACTED]. They explained to me that they didn't want Chris Scott around them. I ask them why. One of them said Chris Scott was gay. One of them said that Chris Scott would touch them in certain places. I asked them where was Chris Scott touching them and one said on the buttocks. Another one said that Chris Scott would take his finger and move it across their backs. The boys explained to me that this meant he was gay. At this point I told the boys that I was going to confront Howard Cook and Gonzalez of the incident.

As I walked into room 410 to explain to them of the incident, they said to me that some of the boys confronted them about Chris Scott. They also said that it was more than touching. As I was in the room with Howard Cook and Gonzalez to find out more information about what was going on, [REDACTED] knocked at the



door. He was let in and asked to have a seat. After [REDACTED] sat down, he began telling me, Howard Cook, and Gonzalez about an incident that occurred in Forest Acres in [REDACTED] apartment which was [REDACTED] located on [REDACTED]. [REDACTED] continued and said that several months ago he received a phone call from Chris Scott. He said that Chris Scott wanted him to come over to [REDACTED] house. [REDACTED] said he complied and went over. [REDACTED] said that while he was at the apartment, he and Chris drank some wine coolers. He also said that [REDACTED] and her boyfriend were in the bedroom asleep. [REDACTED] continued on and stated that Chris Scott said that his sister was coming over and she will give [REDACTED] a Blow Job. [REDACTED] stated that Chris Scott said that in order for his sister to give him a Blow Job, [REDACTED] had to be blindfolded. [REDACTED] said he was then blindfolded and placed on a bed that doubled as a sofa in the living room. [REDACTED] said that while he was laying there he heard the apartment door open and closed. [REDACTED] said that he could hear heavy foot steps and part of the bed going down as a person sat on it. [REDACTED] further stated that his pants was unzipped and the person began giving [REDACTED] a Blow Job. [REDACTED] said that he felt a heavy person on his legs and didn't believe it was a female. [REDACTED] said he removed the blindfold and noticed it was Chris Scott giving him Blow Job. [REDACTED] then said that Chris Scott was apologizing about what had happened.

After the story was told I walked out into the hallway and then down to where the elevator was when I was confronted by [REDACTED] and [REDACTED]. They told me that they didn't want Chris Scott around them because they were scared. I told them to go into their rooms and stay there and that we were having some serious problems with Chris Scott. After they left, the boys approached me and said they didn't want Chris Scott in the same room with them. They continued to say that they have a lot of problems with Chris Scott. I advised them that the problem was being taken care of and also told them to ignore Chris Scott if he confronts them.

I then knocked on the boys room door to find out where Chris was. Chris answered the door. As I walked into the room, Chris Scott asked me what was going on. He also said that some of the others were not talking to him. I explained to Chris Scott that if he was having problems with the others, he should talk to Suzanne Colbert. At this time he went over to the girls room looking for Suzanne Colbert. Suzanne Colbert answered the door and Chris Scott and I walked in. Chris Scott sat on the bed with Suzanne Colbert and I sat in

the chair behind Chris Scott. Chris Scott talked to Suzanne about some of the problems. Suzanne Colbert and Chris Scott talked for a few minutes. After the talk, Chris Scott left and I stayed behind. After the door closed behind Chris Scott, I told Suzanne that the boys were ignoring Chris for a reason. I also told Suzanne Colbert she needs to talk to Howard Cook and Gonzalez about a certain problem with Chris Scott.

As we walked out the door she told all the Explorers to go to the van for a cookout we were supposed to be at. When Suzanne and I walked into room 410, Howard Cook asked Suzanne Colbert to sit down. Suzanne asked Howard Cook if it was bad news. Howard Cook and Gonzalez then began telling Suzanne Colbert about what was going on. Howard Cook said that on June 21st in the boy's room, Chris Scott made [REDACTED] give him a Blow Job. Howard Cook also said that [REDACTED] didn't regurgitate because he ate some much pizza, it was because of the oral sex he had with Chris Scott.

Suzanne then said she didn't want Chris Scott around anybody. She also said she wanted to confront Chris Scott about the incident. Suzanne Colbert said their wasn't going to be any cookout and that they wanted everybody in their rooms. Suzanne Colbert told me to go down stairs and tell everyone to go to their rooms and also to bring Chris Scott up to room 410 at 7pm. I then went down stairs and told everybody to go to their rooms until one of the advisors came to get them. I then told Chris Scott to stay with me. Chris asked why and I told him that Suzanne Colbert, Howard Cook and Gonzalez wanted to talk to you about some of the things you did wrong in some of the events. I told Chris Scott to wait here with me while the others went inside. Chris Scott and I waited outside until 7pm and then proceeded to room 410.

As Chris Scott and I walked in room 410, Chris Scott was placed in a chair. Suzanne Colbert pulled out her Miranda card and read to Chris Scott his Miranda Rights. During the whole time his rights was being read to him, he kept saying "Whats going on, What did I do." After reading him his rights, Suzanne Colbert asked Chris Scott if he understand his rights. Chris Scott's reply was "Whats going on, What did I do". Suzanne Colbert again asked Chris if he understood his rights and she further stated answer yes or no. Chris Scott said "Yes". Suzanne Colbert then asked Chris Scott if he would like to have a lawyer present or if he would like to talk to us now. Chris Scott's reply was "I want to tell you what happended". Howard Cook then asked Chris Scott what did he know. Chris Scott explained in great detail about the incident with [REDACTED] that

happened in [REDACTED] and about another incident with some other Explorers that took place in Richland County's jurisdiction off of Fontaine or Farrow Road in [REDACTED] car. He said that he asked two boys to help him hold down another boy while he gave him a Blow Job. Chris Scott said that he told the boys that if they didn't comply, they would be next. The boys then held the arms and legs of one boy while Chris Scott gave him Blow Job in [REDACTED] car.

After he told us this incident, someone knocked at the door. Answering the door, it was Vicki, the advisor for Charleston County Sheriff's Department. She asked to speak to Suzanne Colbert. Suzanne Colbert stepped out in the hallway with Vicki for a couple of minutes and came back in. When Suzanne Colbert came in she told me that an advisor is needed downstairs for an advisors meeting in regards to a problems with High Risk Car Stop. She asked if I could go and I told her I would. I then grabbed a pencil and notebook and went downstairs to the advisors meeting.

After the meeting, I returned back upstairs and noticed several of the explorers were outside. I asked them what was going on. One of them replied that Gonzalez was in room 410 with Chris Scott and that Suzanne Colbert and Howard Cook were in the girl's room with [REDACTED]. They also said that they were very hungry and needed something to eat. I told them I would talk to Suzanne Colbert about getting the van so we can get something. I knocked on the girl's room door and was let in by Suzanne Colbert. Once inside, I asked Suzanne Colbert how did everything go. She said that they have talked to the Captain by phone. She also said that the local police was notified and was responding to take a report. I then asked for the keys to the van to take the others to dinner. Suzanne gave me the keys and their was a knock at the door. Suzanne opened the door and two police officers and an investigator walked in. At this time I walked out to take everyone to dinner.

On my return, I asked Suzanne Colbert how everything went and she said the officers took Chris Scott into custody and he will be in jail until someone bails hime out. I gave the keys to the van back to Suzanne Colbert and went back into my room.





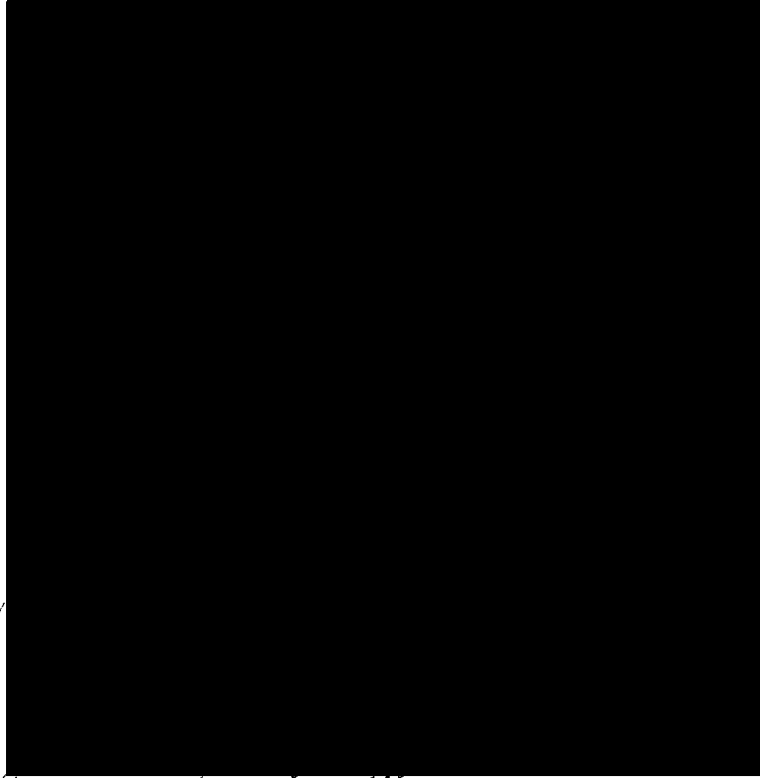
