
~~Kindly~~ Transmitted herewith, is information pertaining to Ronald Hubert and our request that he be placed in the "Confidential" File.





Listed below is the information you requested, in order that his name can be placed on the confidential list:

- 1.- He is registered in Troop 101 as Committee man and Post 8 as I.R. and member of the Committee (Post 8 is an all girls post)
2. He was arrested on March 10, 1974 for Incest 255.25 of the Penal Law which is a Class E Felony. He pleaded Guilty and signed a confession and was allowed to plead guilty to Sexual Abuse in the Second Degree a Class A Misdemeanor.
3. He will be sentenced in Hauppauge District Court on June 6, 1974— He is currently out on \$500 bail.
4. His wife is in the process of getting a divorce.
