Carder, just that all the subscribers will be treated equally.

"If we raise the prices for everybody in the city, we could also raise the prices outside the city," said Carder.

The city is seeking the merger in order to streamline bureaucratic procedures associated with the new city's growth, officials said. By absorbing the LCWD's responsibilities, the city can operate water services through its newly-created Public Works Department. Public Works Director Wilce Martin also would oversee road repairs, city parks and landscaping, and sewage

treatment facilities, officials said.

The city has sent notices to Dos Reis area residents describing their intention to continue providing services in the same manner as before, but Casteel said he learned during personal visits to the area that the affected subscribers don't understand the reason for the proceedings. Nor do they understand how proceedings will affect them, said Casteel.

"Most of 'em said 'no, I don't understand it at all,'" said Casteel.

Over three days time, Casteel said, he visited the rural homes on three roads — Dos Reis, De Lima, and Manthey — and obtained the signatures for a petition protesting the proposed detachment of the area from the LCWD. The petition appa-

rently was turned in during a legally-recognized 30-day public hearing period, but the city announced after the hearing had closed that the signatures are invalid because they were not dated.

"They're standing on a very thin technicality there," said Casteel. "Now all somebody has to do is file a lawsuit to tie that up."

Casteel said he did not know if he or any of the Dos Reis area residents would pursue the matter in court.

Casteel's attorney, Gerald Sherwin, said he had not been asked to represent the Dos Reis area residents and suggested he would be unable to represent them anyway.

"I would be concerned about a potential conflict of interest," said Sherwin.

## One year in county jail for molesting girl

STOCKTON (SJNS) — A Lathrop man charged with molesting a 10-year-old girl was sentenced Thursday to one year in county jail.

Ronald Kelly Pugh, 32, also received five years' probation as part of a plea bargain agreement reached in November.

Pugh was arrested Sept. 11 and charged with two felony child molestation counts and one felony count of victim intimidation.

Those charges were reduced to one felony child molestation count, to which Pugh pleaded no contest in Manteca Municipal Court.

Pugh was charged with molesting the girl, who formerly lived in Lathrop and now lives in Manteca, in August 1989. The attacks reportedly took place when the girl was at her babysitter's home, who was Pugh's girlfriend and is now his wife.

A man involved in Scouting, Ronald Pugh from Lathrop, has been convicted of molesting a child. He still lives in the home. A person who molests is a very sick person and a woman who allows a sick man to remain in the home with her children (not their children) is suspect.

Recently I read that [REDACTED], Ronald's wife, was honored as a Scout Leader. Where are these meetings between [REDACTED] and the scouts held? Does anyone ever just drop in on the meetings? Are you sure they are not being held in the Pugh home?

Is there any type of supervision given or work ethics of the Scouting employees ever verified? I can see a potential liability here, one that needs investigating from a source outside this area.

A last-minute plea bargain saved a 10-year-old girl from testifying further at a Thursday preliminary hearing in the child molestation case against Lathrop resident Ronald Kelly Pugh.

Pugh, 32, was arrested Sept. 11 by the San Joaquin County Sheriff's Department and charged with two felony child molestation counts and one felony count of victim intimidation. The surprise plea bargain allowed for one molestation count and the intimidation count to be dropped when Pugh agreed to enter a plea of no contest to a single charge of molestation.

"The victim was having a hard time," said District Attorney Lon Hansen, who was prosecuting the case against Pugh. "Looking at her psychological well-being, I think it was a good resolution."

The pony-tail clad victim, who was 9 years old at the time of the offense, testified early Thursday afternoon in Manteca Municipal Court, but burst into tears upon taking the stand.

Because of the fifth-grader's emotional upset, she was unable to answer detailed questions about the molestation and could not tell the prosecution what Pugh had allegedly done to her and cried each time Hansen asked her to describe what happened. The judge allowed for a "support person" to sit in the jury box close to the girl in hopes of encouraging her, but the girl shook her head and looked downward each time Hansen asked her if she could tell Judge Thomas Harrington where Pugh had allegedly touched her.

When it became apparent the girl would suffer by testifying, Harrington called into the chambers both the D.A. and Pugh's public defender, Elizabeth Schumb, so that a plea bargain could be hammered out. A previous plea bargain that included a six-year-maximum prison sentence was rejected only hours earlier by Pugh.

"Nobody here wants to put anybody through this," Schumb said after accepting the bargain and advising her client to enter a plea. By entering the plea, Pugh conceded that he had in fact done what he was charged with.

Pugh was charged with molesting the girl, who formerly lived in Lathrop and now lives in Manteca, in August 1989. The attacks reportedly took place when the girl was at her babysitter's, Denise Pugh, on the corner of J and Fifth Streets in Lathrop. At the time, the babysitter

was Pugh's girlfriend and is now his wife. Denise Pugh broke into tears when the girl began crying and later left the courtroom.

Just after school started in 1989, the girl sat watching television when Pugh reportedly took her behind the living room couch and molested her. Court reports indicate the offense was not discovered until the girl began to suffer problems at school and told a school counselor what had happened.

According to Hansen, the girl told Deputy Xavier Ordiz in 1989 that Pugh threatened to kill her parents and "take over her family" if she told anyone about the molestation, leading law authorities to tack on the victim intimidation charge.

That charge, along with one of the molestation charges, was dropped when Pugh agreed to plead no contest to a single charge of molestation. The new bargain includes a three-year-maximum prison sentence, but Pugh will probably not do any jail time, Hansen said.

"He'll probably get probation based upon his early admission," Hansen explained outside the courtroom. "The conduct is minimal as opposed to some very serious sexual conduct. It doesn't minimize the conduct, but there's a good chance he'll get probation and maybe a year in jail."

Pugh will be sentenced for the single felony charge at 8:30 a.m. Dec. 4 in San Joaquin Superior Court in Stockton. In keeping with his admission of the crime, he must now register as a sex offender in the area. If unsatisfied with the sentencing, Pugh may withdraw his plea and insist on a jury trial for the charges.

**Prelim hearing set for Manteca man**

A preliminary hearing is scheduled to begin at 1:30 p.m. Thursday, Oct. 4 in Manteca Municipal Court for Lathrop resident Ronald Kelly Pugh, who is charged with two counts of felony child molesting and one felony count of intimidating a witness.

Pugh, 32, was arrested on Sept. 7 and charged with molesting two siblings, a boy and a girl, in August 1989 while they were at their babysitter's, who was reportedly Pugh's girlfriend, according to court documents. The incident was not reported to authorities until the children reportedly had problems in school and told a counselor what had happened.

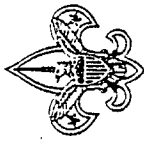
