



Mr. Griffin then wrote on behalf of the committee to Mr. Whitenight. This letter was mailed on May 17, 1989, and was sent as a certified letter which Mr. Griffin states that Mr. Whitenight did receive. Mr. Whitenight did not respond in any way to the Troop 13 letter, according to Mr. Griffin.

The Scout Executive was not informed of this situation until September 13, 1989.

The information regarding statement was provided by Mr. Griffin and Scoutmaster Scott Price. Mr. Griffin verified the names of the committee members and leader present at the May 9, 1989 meeting.
