

On May 31, 1989, I met with Alan Pruitt, Minister, McMurray United Methodist Church, 25 Eugene Field Road, Claycomo, Missouri, 452-4020, at his request. Rev. Pruitt advised within the last week he was made aware that a member of his church and Assistant Scoutmaster of his church's Troop 215 was under investigation. Rev. Pruitt knew that legal papers had been served on the person in question and he had been removed from the home.

Jones is currently registered as Assistant Scoutmaster (#157397) with Troop 215, and as a youth member (#121350) of Post 2288, Northminster Presbyterian Church, 1441 N.W. Englewood.

At the present time I am attempting to determine the status of Jones within the criminal justice system.

Rev. Pruitt also stated Jones' father is currently registered as Troop 215 Scoutmaster. In the vest interest of the troop and church, Rev. Pruitt will encourage the father to resign his position with the troop. If he doesn't resign, he will be replaced.

I spoke with Rev. Pruitt on 6-1-89; he will inform Sam Jones by letter of his removal as Assistant Scoutmaster. He will forward a copy of the letter to use for our files.
