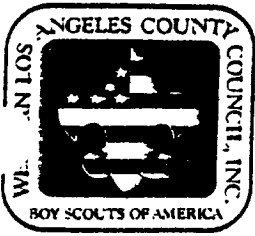


Dear Paul:

Documentation Of Meeting with Samuel Becker

On Thursday, August 8th, I became aware of problems in the past history of Samuel Becker, the Committee Chairman of Cub Pack 721. These allegations were proven correct and I was instructed to deny the registration of Samuel Becker.

I called Sam at his place of business, Community Thrift and Loan, on Thursday afternoon and arranged for a meeting on Friday at 5:00 p.m., at his office. I then called Jacques Behar, the Cub Master of Pack 721 and ask him to accompany me at this meeting. I gave Jacques only the bare information he needed to realize the gravity of the situation and the steps we must follow.

We arrived at Samuel Becker's office at 5:00 p.m. on Friday, August 9th and I suggested we go outside to have a discussion. We walked down the street and sat around a table and I informed Samuel that his registration with the Boy Scouts of America has been denied. I also gave him a refund check of \$7.00 for his registration and a page with the procedures for filing a appeal with the Boy Scouts of America.

Sam became angry and asked why after four years of being a good leader this suddenly is brought to his attention. I informed Sam that upon reviewing his application, his application had none of the information listed that there was a problem in his past and then now has come to my attention. Sam threaten civil and legal action against persons bringing this to our attention. I explained to him that we were not passing judgement and he had a right to appeal, but until that appeal was satisfied, he has to sever any relationship with the Boy Scouts of America.

Sam informed me that he has a son in the Cub Pack and he would continue with his son. I recommended strongly to Sam that until these matters are resolved he have nothing to do with Cub Scouting and Boy Scouting. I again said to Sam that common sense would dictate that you would not put yourself in a situation that could be viewed as a conflict. He thanked me for my recommendation, although he said he probably would not follow it. Jacques and I left the meeting at 5:30 p.m. and I went home.

The above statement is true and correct to the best of my knowledge.

Re: Child Abuse Case - Samuel Jesse Becker

From: Gene Richey, Scout Executive

On this date, I was called by [REDACTED] of San Fernando Valley. [REDACTED] stated that she was a little apprehensive in making this report but felt that it was in the best interest that we be aware of the criminal record of one individual that she has come in contact with.

[REDACTED] related to me that they were going through a custody battle or court case in reference to her husband regaining the rights of his child, by a previous marriage, and it was noted that his ex-wife was living with Samuel Jesse Becker of Canoga Park. [REDACTED] related to me that this individual had been arrested on three or four occasions for (flashing, expositionism) and was presently under psychiatric care) - She felt that he also had an additional record for child abuse, and child molestation, but did not know about the case.

I immediately went to our registration department and pulled from the file the registration papers for Pack 721 of Canoga Park and found Samuel Jesse Becker was registered as a committee chairman with that unit. Taking the registration packet and the individual application, I called David Wells, Assistant District Attorney in the Santa Monica District Area to have a check on his background. I related to him his name and drivers license number. After a period of two hours I received a return call to verify that Mr. Becker has quite a record in regards to child molestation and had served a prison term and that he had been arrested and was on a probationary period for his expositionism "flashing".

Upon receipt of this information I requested that the Director of Field Service take immediate action to remove Mr. Becker from our program and file a letter with him in regards to the fact that he would not be registered with the Boy Scouts of America.

This will be kept on file for the necessary period of time.


Dear Samuel:


