The following information is provided should you desire a review by the East Central Region, Boy Scouts of America, of the decision to deny your registration.

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to: East Central Region, Boy Scouts of America, 230 West Diehl Road, P. O. Box 3085, Naperville, Illinois 60566-7085. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
2. Upon the receipt of your written request, a committee will be appointed to review the situation.
3. If the regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you are dissatisfied with the decision of a regional review, you may request a further review by the National Council. The decision of the National Council will be final.

The second situation has just come to light in the newspapers. Charges have been brought against a long tenured Scoutmaster alleging criminal sexual conduct and serving alcohol to minors. The Scoutmaster in question has been Scoutmaster for Troop 668 since 1972. This troop is chartered by the Christian Faith Baptist Church in Detroit. This situation was brought to my personal attention when a mother and her son came to see me on Tuesday afternoon, February 12. The boy told me about two occasions with the accused on January 28 and February 6 of this year. The mother said that the information they were sharing with me had been given to the Detroit Police Department the prior day.

I had scheduled an appointment with the accused on Friday morning, February 15, for the purpose of informing him that he was being denied registration with the Boy Scouts of America. That appointment was canceled at the request of the Detroit Police Department with whom we have been cooperating in their investigation. The youth who came to me was a Scout in 1988 but has not been registered since February 1989. As part of our cooperation with the Detroit Police Department, we provided them with past rosters of the membership of that particular Scout troop. Their investigation to date has resulted in the identification of a second youth who is a current member of the Scout troop. It is our understanding that the police have questioned all youth on the current roster and none of the other 26 youth have indicated any sexual involvement with the Scoutmaster. It is also our understanding that all of the charges resulted from events which took place at the Scoutmaster's home and not at any Scouting meeting or activity.

Enclosed are copies of the newspaper articles that have appeared to date on this situation. As of this date, we have not been contacted by any media other than the Detroit News. The accused has been involved in Scouting in this council since the mid-1950's. He has been a Scoutmaster since 1959 and has served as a National Jamboree leader on several occasions and as a Philmont Troop leader. He was presented the Silver Beaver in 1970. The council has now denied the accused the right to register with the Boy Scouts of America and his registration fee has been refunded. The National Council has also been advised. We are now working closely with the pastor and with the troop committee from Troop 668 in helping them with the process for the selection of a new leader and the scheduling of a parent's meeting for the parents and Scouts currently involved in the troop.

The Scout Executive serves as the official council spokesman for both of these situations. As a side note, you should know that these are the first two accusations of this type since my arrival here in December 1987. During that time we have had at least 30,000 different adults actively registered in Scouting leadership roles in the council.

Rape charges against Scout chief stun minister

Rape charges brought this week against a 72-year-old Detroit scoutmaster with 37 years of service in local Boy Scout organizations have "astounded" the minister whose church sponsors the troop.

"I'm trying to come to grips with this," said the Rev. Levert Shell, pastor of the Christian Faith Baptist Church on Puritan. "We have so much to do to reassure the parents."

Samuel Lee Cooper, a retired Ford Motor Co. inspector, has been charged with 15 counts of rape and three counts of furnishing alcohol to minors in two separate cases involving 15-year-old boys. He could face up to life in prison if convicted.

One of the victims is a member of Troop S-6008, which is chartered to Mr. Shell's church. The other victim is a former member of the troop. Mr. Shell said he is in the process

of contacting parents of scouts. Most of the 27 teen-agers in the troop are not church members, he said, but the troop meets at the church during the summer months and church members are actively involved in overseas troop activities.

"Mr. Cooper came highly recommended," Mr. Shell said. "I didn't think there was much need to check out his qualifications. This is going to make me very cautious."

Cooper was arraigned on the first rape case Monday. He stood mute at his arraignment on the second case Wednesday in Detroit 36th District Court. Magistrate Charles P. Hammons entered an automatic plea of not guilty for Cooper and ordered him held in the Wayne County Jail on a \$50,000 bond. His preliminary examination is scheduled for March 4.

Assistant Wayne County Prosecutor Margaret Rymter argued for a higher bond for Cooper, saying the suspect had contacted the victims'

families by phone and by letter prior to his arrest. According to court files, one of the letters was accompanied by a \$1,000 check.

The boys told police Cooper served them mixed drinks and then forced them to have sex during overnight stays at his home on Cloverlawn, court files said.

Bob Shoemaker, scout executive

for the Detroit Area Council of the Boy Scouts of America, said the organization officially removed Cooper from its registration rolls this week. A search already has begun for a new leader for the troop, he said.

Cooper has been involved in local scouting activities since 1954, Shoemaker said. He has been scoutmaster of Troop S-6008 for at least six years.

Two boys, 15, say scoutmaster, 72, raped them

Two 15-year-old Detroit boys have told authorities that their 72-year-old scoutmaster sexually assaulted them during separate overnight stays at his house.

Samuel Lee Cooper was charged with three counts of rape in a case involving one of the teen-agers. He was arraigned Monday.

Detroit 36th District Magistrate Richard Halloran entered innocent pleas for Cooper and set a preliminary examination for Feb. 27.

Cooper was released after posting 10 percent of a \$50,000 bond. However, authorities said he could be ar-

raigned today on a second rape case involving the other youth.

Tuesday, 36th District Court Magistrate Charles P. Hammons authorized a warrant charging Cooper with 12 counts of rape and three counts of providing alcohol to a minor.

Cooper could be sentenced to life in prison if he is convicted on any of the first-degree criminal sexual conduct charges.

According to court documents, the first youth said Cooper invited him to spend the night at his home on Cloverlawn last Jan. 28.

The teen-ager told police Cooper served him five mixed drinks, then told him to sleep in the older man's bed. When the youth awoke, he said, Cooper was raping him.

A week later, Cooper called the boy at home and again asked him to spend the night. The youth said Cooper assured him he wouldn't approach him sexually, but later in the evening, when they were watching television, Cooper again molested the boy. The teen-ager said he resisted, and Cooper eventually left him alone.

The second youth told police that Cooper sexually assaulted him at least six times between January and April 1990.

Cooper served him mixed drinks and asked him to watch television in his bedroom, the 15-year-old said. The youth also said Cooper repeatedly told him not to tell anyone.

Law enforcement sources said Cooper has been involved in scouting programs for 40 years.

DETROIT — A 72-year-old scoutmaster accused of repeatedly raping two 15-year-old boys was arraigned Wednesday on 12 rape charges involving one boy.

Samuel Lee Cooper of Detroit is accused of having both boys spend nights at his house, giving them alcohol and raping them. Court records describe one boy as a member of Cooper's troop.

On Monday, Cooper was arraigned on rape charges involving the other boy.
