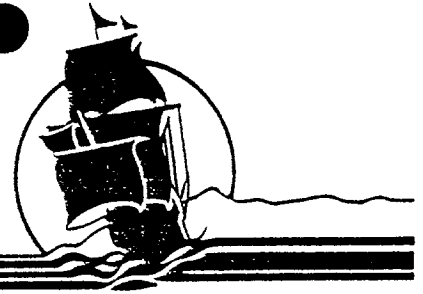

On January 9, 1991, I met with two Scouts and committee members of Troop 44 chartered to the Congregational Church in Randolph, MA. Also attending the meeting was Attorney Stuart Romm, chairman of the council's youth protection committee. This meeting was called after I had had discussions on the previous two days with Dennis Wood, chairman of the Scout committee and [REDACTED] parents of one of the Scouts.

Seventeen year old [REDACTED] reported the following: Then sixteen years old, he spent the weekend in October 1990 at the apartment of his Scoutmaster, Scott C. Estey in Brookline. The purpose of the weekend was for the two of them to "work" on craft items for the Indian lore merit badge.

They spent time with the crafts during the day. In the evening, after viewing two rental videos, Estey brought out and showed a "pornographic" video, which [REDACTED] described as very graphic sexually. He engaged the boy in a conversation about masturbation. They went to bed; Estey offered the boy a towel and suggested that he might want to masturbate. Then, Estey masturbated in the presence of [REDACTED]

Estey, while suggesting a more intimate encounter, did not physically touch [REDACTED]. In the morning, Estey did touch [REDACTED] when he began tickling him. Estey did give [REDACTED] a hug. After rising Estey took a shower and then

walked around the apartment nude and in the presence of

did not cooperate in any of Estey's advances.

Several weeks later, [redacted] confided this experience with his girl friend, who encouraged him to talk to his parents about the incident. The girl friend discovered that a mutual friend and Scout had a similar experience with Estey. The second Scout is sixteen year old [redacted]

[redacted] reported to me that he had a similar experience with Estey at Estey's apartment on November 12, 1990. Estey discussed masturbation with [redacted] Estey took a shower with the door open and walked around nude. He also suggested that [redacted] shower with the door open, but [redacted] closed the door.

Estey tickled [redacted] in the morning. [redacted] brushed off all of Estey's advances.

A third person, [redacted], who is no relation to [redacted], stated that two years ago when he was seventeen, Estey introduced the subject of masturbation with him. Nothing developed from the incident, but it caused him to be suspicious of Estey and when he heard that [redacted] had spent the night at Estey's apartment, he alerted [redacted] older brother of his suspicions.

On Jan 10, I met with the parents of [redacted] and [redacted] and the troop committee. I offered to arrange for a counselor to meet with the individual Scouts, and/or the other Scouts as a group, and the parents to address the issue and deal with post traumatic syndrome.

Scott Estey was removed as Scoutmaster by the committee chairman on January 8. His letter is included.

On the morning of January 11, I notified the Massachusetts Department of Social Services, the Northeast Region of the Boy Scouts of America, and Patricia M. Nigrelli of the District Attorney's office. The pastor of the church, Rev. Bowler, was consulted about the incident by the committee chairman, Dennis Wood. Also I removed his name from all committees and activities in the Old Colony Council.

On January 14, 1991 Attorney Elliott Fine called me and stated that he was representing Scott Estey. He stated that Estey wished to cooperate with the BSA and offered to resign from the BSA and wished that a letter from him be placed in his file.

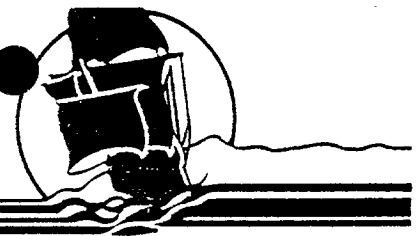
I arranged to meet with Attorney Fine and on January 14, 1991 delivered a letter for Estey severing his relationship with the BSA and returning his registration fee. I accepted a letter from Estey which is included in the file.

Fine stated that all troop records and property would be transmitted by Estey to Dennis Woods by committee person Marc Richman.

Also on January 14, Dr. Williams, psychiatrist at Massachusetts General Hospital, met with the Scouts in the troop. According to Dennis Woods, he was invited by one of the parents. At my invitation, Fr. John Burke, director of the Family Counseling Center in Braintree met with the parents.

[REDACTED] told me on Jan. 14 that he was very satisfied with how the council responded and how the parents were so supportive.

Dear Mr. Estey,

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.




Dear Mr. Kiernan,
