Dear Paul,

I am enclosing a confidential record sheet on Scotty Hyrum Mortensen of , Salt Lake City, UT. I have recently been advised by the Salt Lake County Sheriff Department that they have what they believe to be convincing evidence that Mr. Mortensen, prior to 1987 was involved in at least three different acts of child sexual abuse. They are unable to charge Mr. Mortensen with this crime and he is unwilling to confess to doing so because the boys with whom he has been involved refuse to testify against him. One of the boys has become so disturbed that he has run away from home. The LDS ward to which he belonged have removed him from all involvement with their youth. It is the feeling of the Salt Lake Country Sheriff Department and one with which I concur, that Mr. Mortensen should be placed on our confidential list and not be involved in any leadership position in Scouting. He does have a son in Cub Scouting and an older son in Boy Scouting.

The Salt Lake County Sheriff Department has agreed to keep me advised if anything further develops on this matter but they believe that now where the boys and the boys parents will not testify and Mr. Mortensen will not confess, there is nothing further that they can do but watch his actions closely.
