

Dear [REDACTED]:

This will confirm our two telephone calls over the last four weeks concerning the alleged incident between you and another volunteer Scouter. Since the issue is of such a delicate nature I will not undertake to outline your allegations at this time. As I indicated to you I have discussed the matter in detail with Jack Terwilliger and Dan Maxfield since they are members the Key 3 of this Council. We have also conferred with the National Council for advice on how to handle a matter such as this. After much deliberation we have decided the following:

1. Before any further action can be taken we must receive from you a written summary of the alleged events. Please feel free to be as specific as you desire. The more specific you are the easier it will be for us to deal with the matter. It will be necessary for you to sign and date the summary. Until we receive the written summary no further action will be taken.
2. Upon receipt of the written summary we will immediately discuss the matter with the other Scouter involved. If he admits to the correctness of your allegations appropriate disciplinary action will be taken. Your allegations are most serious in nature since they involve harm to other persons and you can be assured that any disciplinary action will be appropriate.
3. If the other party denies the allegations we will call a meeting and have the two of you meet together so that an open and frank discussion can be held. This will help us to come to a conclusion in this matter.



A written record of the following incident is being provided at the request of Jack Terwilliger, Sequoia Council Executive

On Saturday, September 28, 1985, I participated in a Cub Scout Division Meeting in Coalinga, Ca. I traveled to Coalinga with Mike McKay, Marvin Steed, Everett Rose, and Stan Nakanishi, carpooling in Mike McKay's van. Another group also went to Coalinga from Fresno for this meeting.

We left the Fresno Scout Office at 8:00a.m., having left our cars at the Scout Office. The meeting in Coalinga was held at the Church of Jesus Christ of Latter Day Saints. The meeting lasted until 12:15 P.M. Two of the ladies from the other carpool group talked about stopping for lunch on the way home. Our carpool group started home and no mention was made of stopping for lunch.

I am a diabetic, on 250mg Tolinase, taken twice daily. Due to this disease, and the taking of medication for the control of diabetes, I must eat at regular intervals, or compensate for the medication by eating candy.

At about Kerman, on the way back, I started eating some Necco Wafers, and when we arrived in Fresno, still had some of the Candies left. When we arrived back at the Scout Office, everyone went to their respective cars, and dispersed. Stan's pickup and my car were parked side by side, and as we went to our vehicles, we discussed the meeting we had just attended, talked about summer camp, and how good it had been for me to be able to volunteer at camp for the summer, and at that time Stan remarked how good he thought I looked for having lost more weight this summer. As I turned to get into my car, Stan turned and grabbed my left breast, and squeezed it, then took hold of my right breast, squeezed it, nibbled on it and said "You should let me suck on it for you sometime". I said "Now, Now, Stan, you know better than that No!" Stan had his head hanging down, backed away and said "Sorry", and let go of me. He stepped away and said something about my giving him some candy. I said "You want candy, I'll give you some candy, let me get my purse". I opened the car door and reached across the seat to get my purse from inside, and at that point, Stan came close to me between the open car door and the door post. By then I had gotten the Necco wafers from my purse, and turned around and offered them to Stan. He said "No", took a big puff of his cigarette, turned around and went to his truck, got in and drove off.

I was taken by such surprise and shock by what had just happened, I just froze. I couldn't react. When Stan turned to get in his truck, I got in my car and drove home. When I arrived home, I started to change from my Scout Uniform, and noticed my blouse was wet where Stan had nibbled on me. I was so upset and confused that after changing, I got in my car and drove all over town, trying to avoid having to go home. I was afraid Stan might come to my apartment, and all I could think of was that I didn't know what to do. I didn't want anyone to find me.

I later discovered the dual meaning of his asking for candy, which upset me even more. Recalling that Stan had told me he was a trained expert and instructor in Jungle Survival during W.W.II, and a karate expert, I feel I was in a very threatening situation.

More so than I first realized. This incident has changed my relationships and involvement with other people in Scouting, and has affected my participation in those commitments which I have enjoyed serving on in the past. I am afraid of another encounter with Stan and hesitate to participate in those activities at which I know he is likely to be. As a consequence, I did not fulfill my obligation as Cub Scout Roundtable Commissioner on October 8, 1985.

I couldn't believe this man, a recipient of the Silver Beaver Award, and a man I had worked closely with for six years or more could have done what he did. The shock was so great, it took me from the time of the incident, until Monday morning when I saw Dr. Tim Butler, also a Scouter, trusted friend, and former bishop of my church, to be able to tell anyone what had happened.

The most shocking thing about what happened, I feel is that this man so trusted by Scouters that he is able to move at ease throughout the Council, could with will, disregard the Scout promise and law to be morally straight and clean.

I would hate to see this happen to another woman in Scouting.

Dear Stan:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.
