Thank you for the detailed information sent concerning the above Scouter. This case has been reviewed with our attorney and is now on our permanent Ineligible Volunteer File.

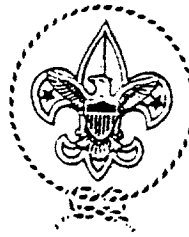

Stephen Edward Ahern was tried before a General Court Marshall on Monday, October 30, 1989 and was found guilty on all counts of Child Molestation. He was sentenced to 45 years of imprisonment at FT. Leavenworth, Kansas and will not be eligible for parole until the year 2,019. Attached is the Confidential Record Sheet completed as best we can, for the Undesirable Leader File.

Some of the Scouts will require counseling and I am coordinating between their parents and National BSA Risk Management.

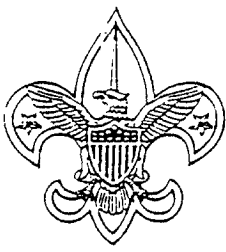

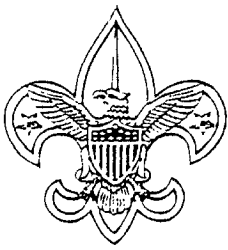
Conversation with COC, 3d Corps HQ (Corps Operation Center) revealed that Steve Ahern was arrested by the CID on 28 August 89 and was listed as the subject in an SIR (Serious Incident Report). The CID opened up an ongoing investigation, Criminal Sexual Assault, and assigned an ROI number to it. (Report of Incident). This number is a permanent assigned criminal investigation number. It will always be on file at FBI and Ft. Holibird HQ, Maryland. The SIR goes to FORSCOM HQ, CID Command, and COR, USA Army, Washington, DC. Follow-up report must follow within 45 days.

Reference our phone conversation this morning. We have deleted Steven Ahern, Scoutmaster of Troop 225, Leon Valley District, from our registration files.

I have also talked with the Provost Marshall at Fort Hood, Texas, apprising them of the allegations made against Ahern. They will interview the principals and will decide jurisdiction. If the incidents indicate a need to notify local civil authorities, they will do so.

Attached is a copy of the letter written this morning suspending the registration of Steven Ahern. Also attached is my chronological report of the incident and who reported what to me; also of my actions resulting to date.

Paul, I will keep you informed of the situation.

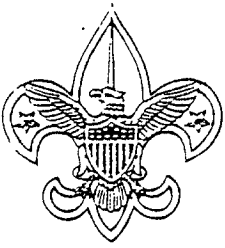

Dear Mr. Ahern:

Recent occurrences have made it necessary to suspend your registration with the Boy Scouts of America. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for review of this decision are attached.
