



At 5:15 p.m. on Friday, October 29, 1987, the parents of a youth that is a member of an Explorer Post reported to the Council Office that the Explorer Advisor had taken indecent liberties with the This alleged incident took place at approximately 1:30 a.m. on Friday morning, October 29, at the Advisors home in Sophia. The Council Executive immediately reported the incident to the Randolph County Sheriff's Department and to the Explorer Post Committee Chairman.

The Explorer members (approximately 13) were sponsoring a "Haunted House" project in Archdale. The Council Executive met with officers of the Randolph County Sheriff's Department at approximately 7:30 p.m. Friday evening and went to the "Haunted House" to meet with the advisor. The advisor, Mr. Steve Russell was informed that a complaint had been filed against him and he was immediately removed as Explorer Advisor and to turn over all responsibilities of the "Haunted House" to other adults and parents who were present. He agreed to this and immediately vacated the premises.

The investigation is being conducted by the Randolph County Sheriff's Department.
