
I would like to set up an appointment with the national review committee as soon as possible.



Six pending situations were reviewed with results as indicated below. The review was conducted by three members of the Committee and chaired by Barney Ellis of Pittsburg, Kansas. Mr. Ellis was in attendance at the meeting held in Baltimore for members of the Regional Review Committee. Others present were Lee Phillips of Wichita, Kansas and Phil Starr of Kansas City.

Results as follows:

Mr. William H. Johnson, Hillrose, Colorado - Action of the local council was upheld. Did not appear before the committee.

Mr. Richard D. Pechuman, Mrne St. Croix, Minnesota - Action of the local council was upheld. Did not appear before the Committee.

Mr. Mark Taylor, APO Miami, Florida - Action of the local council was upheld. Did not appear before the Committee.


Mr. Steven McReynolds, Cal Junction, Missouri - Action of the local council was upheld. Mr. McReynolds did appear before the committee.

Mr. Terrence Overstreet, Salida, Colorado - This was the second time this file was reviewed by a Regional Review Committee. The decision of the first group was to postpone and seek further information or more believable information. The local council was unable to add to the original information provided.

The Review Committee did not recommend that Mr. Overstreet's registration be denied and suggested that he be informed that his registration can be re-instated. Copies of all correspondence from/to and in behalf of Mr. Overstreet is being forwarded to you.

Mr. Anthony Dehl, Waterloo, Iowa - Mr. Dehl appeared before the committee as did his wife. The decision of the committee was that the courts had found Mr. Dehl innocent of the accusation and that they had no reason to set themselves in higher judgement. They recommended that Mr. Dehl be permitted to register with the Boy Scouts of America. The local council and the Regional Office have received letters in support of Mr. Dehl's registration. The regional copies of these letters are being forwarded to the National Office.

1. at approximately 5:30 pm I received a call from District Executive Rob Sights. Rob was working with a web camp program at children scout reservation when 7 aquatic camp contingent returned to camp.

Rob stated that a young lady, [REDACTED] had accused Steve Mc Reynolds, aquatic camp director of raping her.

Rob + Doug Winters another District Executive who is the staff advisor to the aquatic camp contingent felt this was a serious accusation and I agreed.

I instructed Doug to begin immediately to get a written statement from the people who have direct knowledge of the concerning the accusation.

I also instructed them to give whatever comfort + insurance to the young lady involved. As I left for camp, Rob Sights said Dan Weaver had reported this info to the child abuse hotline. I arrived at camp shortly after 6 PM 77 + visited with Doug, Rob, and those who were filling out ~~the~~ writing down ~~what~~ ~~the~~ ~~thought~~ ~~happened~~ their statements. [REDACTED]

3. I visited with [redacted] and asked her if she wanted to call her parents & would she want us to take her home. She called to make sure they were home then Doug Winter & I took her home.

We arrived at [redacted] house at approximately 7:35 in Meosho. We spent about 40 to 45 minutes with the family. We did our best to explain what had occurred & what procedures were being followed. I also informed them that Steve McReynolds' BSIT Registration had immediately been pulled and that this was done for all concerned. As we were leaving I personally talked to the parents and told them that our policy is that when a youth confides in adults we take that info in & confidentially and that [redacted] needed their support & that we would help in any way possible.

4. As we were leaving camp on the way to [redacted] house I instructed Robert Dept DE, & Tom Reardon, Leisure Camp Director to ~~take~~ inform Mr. McReynolds that due to this serious accusation his registration in the BS was immediately suspended and he was escorted off of camp property. I later that evening ~~took~~



received a phone call from Mr. McRylands who  
explained to him that the suspension meant that  
he could Not take part in any SSA activity

wanted real info but I told him to call me  
Monday morning at 9 AM and I would set a

Testimony involving Incident at  
Mokan Area Council Aquatics  
Camp 1990

Information that may possibly  
be directly related to Incident

At the beginning of camp, a few  
campers told me that they thought  
[redacted] was attractive and since  
we [redacted] + I) attended the same  
high school they asked me if T. knew  
any of her. I told them that I had  
heard that she got around but she  
was definitely not a 'slut' and not 'easy'.  
T. knew nothing until Wednesday  
night but on the beginning days of  
camp, T. along with others, noticed  
that Steve was spending a lot of time  
with [redacted]. He would have been  
be the first one on the ski boat but  
be the last one to ski.

Wednesday night Steve told me  
that he needed to talk to me. I knew  
nothing as of yet so I just said "sure, OK".  
We walked down the road a little ways  
when Steve began accusing me of  
starting rumors about [redacted] being a 'slut'.  
I just figured that the campers must  
have taken what I said wrong. I apologized  
to Steve and told him that I would  
correct it. At this time, Steve began  
accusing me of starting rumors about  
him and [redacted]. He told me that  
[redacted] family has been friends of his since  
[redacted] was 12 so of course he would  
favor her over any of the other campers.  
At this time Dan walked up and heard  
Steve's accusations about the rumors.  
Dan told Steve that the rumors were  
not helped at all by Steve favoring her.  
Dan had not heard Steve tell me that  
Steve favored her so at this time, Steve

had told me a few minutes before that he did. Dan and Steve got in an argument over whether or not she was favored. The argument ended with Dan walking away telling Steve, "You're always right and everyone else is always wrong so just Fuck you Steve." As Dan was walking away David Magee walked by on the way back from the bathroom. Steve stopped him and started asking David about a conversation that David and [redacted] had had earlier that day. Steve asked David what he had said to her that had made her upset. David said something about like "I know that you know that I know" At this time, I thought "OK, this may be something confidential," so I thought I should leave. As I was thinking ~~Steve~~ Steve asked David just what he was talking about. David said "the incident on the boat." When I heard this I decided that a third party needed to be present. But before anything else could be said, Bob Vice walked up and told Steve to close this up so they could have their nightly staff meeting. After Bob walked away, Steve kept asking David just what he was talking about and all David would say is "You know." I told them both to shut up so we could finish. I told Steve that I would take care of the rumors and that he needed to stop spending so much time with [redacted]. He said OK and walked off. David and I walked up the road and I asked him just what the hell the incident on the boat was. He told me that [redacted] was raped by Steve. I was so shocked that I don't remember much else of what was said. The next day I got [redacted] alone and asked her what was going on and that's when she told me all about it. Information was received first  
hand from [REDACTED]

On Monday night July 2, the  
camp had a ~~first~~ CPR learning  
session. Afterwards members of  
the staff and a few campers  
were on the deck. Steve McReynolds  
approached [REDACTED] and  
told her that he needed to talk  
to her. She waited for him inside  
the cabin until after the  
entire camp, including myself  
had retired to our tents. At this  
time Steve suggested to [REDACTED]  
that they take a boat ride. [REDACTED]  
told me that since Steve was a  
family friend, she thought nothing  
of the suggestion. About fifteen  
minutes (as I recall correctly) the boat was  
heard leaving the camp. The boat  
returned about 2:00 or 3:00 (I was  
asleep when it woke me up so I'm not  
sure of the exact time). [REDACTED]  
confided in me later ~~that~~ (thru.)  
that while she was with Steve  
alone in the boat, she was forced to  
the floor and raped. The exact details  
of the rape were apparently too  
traumatic for her to talk about. The  
day following the incident (Tuesday)  
[REDACTED] hurt her ankle while skiing  
so she slept on the deck so as to  
be close to the bathroom. [REDACTED]  
told me that Steve made advances  
towards her once again. But [REDACTED]  
managed to keep his advances from

The next morning she wasn't in the great of a mood but I didn't think too much of it. At the time Steve constantly was asking about [redacted] when we got down to the moped I told her I was constantly asking her questions & being very inquisitive & said "lets talk tonight" to her. Later she came back & jumped into her car. Monday she was talking about how much Steve got on her nerves. And that she didn't really want to talk to him. Wednesday night she & [redacted] went on a little drive 11:30 PM at night & she was talking how much I love "cuckoo" behavior. She wished he would rape her alone. That night she & I were up till 4 AM & we had a good time but she was holding some thing back. Thursday night she asked me to sit down & she told of the rape & everything I had seen & heard clicked. There had been nothing really unusual & was asking me if I was sure. Where is [redacted] He always had her on the belt with him & not on the

on & last to sleep & to get off. He  
had her go places & talked to  
her all the time. Steve showed  
great favoritism to her. Steve  
was beginning to be a "fucking  
asshole" to anyone who was  
around [redacted] when he wasn't  
there & would grip people out  
& get them "pissed off" & he  
was a constant thing around  
[redacted]. Steve seemed so nice &  
understanding like he understood,  
but he knew how to kind of  
"push all the right buttons." so to  
speak. At camp fire he asked

# DAILY RECORD OF EVENTS

It was that Steve McKennals raped her on Mon. July 2 1981. She told me this on the Wed. July 4 91. He wanted to talk to her and Steve asked her to go out to the field ~~in the field~~ to talk. Steve came in self on her and she said she tried to fight but Steve was too strong for her. After this happened Mon. Tues. he strg. to do the same. That night after our CPR class/gatorade at 11:00pm when everyone was asleep.

I was the first one she told that he did this to her. I was taken away when she said this to me.

Steve would stop us from talking to her to find we could talk about Camp Review - 17/1, for 3 years going on the 4th year.

Steve made the "Eugene" and got mac McKennals and ~~the~~ then both are a Boy & Girl camper at camp.

Steve wanted to talk to me July 4th night when everyone was asleep. He asked me to tell him at Rob Vries ~~the~~ Frank in 5 min to talk about what happened. And I told mac to come to get me when I did not come back to camp. But Scott Copeland was there with Dan Weaver the camp cook. And I was about ready to go. Steve right there on the spot. But I didn't because he was lying through his teeth.

That is when I told Scott Berance. He was Head Lifeguard at camp and he asked me and I had to tell him.

Steve told me that I had put

and was startin her head. Steve told  
Bob Vee Dan Weaver that he was  
afraid that Mac & I would do something  
to her out in the woods in the dark.

Steve tried to get all of me &  
Scott to leave it alone and drop it.  
He tried to / "Better us up!"

Steve has been a friend of my family for a few years now, so when he asked if I would talk to him on the boat Monday night. I didn't feel threatened. When we were in the boat, he took us to a cove across the lake, & dropped anchor. I started looking at stars through the porthole of his boat. To do that you've got to lay down on cushion. He was in there with me, and started getting closer and closer, then he started touching me. I asked him to stop, told him I was uncomfortable, even reminded him of my mom & brother. But he just acted like it was funny, like a joke. He took my hands & made me touch him in places. (private places) He gave me hints to do things. Then he insisted I do things. I was under the impression we wouldn't leave until I did something to him. Actual intercourse did take place, & no

he wasn't using a condom. I was so scared to say anything the next day. Tuesday, I ended up bruising my ankle real bad. Steve insisted I stay at his parents cabin. Steve's mom wanted me to sleep inside but Steve said I didn't need too, that I would be cooler outside. Later that night he came again, he got a little upset with me, cause he said I was to tight. I ~~was~~ was in more control of myself though. He still made me touch him. Wednesday I told a friend, it was getting to be too much to handle on my own.

Monday evening (approx. 11:00-11:30) Steve came up to me in the kitchen of his parents' cabin and told me that [REDACTED] wanted to talk to him in private about some personal matters. He said he was going to take her out in the boat and go out to the middle of the lake. I said "What about national standards?" and he said he knew it was against national standards but she was a family friend, [REDACTED] and she wanted to be in private to discuss her personal matters and that he thought it would be ok. I again urged him not to take [REDACTED] out in the boat, but he <sup>again</sup> said it would be ok and then he left. Dan <sup>Weaver</sup> and I sat up and waited for awhile for him to return, but I went to sleep before they got back. I don't know when they returned.

The next day [REDACTED] hurt her ankle, and Steve prepared a bed on the cabin's deck "so she could more easily get to the bathroom if she awoke in the night and had to go."

(approx 11:30)  
FRIDAY NIGHT, after campfire, I was called to ~~talk~~ talk to a group of campers. Dan Weaver was also present. I was told we had a bad problem. I asked to hear it, and [REDACTED] said "Steve raped me." She said she was out on the boat Monday night and she and Steve talked. Then, after talking for awhile, they were laying on the front of Steve's boat and he had her "touch him," and "do things." I then asked her to come with Dan and I so she could get away from the group we were with and be more specific.

At this point, she said that actual intercourse had taken place on the boat, and that he had made advance Tuesday night at the deck of the cabin but intercourse not taken place then.

Then Dan and I told her we would contact the pro authorities, and we shouldn't talk about it ~~any~~ anymore.

2. Upon the receipt of your written request, a committee will be appointed to review the situation.
3. You may attend the review hearing, but it is not adversarial in nature and neither the committee nor you will be represented by legal counsel. If you wish, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you disagree with the decision of the committee, you may request a review of this decision by the National Council of the Boy Scouts of America.
