

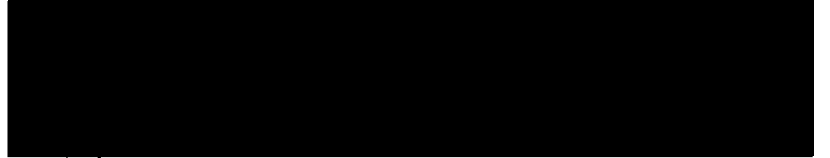

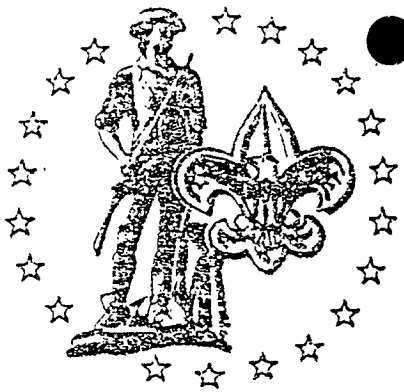

Mr. Conti:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that you registration as a BSA member should be reinstated.

Resident charged in rape of child Suspect member of town Scout troop

A Burlington man who police say became involved in a local Boy Scout troop and a Big Brother organization to get close to children is free on \$5,000 cash bail following his arraignment Monday on child rape charges.

Steven Conti, 26, of 10 Makechnle Rd., was arrested Nov. 9 after a two-day investigation and charged with rape of a child and indecent assault and battery of a child, according to Sgt. Walter Bevis, head of detectives.

Although he was released after the initial arrest, Conti was arrested again on Friday after investigators discovered that he

had been involved in various youth organizations during the past seven years.

"At first it was thought to be an isolated incident," said Bevis, explaining why Conti was released after the first arrest.

Conti was charged Monday in Woburn District Court on one count of rape and abuse of a child under 16 and one count of indecent assault on a child under 14, according to Thomas Samoluk, a spokesman for the district attorney's office.

Conti will return to court Dec. 8 for a pre-trial conference, Samoluk said.

Bevis said Conti, an assistant electrician, may ultimately face

two counts of child rape and three counts of indecent assault and battery of a child.

During the weekend, police interviewed about 40 families who knew Conti, Bevis said.

"We're interviewing anybody who had any contact with him," he Bevis.

Conti was an assistant scoutmaster in Boy Scout Troop 103 and also member of a Big Brother organization.

Bevis said Conti was involved in the organizations "just as a means of being close to the kids."

"He used his position to manipulate people," Bevis said. He

noted that none of the incidents occurred during Scouting functions.

The two incidents in which Conti has been charged occurred within the last two years, Bevis said.

Other children who police believe were victimized are between the ages of seven and 15, and not all of them were Scouts, Bevis said.

He said the investigation is winding down.

"We have a profile of him. We know what we're looking for," Bevis said.

"He's got some serious problems," said Bevis, who interviewed Conti after the arrest. "He showed no remorse."

Mike Vecchi, the scoutmaster whom Conti served under, could not be reached for comment.

Local Cubmaster Peter Mohan said he knew Conti and was shocked to hear about the allegations.

"I was there when the officers came up," Mohan said. "I didn't even know what was going on." He said the Minuteman Council, which oversees local Boy Scout, Cub Scout and Explorer troops, has safeguards in place to prevent this type of thing from happening.

"We don't just take anybody," Mohan said.

"They've really become quite stringent on it," Mohan said.

"They want to make sure there's all the protection in the world for the kids."

Minuteman Council Executive Director Ronald Rogers said that intense screening for scout adult leadership has been implemented within the last 18 months as a response to growing

awareness of child sexual abuse. "There are checks done on the leadership within a Boy Scout troop," Rogers said.

Rogers said that a background check conducted on Conti showed that he had no past criminal record. However, Rogers pointed out that Conti joined the organization before the stricter screening guidelines were in place.

He said that during his three years on the Minuteman Council, he has heard of no other cases involving sexual abuse of a child by a Scout leader.

"One case is too many," Rogers said.

Rogers noted that the Burlington Boy Scout troop is one of the best and most active within the council, and he said he does not believe the situation will have a negative impact on the organization.

"As far as the Scouting program is concerned, it is still one of the best programs we have," Rogers said.

Marshall Simonds, Middle School Principal Richard Connors said he was not familiar with the details of the situation.

"No one has said a word to me," Connors said.

Connors said the issue of sexual abuse is discussed in health courses taught at the middle school.

"There's no question that kids ought to be able to talk to a professional at an appropriate time," Connors said.

Connors could not speculate whether the matter would prompt additional emphasis on abuse education in the middle school.

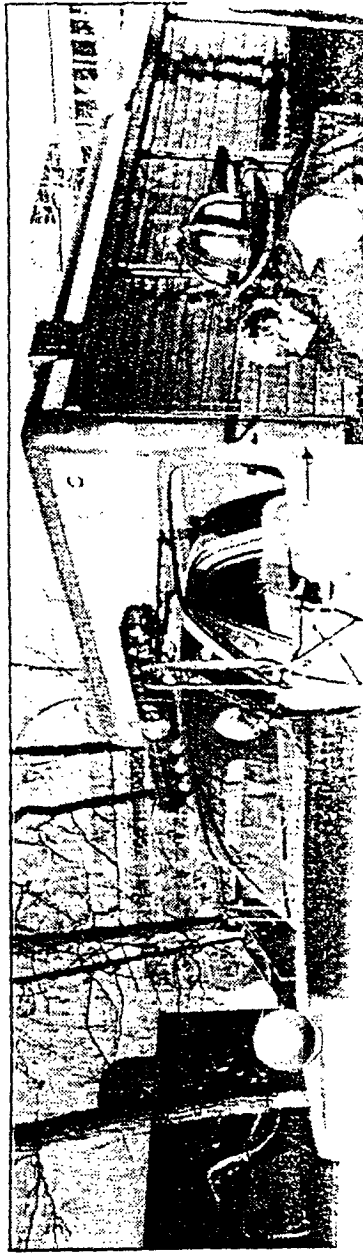
"I've been reluctant to do anything until I know all the facts," he said.

Resident held on charges of child molesting

A two-year investigation by Burlington Police has led to the arrest of a 27-year-old resident. He was charged with indecent assault and battery of a child under the age of 14 and rape of a child. Stephen A. Conti, 10

Makechnie Road, was arrested last Wednesday night by Burlington Police Sergeant Walter Bevis, who supervised the investigation.

"The suspect had an opportunity to be in contact with children," said Bevis, "and

took advantage of the situation."

Local authorities are withholding information regarding the exact circumstances of the incident pending further investigation of more potential victims.

"At this time, we're questioning anyone that has come in contact with the suspect during the last five to seven years," said Bevis.

The alleged assault and battery and rape occurred in Burlington in 1986, and local

authorities have been conducting an extensive investigation and will continue to gather information as they question any other children who may have any knowledge of this or any other similar incident.

"He loved young boys, just being near them," said Sgt. Walter Bevis, the detective heading the investigation. "He just picked out someone he wanted to be closer to and got close to the family, moving himself into a position of trust."

Conti was a secondary leader for Burlington Troop 103 of the Boy Scouts of America and a volunteer for Big Brother/Big Sister. He was a respected and well-liked man who got along well with the kids, according to police.

He has no prior arrests and no known record of sexual offenses, Bevis said. Police allege that Conti had become affiliated with youth organizations during the past seven years in order to become acquainted with the boys.

Over seven years, he just made himself available to several youth organizations, Bevis

Burlington Boy Scout leader charged with sex assault on boys

BURLINGTON — A 26-year-old Burlington Boy Scout leader and Big Brother faces charges he sexually assaulted two young boys after using youth groups to befriend the boys and win over their trust.

Stephen Conti, 26, of 10 Makechnie Road, Burlington, is expected to be indicted next week by a Cambridge grand jury on these and other charges of rape of a child and indecent assault and battery on a child, according to police.

Police charge that Conti befriended the boys and their families, winning over their trust for sometimes a year before assaulting the boys.

said. "It looks like he got into these organizations to get close to the boys."

Conti has been removed from all affiliation with the Boy Scouts, according to Ronald Rogers, the executive director of the Minuteman Council in Stoneham, which oversees the Boy Scouts.

Rogers said Conti's past was thoroughly investigated before being approved as a leader.

"With all the onslaught of abuse cases nowadays, our registration procedure is quite extensive to determine character of the people," Rogers said. "Ironically, Conti, as all Boy Scout volunteers, received extensive training to recognize and prevent child abuse in the Scouts, Rogers said.

The abuse apparently did not occur during any Boy Scout outdoor outing.

Police are investigating the Big Brother/Big Sister angle, but have no indication of abuse at this time.
