11 March 1986

Before a general court-martial which convened at Bad Kreuznach, Federal Republic of Germany, pursuant to Court-Martial Convening Order Number 1, this headquarters, dated 2 January 1986, was arraigned and tried:

Specialist Four Steven C. Klein, [REDACTED], U. S. Army, Company A, 12th Engineer Battalion, 8th Infantry Division (Mechanized), APO New York 09111.

The accused was arraigned on the following offenses and the following findings or other dispositions were reached:

Charge I. Art 134. (Guilty).

Specification 1: Indecent acts upon the body of [REDACTED] male under 16 years on 29 Dec 84. (Guilty).

Specification 2: Indecent acts upon the body of [REDACTED] male under 16 years on 25 Dec 84. (Guilty).

Specification 3: Indecent acts upon the body of [REDACTED] male under 16 years sometime during Oct 84. (Guilty).

Specification 4: Indecent acts upon the body of [REDACTED] male under 16 years sometime between 1 Jan 84 and 15 Jun 84. (Guilty).

Charge II. Art 86. (Guilty).

Specification: AWOL from 26 Feb until apprehension on 15 Mar 85. (Guilty).

The findings of guilty as to the Charges and Specifications were based on the accused's pleas of guilty.

The members adjudged the following sentence on 5 February 1986.

To be reduced to the grade of Private E1; to forfeit all pay and allowances; to be confined for 20 years; and to be dishonorably discharged.







Specification: AWOL from 26 Feb until apprehension on 15 Mar 85. (Guilty).

The findings of guilty as to the Charges and Specifications were based on the accused's pleas of guilty.

The members adjudged the following sentence on 5 February 1986.


To be reduced to the grade of Private E1; to forfeit all pay and allowances; to be confined for 20 years; and to be dishonorably discharged.
