Dear Paul:

This letter should help update your files regarding the above named individuals.

It is our understanding that in the case re: John Savastano, there was insufficient evidence to prosecute in Massachusetts. However, while there was sufficient evidence to prosecute in Maine, the parents have declined to pursue the matter out-of-state and hence this case is apparently "dead in the water". There has been no communication between the Council and Mr. Savastano since he was presented his letter and removed from registration. He has obviously not chosen to appeal.

Steven Ward's case was dismissed by the District Court on February 9, 1991 in order that he be arraigned before a Grand Jury. This was done and Mr. Ward has been indicted by the Grand Jury and awaits trial by the Superior Court of Bristol County, Massachusetts. Enclosed is the dismissal notice of the lower court.

We will keep you informed as to further developments.

Dear [Redacted]:

As you know, I have talked to you about the report that the Department of Social Services received that [Redacted] may have been abused and/or neglected.

After visiting with you and your child(ren) and talking to other people who know your family, the Department has found reasonable cause to support the allegation that your child(ren) has been abused and/or neglected and the report is supported.

While the report is supported, it is not necessary to open a case for an Assessment. The assessment is an opportunity for the Department to collect information on your need for services and to develop a plan for how services will be delivered to you and your family. It is also an opportunity to review and possibly change the investigation decision.

We have discussed and agreed that your family is not in need of services. If you still agree your right to a review of investigation decision is waived and your case will be closed. If you disagree please contact me and I will arrange to have your case opened for an Assessment.

If the report about your child came from a person who is required by state law to make this type of report (this could be a doctor, teacher, nurse or other professional) I will be sending them a copy of this letter.

If you have any questions about this letter or want to talk to me, please call me or come to my office.

This letter is to confirm our phone conversation of this morning concerning my son's boy scout troop # [REDACTED] leader, Steve Hard.

A few weeks ago Steve Hard called the house around 9 o'clock at night and said the scouts were going to see the fireworks in back of Case High and if [REDACTED] could go. I told Steve I was already in [REDACTED] pajamas and he then said he would pick [REDACTED] up. I asked [REDACTED] if he wanted to go and he said yes. [REDACTED] returned home with the father and I asked him if the fireworks were nice, which he said yes. He also asked him who else went and he replied "just Steve & I went".

This bothered me but both the father and I know Steve personally as he is a member of the sportsman club which my husband also belongs to.

However, on Thursday June 7th, Mr. Hard again picked up [REDACTED] @ 7 P.M. to bring him to Boy Scouts. At 9 P.M. I picked up [REDACTED] at the boy scouts and saw where he was in Steve's truck to be brought home. [REDACTED] got out of his truck and into my car. At this time (ride home) the [REDACTED] I did question [REDACTED] if Steve ever got "funny" with him. [REDACTED] replied "he's always touched me and I told him 'stop it' that I don't like it." I then asked him what Steve said and my son [REDACTED]

he said "Go home."

My husband and I both tried to question him further and he started to cry. My sister, [REDACTED], questioned him the next day and he told her that Steve would pub his private part (photos or) and he told Steve to stop it.

I hope this problem can be handled swiftly and confidentially. I know my son is telling the truth, I do not want him to be afraid nor do I want any harm to come to him.


Dear Mr. Ernst:

It is my opinion that the Moby Dick Council should immediately suspend the registration of Mr. Steven J. Ward for alleged child abuse pending investigation by the Department of Social Services. Mr. Eric Jaikes, legal counsel for the Moby Dick Council concurs based on BSA's Standards of Membership. Mr. Ward should be placed in the Ineligible Volunteer File and the appropriate documentation is enclosed.

The letter regarding Mr. Ward's separation from the BSA was delivered by me, Mr. Everett Graviel (District Executive), and Mr. Eric Jaikes, Council Board Member and Attorney on Tuesday, June 12, 1990 at 10:07 a.m. at the Fall River Chamber of Commerce parking lot. Mr. Ward asked, "What's this all about?" and I simply replied that he did not meet the high standards of membership of the BSA and that his registration was being suspended pending an investigation. He wanted to return the check, but I did not accept it. He asked if this had anything to do with a woman being in a campsite on Saturday, June 9th and I told him it did not. I explained his right to appeal after which he quietly got into his truck and left.

The chartered organization and key troop leadership have been contacted.
