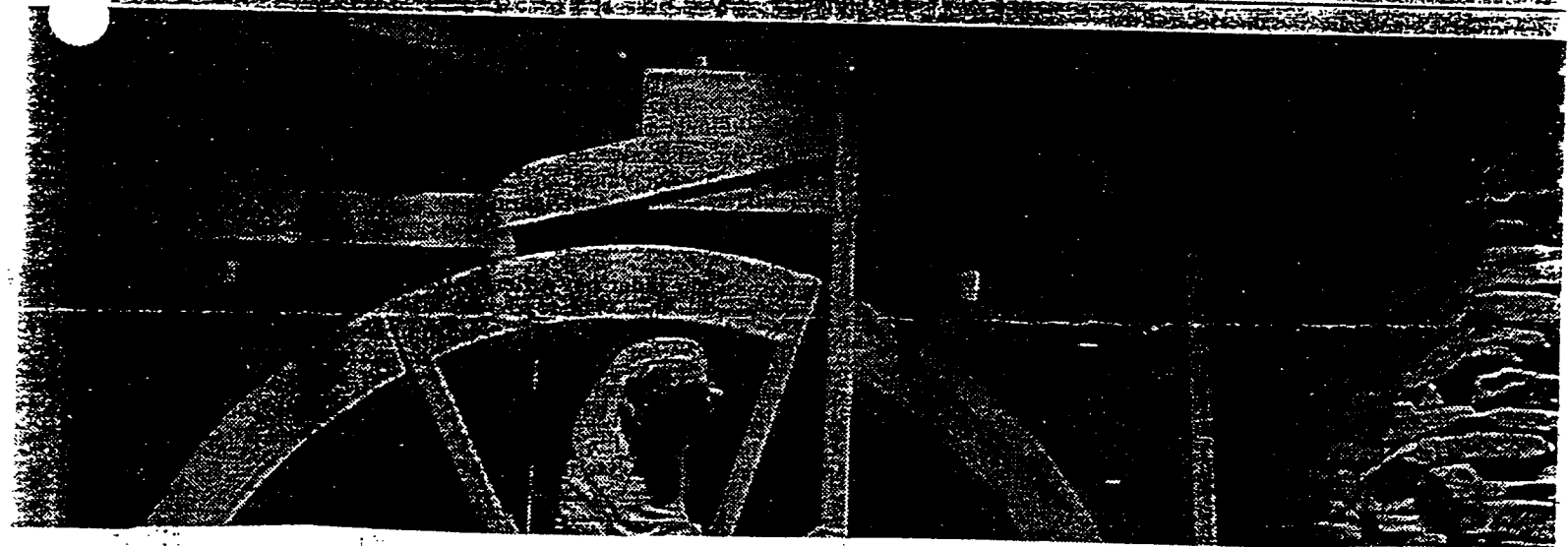

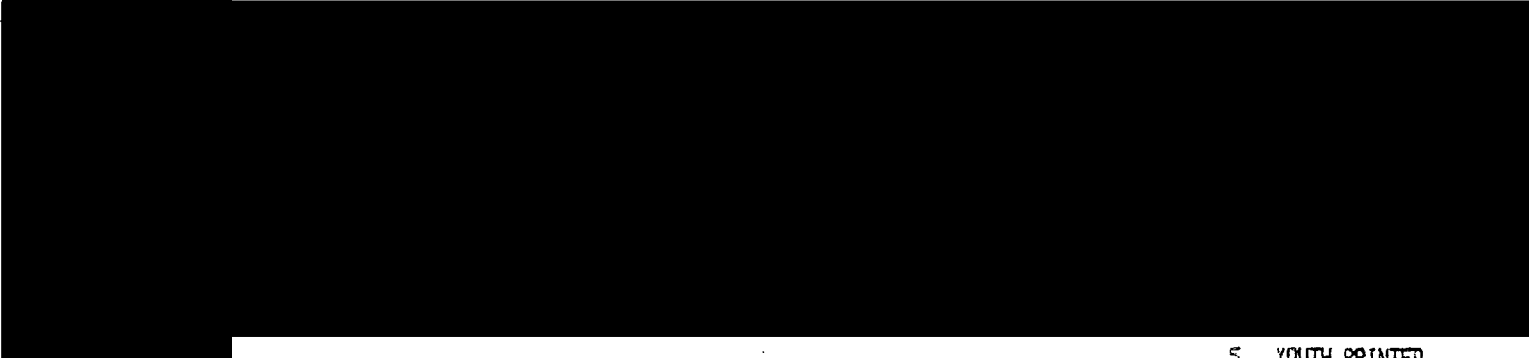

Situation - On July 7, 1989 Herb Truax ([REDACTED]) called to report child abuse incidents that have occurred between Steven Schoedinger and [REDACTED] on multiple occasions during the last 7 months at a mini storage warehouse. He alleged that Schoedinger anally penetrated [REDACTED] age 16 and brother [REDACTED] age 14.

Additional incidents occurred when Schoedinger took one of the boys to a Pow Wow in Portsmouth, Ohio. They stayed overnight in a motel and Schoedinger did a complete massage of the boy's body.

Schoedinger is registered as a MC in Troop 354 and as a CM of Pack 153 in Scioto Valley District. He is active with the O.A. as well.

Action - The Franklin County Children Services [REDACTED] was immediately notified the same day by the Director of Field Service.

Investigation - Randy Walker [REDACTED] of Children Services conducted an interview with Mr. Truax and additionally with the 2 boys. He has found great substance to the allegation and has turned the case over to the Police - Juvenile Bureau ([REDACTED]). The police will conduct the investigation of sexual abuse.

Mr. Walker has recommended that Schoedinger not have any contact with children. He did relate that the incidents occurred on non-Scout time. However, the two boys have been active in Scouting. [REDACTED] - Troop 354 a past member and [REDACTED] - a current member of Troop 354.

Mr. Walker will be on vacation the week of 7/17. The Supervisor, Marvenna Twigg can be reached at [REDACTED].

Recommendation - That we immediately suspend the registration of Steven Schoedinger, prepare the suspension letter, inform and brief the Council President and heads of the 2 chartered partners involved, plus CC and SM of troop 354, plus key leaders of the Central Ohio Council and the BSA.

Because I will be on vacation, it is suggested that John Preston follow this with the details of the suspension.

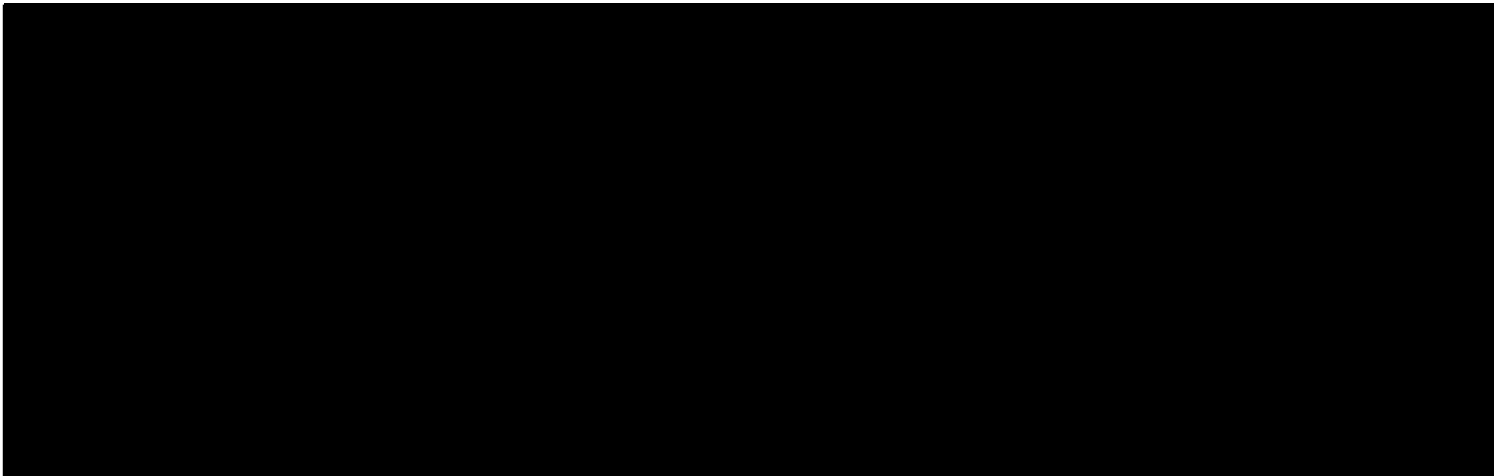

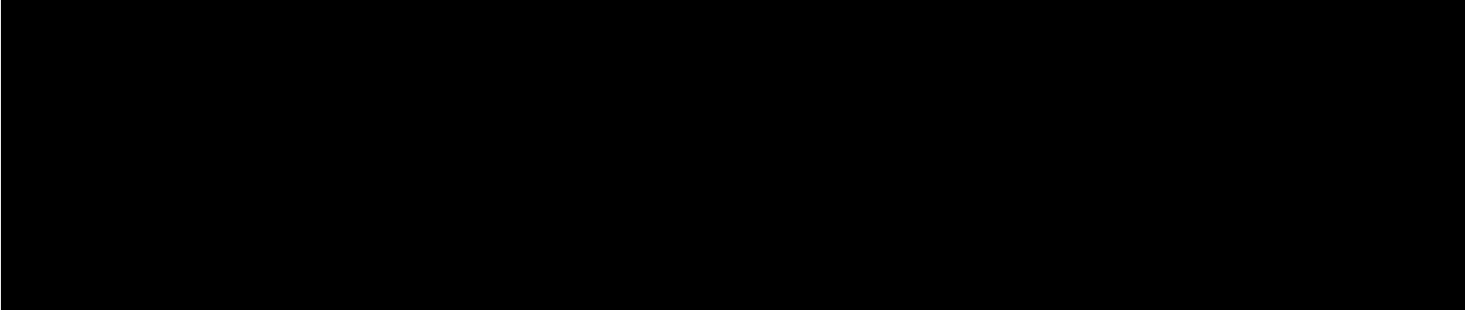
