After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

The following information is provided should you desire a review by the Southeast Region, 8.S.A., of the decision to deny your registration.

- 1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to the Regional Director, Southeast Region, B.S.A., PO Box 440728, Kennesaw, Georgia 30144. In your request you may include your version of what occurred in support of your claim that your registration should not have been denied.
- 2. Upon the receipt of your written request, a committee will be appointed to review the situation.
- 3. You may attend the review hearing, but it is not adversarial in nature and neither the committee nor you will be represented by legal counsel. If you wish, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
- 4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
- 5. You will receive a letter setting forth the decision of the committee.
- 6. If you disagree with the decision of the committee, you may request a review of this decision by the National Council of the Boy Scouts of America.

SUBJECT: Steven V. Brier August 2, 1990, 4:00 p.m.

I received information via that Mr. Mike Poore had called indicating that Steven Brier, Assistant Scoutmaster of Troop 16, had been charged with molesting. He also informed us that Detective Debbie Johnson was the person that was working on the case.

August 3, 1990, 9:00 a.m.

I called for Detective Johnson and was informed that she would bee at work after four (4:00) p.m. on that day. I then called the jail (and was advised that Steven Brier was admitted on July 18 and released on July 21.

I secured the arrest report (copy attached).

August 5, 1990, 8:30 p.m.

I called Ray Ricks Troop Committee Chairman. Ray had no awareness of the incident. I informed him what had taken place and he indicated that he would talk with Scoutmaster Mr. William Charles.

August 5, 1990, 8:45 p.m.

I talked with Thomas McCargo, Charter Representative. He also had no awareness that the incident occured. I advised him that I had tried to get in touch with the Pastor Bill Robertson and he indicated that he was probably out of town over the weekend and I could get in touch with him the first of the week.

August 6, 1990

I was able to contact Reverend Bill Robertson of the Springfield Presbyterian Ehurch and he to had no information of the arrest. He was not familiar with the Boy Scouts of America Youth Protection Program. I advised him of the nature of the Program and how it worked. Reverend Robertson indicated that he would like to be present as I visited with Steven Brier. I determined several different times that Reverend Robertson would be available for visit and called Steven Brier to schedule an appointment.

Date for visit was set for 11:00 a.m. on August 7.

August 7, 1990

At 11:05 a.m., on August 7, 1990 Steven Brier came to the Springfield Presbyterian Church and Reverend Bill Robertson and I visited with him in the Pastor's study. I inquired as to whether or not Brier was aware of the Youth Protection Program he indicated that he had not heard of it and had no Scout Leader training since his involvement with the Troop in the last year and a half. I advised him of the nature of the Youth Protection Program, read the letter to him, gave him a copy of the appeal procedure and \$1.80 cash as his registration refund. He also signed a receipt for \$1.80. There was very little reaction from Steven Brier to the conversation and he had no quesitons. I excused myself from the trio and left Reverend Robertson and Steven Brier in conversation.
