

Frank Lawrence volunteered as my A.S.M. last August while at summer camp. Knowing Frank to be a minister and a very wonderful Scouter I was very happy to add him to Troop 989.

Everything was wonderful and he was most helpful and I was happy to have such an assistant.

After a hike on the Appalachian trail, on which Frank was in charge, one of my boys quit. I talked with the boy and his parents but could not get a reason for this drop-out.

Sometime later, a parent of two other scouts informed me that their sons objected to Mr. Lawrence and gave me the reason. I talked to one of the boys and was told things I found hard to believe. However, while at Broad Creek camping last December, the chairman of the troop committee and the treasurer and I saw acts that convinced us the boys told the truth.

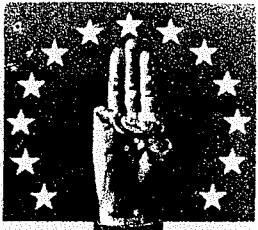
We asked Frank to resign and suggested to him that he confine his Scout activities to adult groups which he agreed to do. When I learned he had another troop and also a Cub Pack, I felt that something should be done immediately and Mr. Harris was informed.

I am sorry such a well-informed and talented Scouter cannot be used by our organization where he comes in contact with boys.

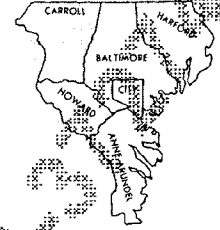
