Dear Bob:

I recently received information on Mr. Disbennett's wife. She had been put on the file, because of a charge of contributing to the delinquency of a minor. I understand she was convicted on that charge.

We feel that the information contained in the statement would make it imperative that we also place Mr. Disbennett on the file. It was indicated that he had been charged with molesting [REDACTED].

I am asking that you send us an Ineligible Volunteer Record Sheet for this individual. Please complete it with as much information as is available. We have enclosed one for your use.

We would also like to have any information that you can secure on the outcome of the legal action related to this charge. He certainly does not seem to be the type of person we would want registered in Scouting. We notice that he is currently registered in Pack C3825. You should suspend him from your computer.

Cree received information from Scouter Bob Earl of Pack 825 that Disbennett had been arrested. He also indicated that he heard that Terry Disbennett, her husband, had been arrested for molesting [REDACTED].

6/15/90

Mike Smith followed up with city records and found that a warrant had been served on April 27, 1990 on Sharon L. Disbennett of Pack 15 for contributing to the delinquency of a minor. The court date as set for June 5 but no word as to the outcome of the case.

6/25/90

Mike Smith contact Judge Poston who confirmed that Sharon Disbennett had been convicted on 4/7/89 of disorderly conduct and convicted on 4/7/89 of contributing to the neglect of minors ages 6 and 5 and is currently charged with contributing to the delinquency of a minor.

6/28/90

Cree called Shields Parsons who agreed that Disbennett should be suspended as per the policies of the Boy Scouts of America.

6/28/90

Suspension letter, appeal form, and \$7 refund check prepared for hand deliver by Mike Smith and another.

7/9/90

Paul Moore called asking for information. Moore said Disbennett had called him. Cree had Mike Smith talk to Moore. Smith told Moore that he had reconfirmed the convictions as well as the current charge with the judge. They also checked the birth date which matched exactly. Moore is to call Disbennett and tell her of the facts. Smith is also going to call her and tell her of the status.

7/9/90

Jim Wilson of Region called and wants final paperwork on Disbennett.

7/9/90

Scouter Bob Early came by and informed Cree that Sharon Disbennett had told Mary Hall that she (Disbennett) had been on the list of the social services for child abuse for seven years. He also reported that her husband Terry Disbennett has been charged with molesting [REDACTED] and that Sharon Disbennett said she did not know if it was true but if it did happen, [REDACTED] would have liked it.

7/11/90

Mike Smith contacted Sharon Disbennett on the phone at 10:00 AM and reconfirmed the arrest information with her. She admitted to the conviction on the contribution to the delinquency charge. She asked about a refund for Cub Resident Camp fees for her sons.

7/11/90

Sharon Disbennett called Linda Boyce and asked about refund. Linda Boyce told her that a refund would be issued.

7/12/90

Sharon Disbennett called Mike Smith and told him that she would be going
