Dear Les:

I appreciate the information you sent us concerning the above named individual. From the material you sent, I certainly think Mr. Bess should be on our Confidential File and Registration refused.

You indicate that he did not molest the girl, but did touch her. I do not know how you are defining this, since most of the courts of law indicate any touching of sexual parts does constitute a molestation of a youth.

Many Chartered Organization heads especially, those related to religious organizations try very incently to rehabilitate a person and do not wish to remove individuals from the Scout unit. We cannot always agree with their philosophy. I, therefore, feel we must tell Father Feldman that we will not register Mr. Bess.

A letter should be sent to Mr. Bess indicating that his registration will be refused in the future. If you have any questions concerning the letter, please do not hesitate to contact me.

It would be helpful to us if you would give me some information on Mr. Bess related to his race, height and weight, as these do aid in our identification process. A copy of a paper with his signature would be helpful.

Please do not hesitate to call me, if we need to discuss this further.

Dear Paul:

I have attached information which I feel should be considered in denying future registration of Terry Hess.

The letter from [redacted] accurately describes the situation.

Additional facts are: Terry Hess, although currently registered, is not active in the pack. He did not resign but has withdrawn from involvement. His wife is active as a den leader.

He did not molest the [redacted] girl but did touch her.

The head of the chartered organization, Father Heiman, St. Joseph's Catholic Church, is aware of this situation and does not wish to have him removed from the pack.

I have been unable to get any information from the court as this is treated as simple assault. I do not know if any judgement was arrived at.
