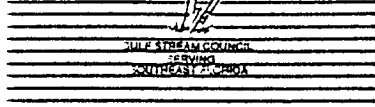

ATTACHMENT

The following information is provided should you desire a review by the Southeast Region, Boy Scouts of America, of the decision to deny your registration.

- 1) Within 60 days you must request in writing a review of this decision. Your request should be sent to Southeast Region BSA, P. O. Box 440728, Kennesaw, Georgia 30144. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
- 2) Upon the receipt of your written request, a committee will be appointed to review the situation.
- 3) If the Regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
- 4) The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
- 5) You will receive a letter setting forth the decision of the committee.
- 6) If you are dissatisfied with the decision of a Regional review, you may request a further review by the National Council. The decision of the National Council will be final.

Dear Tom:

I have reviewed certain records from the State of Michigan regarding Terry Lee Kostiuk. These records cover his criminal history in that State between 1984 and 1988; a recapitulation of those records is as follows:

1. On August 9, 1984 he was arrested in Wayne County, Michigan, on two (2) Counts of "Sex Offense Excluding Assault and Commercializing". On September 10, 1984, in the Twenty-ninth District Court, (Wayne County) the following disposition was made:

A. As to Count I, he was convicted of "Indecent Exposure" and sentenced to pay a fine of \$105.00 and placed on probation for one (1) years.

B. As to Count II, listed only as "Sex Offense", he was found guilty, his sentence being consolidated with Count I.

2. On November 27, 1984, he was charged by the Westland, Michigan Police Department with one (1) Count of "Sex Offense Excluding Assault and Commercializing". On February 26, 1985, in the Eighteenth District Court of Michigan (Westland) he was found guilty of the misdemeanor offense of "Indecent Exposure" and fined \$200.00.

3. On July 13, 1988, he was charged by the Redford Township Police Department with one (1) Felony County of "Sex Offense Excluding Assault and Commercializing". On that same date of July

13, 1988, he was charged with one (1) Misdemeanor Count of "Children - Accosting for Immoral Purposes" in Wayne County, Michigan. Unfortunately, there was no record as to the disposition of these two (2) separate charges in two (2) separate jurisdictions, but both on July 13, 1988.

4. On July 13, 1988, he was charged by the Livonia, Michigan Police Department with one (1) Count of "Misdemeanor - Public Peace". On August 8, 1988, he was found guilty by the Sixteenth District Court of Michigan (Livonia) and sentenced to ninety (90) days confinement.

Obviously, this information is not for public dissemination but is to be utilized at your discretion in the best interests of Scouting.
