
Dear Paul:

Mr. Ostrowski was charged with forcible sodomy on November 12, 1981, a charge which was amended on January 14, 1982 to taking indecent liberties with a child. The Court ordered on September 29, 1982 that his sentence be suspended until October 15, 1984 conditioned upon his good behavior for four years and upon his receiving psychiatric counseling and his submitting monthly reports from the counseling physician to the Court. On November 21, 1984, the Court entered a nolle prosequi in his case, and he was discharged from this case.

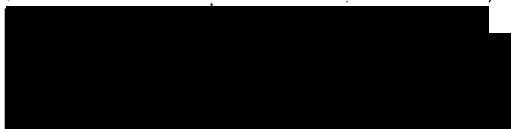
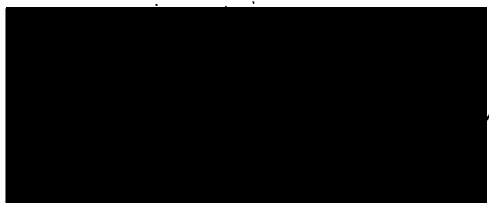

THE 29th day of September, 1982 came the Commonwealth of Virginia, by its Attorney, Arthur Karp, the Defendant pursuant to his recognizance and his Retained Attoreny, Warren McLain.

THEREUPON the Defendant informed the Court that this case had been previously set for a jury trial in the Court Order of July 23, 1982, that now the Defendant, after conferring with his Attorney, personally moved the Court for leave to try this case without the intervention of a jury, which said motion the Court granted; the Court having determined that the waiver of the jury by the accused was voluntarily and intelligently given, the Commonwealth and the Court concurring in said waiver.

THEREUPON the Defendant, after conferring with his Attorney, moved the Court for leave to enter a plea of "Guilty" to the lesser charge of "Assault and Battery", which said motion the Court granted; the Commonwealth of Virginia consenting to the reduction of the original charge and the entry of the plea of "Guilty" to "Assault and Battery".

WHEREUPON the Defendant, after further conference with his Attorney, entered a plea of "Guilty" to the lesser charge of "Assault and Battery" which plea was found by the Court to be voluntarily and intelligently entered.

THEREUPON at the request of the Defendant and with the consent of the Court, the Defendant and the Commonwealth of Virginia, the Court heard this case without the intervention of a jury, all matters of law and fact being presented to the Court for determination.

UPON CONSIDERATION WHEREOF it is the opinion of the Court that the Defendant is "Guilty" of the lesser charge of "Assault and Battery" and so finds.

WHEREUPON the Defendant moved the Court to suspend the imposition of any sentence in this case until October 15, 1984, which said motion the Court granted, the Attorney for the Commonwealth offering no objection thereto; it is therefore

ADJUDGED and ORDERED by the Court that the imposition of any sentence in this case be and it hereby is suspended until October 15, 1984 conditioned upon his good behavior for a period of four (4) years and further conditioned upon the Defendant receiving psychiatric counseling and submitting monthly reports from the counseling physician to the Court; the same to commence by December 1, 1982 and every six (6) months thereafter unless otherwise directed by the Court.

THE COURT CERTIFIES that at all times during the trial of this case, the accused was personally present.

THE birth date of the Defendant is reported to be August 6, 1937.

IT IS FURTHER ORDERED by the Court that the appearance bond of the Defendant be released and the surety thereon relieved and released from further liability thereunder and the Clerk is hereby directed to so indicate in his records, referring to this order for his authority.



## Former Scout leader arrested on sex charge

A former Cub Scout leader, who used to live in Alexandria, was arrested Wednesday and charged with sexually molesting an 11-year-old boy almost two years ago, police said.

Theodore Ostrowski, 50, of 10616 Bent Tree Drive in Fredericksburg, has been charged with aggravated sexual battery. He was released Wednesday under a pre-trial supervision program, police said. Under that program, Ostrowski, who is a self-employed accountant, must call police regularly and answer their questions.

Police said Ostrowski knew the boy and was friendly with him. In November 1986, he allegedly invited the boy to his house on the 600 Block of North Ripley Street, and assaulted the boy numerous times, according to police.

## Man shot in Lynhaven

A 22-year-old man was shot in the back Wednesday while walking to 7-Eleven store in the Lynhaven neighborhood, police said. There is no indication that the shooting was drug-related, according to police spokesman Dennis Butler.

Police said the victim, whose name was not released, was walking down Lynhaven Drive around 10 p.m. when two men approached him from behind and told him, "This is a robbery."

According to the report, one of the attackers had a gun, which he passed to the other man and requested him to shoot. The victim tried to run away when he heard the order, but the attacker fired the gun, police said. The attackers robbed the victim of less than \$50 and of a small book that appeared to be a Bible, and the attackers fled, police said.

Police said the victim was taken to Alexandria Hospital, where he was listed in fair condition.

On a hypothetical Thursday at 8:20 a.m., a Boeing 737 with 185 passengers on board goes off course while attempting to land at National Airport, loses engine power and crashes at Fairfax Street near Queen.

Within two minutes the police and fire departments are on the scene. Within five, the city manager is convening City Council with the intention of declaring a state of emergency.

In an hour, the Health Department has set up a morgue in the cafeteria of Hatmond Junior High School.

The countdown continues as the hypothetical tragedy unfolds, making a horrible situation perhaps a bit more manageable.

Such a scenario, which was prepared for city officials by the Public Safety Department in 1985, is not the kind of thing people like to contemplate on a sunny day, or even a cloudy one.

But Mayor Jim Moran and the city's safety officials are urging Alexandria residents to give some thought to such matters, on grounds that businesses and individuals — as well as public personnel — need to plan for "worst-case" episodes, and need to realize that many disasters of

City safety officials catalog lengthy list of disasters could happen here. In addition to the airplane crash, they include air pollution, a boat accident, civil disorders, a terrorist deed, a construction accident, prolonged drought, an accident in a high-rise, a pipeline accident, or contamination of water supply.

"If you think ahead, you can avoid small disasters," said. "For the things you can't avoid, be aware, and be prepared to cope."

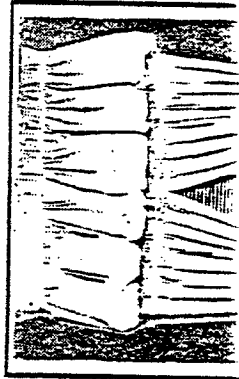
