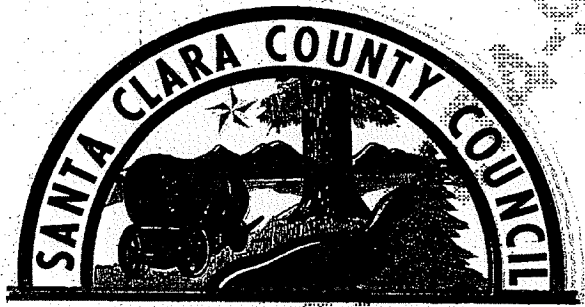

Mr. WATSON WAS FIRST REGISTERED WITH US ON 4-16-66 AS ASSISTANT SCOUTMASTER OF TROOP 501. HE HAS BEEN INFORMED THAT WE ARE UNABLE TO ACCEPT HIS REGISTRATION AND HIS REGISTRATION FEE HAS BEEN RETURNED. THE TROOP COMMITTEE IS AWARE OF THE SITUATION.

Mr. WATSON IS 24 YEARS OLD (BIRTH DATE, 1-21-42), SINGLE, BLOND, BLUE EYES, 5'9" HEIGHT, 175# WEIGHT, AND WORKED AS AN ELECTRONICS TECHNICIAN IN REDWOOD CITY. HIS HOME ADDRESS IS 18166 FERN AVE., REDWOOD ESTATES, LOS GATOS, CALIF.

Sex Offenders Get Court Sentences

offenses brought jail terms, a fine and probation to five male defendants in Superior Judge Harold Hadden's criminal court.

Called here: Gabriel S. Souza, 26, a card room janitor, of 1836 Franklin St., Santa Clara, six months, for exposing himself to a female at the Santa Clara post office June 11. Souza said he had been playing cards, was drunk, could not recall his offense.

Leonard Manuel Sepulveda, 22, a warehouseman, of 1497 Little Orchard Rd., 60 days and two years' probation for contributing to the delinquency of a 13-year-old Santa Clara girl last April. Defendant said the girl

"turned me in because I didn't want to get married."

Jose Quesada Garcia, 28, a Spence street laborer, 30 days and two years' probation. He admitted molestating a nine-year-old girl in Jose's office in Redwood City electronics technician, \$200 fine and two years' probation, for lewd and lascivious conduct with a 12-year-old boy on numerous occasions earlier this year.

Placed on five years' straight probation was Erle Otis Cross, 49, an office machine repairman, of 1457 Jeffrey Ave., for lewd and lascivious conduct with an eight-year-old girl.

Assistant Scoutmaster Arrested

A 24-year-old Redwood City assistant scout master has been arrested by the Santa Clara County sheriff's office for child molestation and committing lewd and lascivious acts with children.

Ecked into Santa Clara County jail was Thomas Burton Watson of 28166 Fern Ave. in Redwood City.

The two boys, ages 12 and 13, respectively, met Watson at the Redwood City swimming pool last year and became interested in him because he was an assistant scout master and interested in camping and hiking.

The boys' fathers, who are divorced, let their sons go on camping and hiking trips with Watson because there were no fathers in the boys' home and because of Watson's association with the scouts. The alleged molestations and lewd acts took place on these trips.

The information came to light when one of the boys told his father of the incidents while visiting him. Watson is being held without bail.
