I am going to set up a confidential file and refuse registration should he attempt it anywhere in the country. There is no need for you to contact him at this time related to this, according to our corporate attorney.

I would, however, like to have a confidential record sheet completed to the best of your ability. We would then use this as the basis for identification at a later time.

If you could complete this file with as much information as you have available this would be most helpful to us. Do not be concerned if some of the areas are blank since we will complete some of these from other information which we have available.

We would also like to know where he was accused of sexual assault in 1982. This would be extra information for our file.

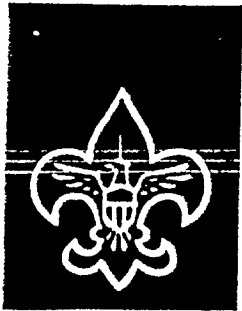

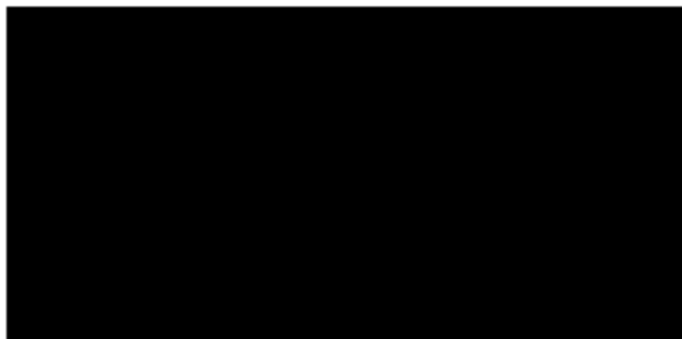

We believe [redacted] much as is instrumental in the arrest and sentencing to St Lawrence of an Assistant Scoutmaster of Troop 2 in Okinawa in 1983 or 84. We don't remember the Scoutmaster's name, but we know he worked at the [redacted] Hospital.

I only wish there was something legal we could do to imprison both, but I have been informed by [redacted] at OSI, Caswell that they only have jurisdiction over Tom Siefert but because Jim Hale is a civilian they cannot do anything.

It is comforting to know that he will never be able to be around Scouts again, but what about other kids, - Boy's Clubs, YMCA where Jim possibly will apply for a job.

Jim Hale is originally from Pearl City, Hawaii and he was always involved in Scouting there.

[redacted] who in the ^{late} 1970's had warned us of a possible problem with Jim was a Scoutmaster there. Our other son [redacted] was more or less a test in some ways for Jim because he had never done anything out of the ordinary with him, we thought the rumors were only rumors. It is such a sad thing for all the kids he has touched.

Again I want to thank you for such quick action in this matter. He as a family loved Scouting and all of us were deeply involved for several years and I know it is a good program for young boys. I would hate to have it ruined by people like Jim & Tom.
