## Boy Scout leader gets abuse term

A 36-year-old janitor was sentenced to six years in prison Monday after he pleaded guilty to molesting six boys, including five Boy Scouts whom he had met as a scouting leader in the Uptown area.

Thomas M. Whalen, arrested in November when police saw him talking with one of victims on the street, pleaded guilty Monday to aggravated criminal sexual assault, aggravated criminal sexual abuse and exhibiting child pornography.

Criminal Court Judge James Bailey gave Whalen the minimum sentence despite allegations by prosecutors that Whalen had been engaging in sex with minors for more than a dozen years.

Assistant State's Atty. Gregory Ellis said Whalen had been a Boy Scout troop leader for 10 years. Ellis said the six victims who gave information to police were a 10-year-old, two 12-year-olds, two 13-year-olds and a 14-year-old.

Ellis said Whalen has been held in Cook County Jail in lieu of \$50,000 bond since his arrest Nov. 23.

According to the evidence compiled by the special investigative unit of the Chicago Police Department's youth division, Whalen would display child pornography from magazines, play strip poker with the boys, always losing, and then engage in sex with them. In some instances, he would photograph them.
