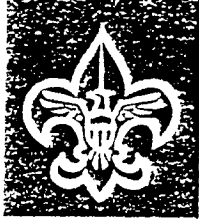

Thomas W. Huyett, 31, of the 700 block of North Front Street, was sentenced by President Judge Forrest G. Schaeffer Jr. to four years of probation and fined \$250 on a charge of corrupting the morals of a minor.

Charges of indecent assault, indecent exposure, and providing alcoholic beverages to a minor were dismissed.

Police accused Huyett of incidents involving a 16-year-old city male between Jan. 22 and 23 in a cabin off Pine Grove Road in Bethel Township.

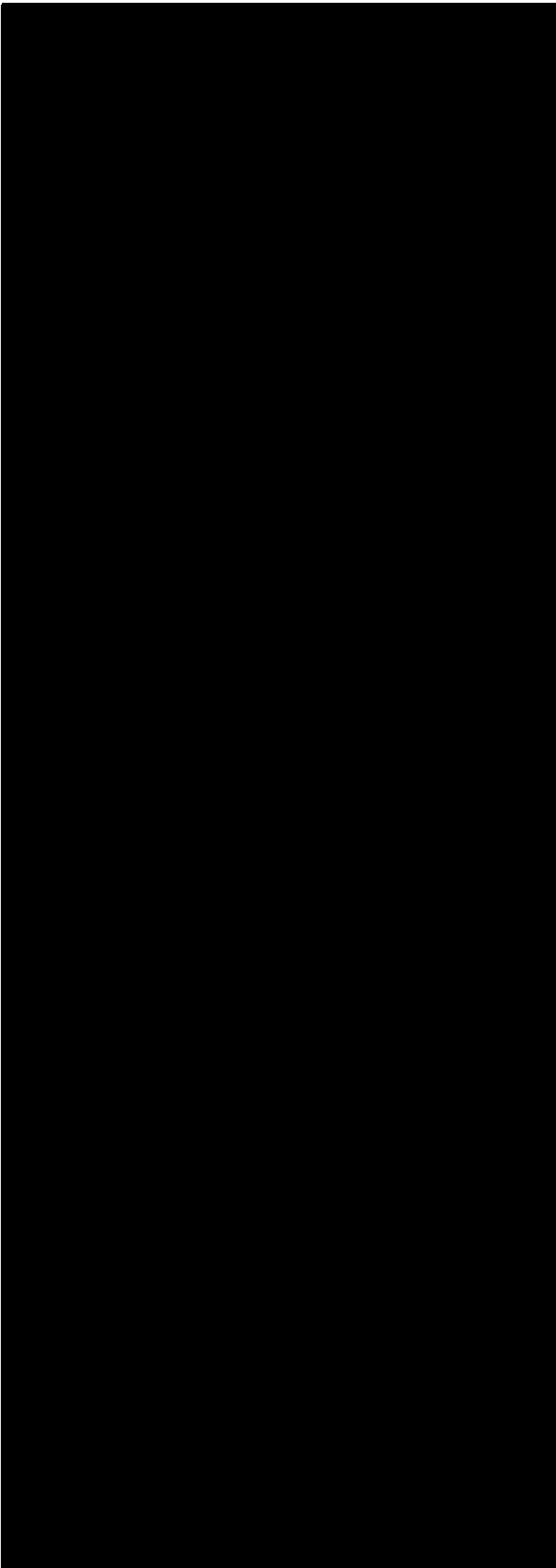

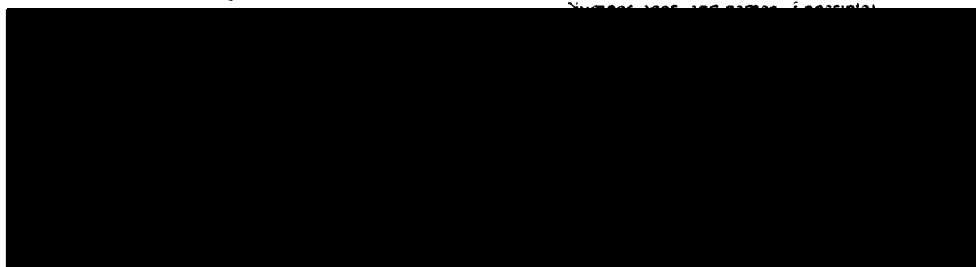


Enclosed are confidential record sheets for two Scouters.
