HOWEVER, THE POLICE RECORD INDICATES PRIOR CONVICTIONS. THEY ARE UNWILLING TO GIVE US A COPY OR PHOTOSTAT OF THIS RECORD DUE TO A LEGAL INTERPRETATION IN ALAMEDA COUNTY. WE WILL CONTINUE TO TRY TO GET SOME DOCUMENTARY PROOF. WE HAVE ASKED FOR A WAIVER TO ALLOW PHOTOSTATS TO BE MADE. WE ARE AWAITING A REPLY ON THIS. INCIDENTELY, HE WAS INJURED IN THE KOREAN WAR AND IS A VETERAN OF WORLD WAR II. HE WAS SUPPOSED TO HAVE SUFFERED A BRAIN INJURY AND HAS A METAL PLATE IN HIS HEAD AT POINT OF INJURY. THIS IS NOT OBSERVABLE.

This additional information will enable us to identify Mr. Coffee should he ever again attempt to register in the Scouting program. Thanks for your help.

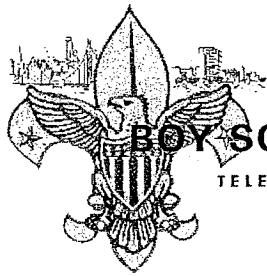
