Dear Sir:

The following report is in regards to an investigation conducted by the Ouachita Parish Sheriff's Department in regards to some alleged homosexual acts and indecent sexual acts with teenage boys involving one Tommy Young, a white male.

AGENCY: Ouachita Parish Sheriff's Dept.

COMPLAINANT: Mrs. [REDACTED] alias Mrs. [REDACTED], West Monroe, Louisiana, telephone no. [REDACTED].

NATURE OF CRIME: Reported Homosexual Acts with Teenage Boys and also indecent sexual acts.

DATE REPORTED: August 10, 1965

TIME: Approximately 3:00 P.M.

DEPUTY ASSIGNED: [REDACTED]

M.O.: The suspect, Tommy Young, affiliated with Boy Scouts of America supposedly to have been having homosexual acts involving indecent sexual acts with teenage boys who are Boy Scouts and who are members of the boy scout troop of which Tommy Young is the Scoutmaster and also serves on the Advisory Committee. The suspect, Tommy Young, supposedly playing with the penis of some of the boys in the Boy Scout Troop and has tried to get some of these boys to let him put his penis in their mouth.

EVIDENCE: See statements of subjects interviewed in regards to this complaint which are attached hereto as a part of this report.

SUSPECT: Tommy Young, 709 South 2nd St., West Monroe, Louisiana, telephone no. 323-4775.

INFORMATION: On August 10, 1965 a Mrs. [REDACTED] alias Mrs. [REDACTED] of [REDACTED], West Monroe, La. reported to Chief Criminal Deputy [REDACTED] and me, Sgt. [REDACTED] that she suspected that Tommy Young who is one of the Scoutmasters for the Boy Scouts of America and who has been in charge of Post 10 of having homosexual acts and other indecent sexual acts with some of the teenage boys who belong to Post 10 of the Boy Scouts. She went on to state that in fact her son, [REDACTED] 17 years of age, had told her of about some of the acts that he had while with Tommy Young. She advised us that [REDACTED] was her son by a previous marriage and she had two other sons of whom she suspected of being engaged in some of these sexual acts with Tommy Young. She requested that this department make an investigation. However, at the time she made her complaint to Chief [REDACTED] and me she requested that we hold up on the investigation until she could have a further talk with her son and then she would notify this department.

On August 11, 1965 Mrs. [redacted] advised us that her son, [redacted] 17 years of age, would meet me, Sgt. [redacted] at 6:00 P.M. and he would give me a statement in regards to the alleged above complaint. The following interviews were made with the subjects whose name appears below:

INTERVIEW #1.

[redacted] white male, age 17, date of birth March 14, 1948, address [redacted], West Monroe, La. This subject, [redacted] is the son of the complainant, Mrs. [redacted]. At 6:00 P.M., August 11, 1965 I met [redacted] at the Standard Office Supply on St. John St. and brought him to the Ouachita Parish Court House to the interrogation room and this subject was interviewed and questioned in regards to some alleged homosexual acts and other indecent sexual acts that occurred between him and the suspect, Tommy Young.

In the interview with [redacted] he told me that on several occasions Tommy Young had played with his penis causing him to reach ejaculation and he, [redacted] had also played with Tommy Young's penis causing him to reach ejaculation. He also stated that Tommy Young had gotten him to put his mouth on his penis on one or two occasions and that on two occasions Tommy Young had got up on top of him and Tommy Young had put his penis into his rectum, and he had reached ejaculation on both occasions while having his penis in [redacted]'s rectum. [redacted] stated that both of these occasions occurred at Lake Bruin. However, [redacted] denies that Tommy Young has ever put his mouth on [redacted]'s penis. (For further details -- correction) Also [redacted] states that Tommy Young has carried beer, vodka and gin on some of the boy scout outings and he permitted some of the boys in the troop to drink some of the beer, also some of the vodka and gin with him which [redacted] included himself. (For further details see statement of [redacted].)

INTERVIEW #2.

[redacted] white male, age 17, address [redacted], West Monroe, Louisiana.

On August 12, 1965 I called [redacted], West Monroe, La. and requested that she bring her son, [redacted] to the Court House so that he may be interviewed and questioned in regard to some of the homosexual acts and some of the other indecent sexual acts that had been occurring between him and some of the other teenage boys who live in the neighborhood.

Mrs. [redacted] brought her son, [redacted] to the Court House where I, [redacted] took [redacted] into the interrogation room and questioned him in regards to some of the alleged homosexual acts and other indecent sexual acts that had been going on in the neighborhood where he lived. [redacted] admits that he has been to the house of Tommy Young at 709 South 2nd St., Monroe, La. to watch color television with him, that he had been invited over there by Tommy Young and on one occasion in particular he mentions was the night of Sonny Liston fight. He states that Tommy Young showed him some hand drawn sketches of nude people committing or where they would be engaged in sexual acts, some homosexual drawings, some normal sexual acts and just some

plain pictures of nude women. [redacted] stated that these pictures were shown to him by Tommy Young more or less to arouse his passion and his sex drives and when these -- correction -- and when his passion was up he and Tommy Young played with each other's penis, both of them reaching ejaculation. [redacted] stated he did not know who drew these pictures but he thought they were possibly drawn by Tommy Young and he had ran several copies off of a stenciling machine. Upon further questioning [redacted] he admits of having also played with the penis of [redacted] white male, age 11, on several occasions and [redacted] had also played with [redacted] penis causing him to reach ejaculation each time. (For further details see statement of [redacted] which is part of this report.)

INTERVIEW #3. [redacted] white male, age 17, date of birth March 14, 1948. This subject is a brother to interview #1, [redacted] of which [redacted] and [redacted] are twins and who are sons of Mrs. [redacted]

On August 13, 1965 I went to the residence of the complainant, Mrs. [redacted], St., West Monroe, La. and picked up [redacted] and [redacted] age 11, who is also the son of Mrs. [redacted] by her present marriage. After arriving at the Court House [redacted] was brought into the interrogation room and questioned in regards to any homosexual acts between him and Tommy Young. However, [redacted] denies that Tommy Young has ever tried to play with his penis, also denies that he has ever played with Tommy Young's penis and that at no time had Tommy Young ever made any sexual advances toward him, and he states probably the reason for this was that Tommy Young was probably afraid that [redacted] would tell on him. [redacted] does admit in his statement of having seen beer and other alcohol beverages in the possession of Tommy Young when they would be on some of the scout outings. [redacted] states he does not know of any of the boys who Tommy Young has messed with other than he mentions one subject, [redacted] who he states had told him that Tommy Young had made some sexual passes at him, but of his own knowledge he did not know this. (For further details see statement of [redacted] attached hereto.)

INTERVIEW #4. [redacted] white male, age 11, date of birth Dec. 30, 1953. [redacted] is also a son of Mrs. [redacted] by her present marriage. He is a half-brother to [redacted] and [redacted]

[redacted] was questioned also on Aug. 13, 1965 in regards to the complaint as mentioned above. He states that Tommy Young has never tried to play with him nor has ever asked him, [redacted] to play with him (Tommy Young). He does admit, however, of having been at the residence of [redacted] and [redacted] has taken his hand and played with his penis and he, [redacted] had also played with [redacted] penis. [redacted] said that each time he played with [redacted]'s penis some white stuff would come from the penis of [redacted]. In the statement [redacted] goes on to relate that these indecent

sexual acts between him and [redacted] have occurred on numerous occasions and on one occasion he put [redacted] penis in his mouth but just for a very short time and then took it out. (For further details see statement attached hereto of [redacted].)

INTERVIEW #5. [redacted], white male, age 16, date of birth April 9, 1949.

[redacted] states that he met Tommy Young approximately three years ago at which time he joined the Boy Scouts and that last year right at hunting season he had gone to a camp in Caldwell Parish belonging to Tommy Young and that was the first time that Tommy Young had made any advances toward him by taking [redacted], Jr.'s penis from his underwear while they were in bed and playing with him. [redacted] said that he told Tommy Young to stop which he did. Nothing else happened on that occasion. He stated that at the end of hunting season he, Tommy Young and another subject went down to the same camp in Caldwell Parish and that again Tommy Young started playing with his penis that night while they were in bed. He told him to stop and he quit awhile then he started back, pulled his underwear down and Tommy Young got him, [redacted] to play with his penis and both subjects playing with each other reached ejaculation. He states that these acts have gone on numerous times between him and Tommy Young, almost every time they would go off on a camping trip or be together that these acts would be committed between him and Tommy Young by playing with each other's penis causing each other to have ejaculation. [redacted] states that only one time has Tommy Young tried to put his penis into his mouth and he did put it into his mouth for a short period of time and then took it out. [redacted] has this past week from Aug. 8 until the night of Aug. 12th has been on Lake Bruin with Tommy Young; however, he states that Tommy Young has not made any sexual advances toward since they had been down on the Lake Bruin this week. He stated that the last time that Tommy Young played with his penis/[redacted] played with Tommy Young's penis was last week of which he mentioned Thursday, Aug. 5th at which time they were in Caldwell Parish. He states at that time both he and Tommy Young played with each other's penis, both subjects reaching ejaculation. [redacted] denies at no time Tommy Young has ever put his mouth on his penis and tried to have a homosexual act with him. He states that Tommy Young has always tried to put his penis in [redacted]'s mouth, but instead they usually wound up by playing with each other's penis reaching ejaculation. [redacted] also states that he had drank beer with Tommy Young on several occasions on these outings and that also Tommy Young has carried Vodka and Gin with him on some of the Boy Scout outings and around some of the camps. [redacted] further admits that he has been to [redacted] correction -- has been invited over to Tommy Young's house to watch color television and Tommy Young has showed him some nude sketches, believed to have been drawn by hand, of naked women and also some pictures of women and men having sexual intercourse, also nude pictures of two men committing or engaged in homosexual acts. [redacted] went on to say that these pictures were

drawn by Tommy Young and he had made several prints of them by using some kind of machine to run them off. However, [REDACTED] says that Tommy Young has never tried to play with him when he would be at his house or when he would show him those pictures. He states that Tommy Young has never made any advances toward him or indicated that he wanted to play with him.

INTERVIEW #6. [REDACTED], white male, believed to be approximately 17 years old, address [REDACTED], West Monroe, La.

This subject, [REDACTED] is out of town on vacation and at the present time is supposedly in Mexico and has not been interviewed in regards to the above alleged information.

I, the undersigned Deputy, Sgt. [REDACTED], have been advised that [REDACTED] is to return to Monroe Saturday, August 14, 1965.

Nothing further at this time.

The following is a statement taken from Tommy Fletcher Young, Jr. spelling name T-o-m-m-y, middle name F-l-e-t-c-h-e-r, last name Y-e-o-u-n-g, Jr., white male, age 31, date of birth June 22, 1934. This statement taken on the 3rd floor of the Ouachita Parish Court House in reference to homosexual acts or indecent sexual acts involving teenage boys and Mr. Tommy Young. This statement taken this 15th day of August 1965 in the presence of Deputy Sheriff [redacted] and Sgt. [redacted].

- Q. Would you state your full name, please?
- A. Tommy Fletcher Young, Jr.
- Q. How old are you, Mr. Young?
- A. 31.
- Q. Your date of birth?
- A. 22nd of June '34.
- Q. And your address?
- A. 709 South 2nd, West Monroe.
- Q. Are you married, Mr. Young?
- A. No.
- Q. Have you ever been married?
- A. No.
- Q. What is your occupation, Mr. Young?
- A. I'm unemployed at the time.
- Q. Are you ...
- A. Work as ah - aircraft work - some maintenance and ground crew.
- Q. At the present time are you affiliated with the Boy Scouts of America?
- A. Yes.
- Q. In what capacity?
- A. Scoutmaster and Explorer Advisor.
- Q. Are you in charge of a troop or post?
- A. Both.
- Q. Which troop?
- A. Troop 10 and Post 10.
- Q. Mr. Young, in your presence there is a microphone, also a soundsciber machine which is on. This machine can be identified being on by the lights that are on in the machine and also a little white light on the right hand corner of the machine which is blinking indicating that the machine is recording anything that you and I might say or [redacted] might say. Are you aware of that?
- A. Yes sir.
- Q. The machine and the microphone are both in plain view of your vision?
- A. Yes sir.
- Q. Also prior to the starting of this statement I advised you of your rights telling you that you do not have to make a statement,

that anything you say may and can be used against you.

A. Yes sir.

Q. That you are also entitled to have a counsel present. Did I not sir?

A. Yes sir.

Q. Also I handed you a waiver which explains to you your rights entitling you to an attorney-at-law and any other rights that you might have, that the statement would be voluntary and not under any duress of any kind or without any reward. Is that true, sir?

A. Yes sir.

Q. And after you read this waiver you have signed this waiver indicating below? Is that right?

A. Yes sir.

Q. Mr. Young, we would like to ask you some questions pertaining to an alleged - some alleged indecent sexual acts involving some boys that are in your troop with relationship to some indecent sexual acts. Do you know a subject by the name of [REDACTED]?

A. Yes sir.

Q. Do you know how old [REDACTED] is?

A. 17.

Q. Is [REDACTED] in your - in post 10 which is under your supervision?

A. Yes sir.

Q. Mr. Young, have you ever committed any indecent sexual acts with [REDACTED]?

A. Couple times.

Q. Where did these incidents take place?

A. At Lake Bruin, I believe it was.

Q. In what parish is Lake Bruin in?

A. Tensas.. out of St. Joseph.

Q. Do you know about when these acts were - when these acts took place between you and [REDACTED]?

A. As the time - no sir - I mean how long ago - I don't remember.. been back in the spring I guess.. sometime in April.. March or something like that.

Q. Was it before school was out? Or after school was out?

A. Before school was out I believe. I don't remember. I sure don't remember Mr. Booth.

Q. Would you state in your own words tell exactly how it happened, what happened?

A. Well, I don't know how to say it happened - it just did. I don't know ...

Q. Well did you take a group down there - or how many was down there at Lake Bruin with you?

A. Three of them - went down - we went fishing.

Q. Who were the three?

A. Eh myself and [REDACTED] and [REDACTED].

Q. That would be [REDACTED] and [REDACTED]?

A. Yes sir.

Q. Was it on a week end?

A. Yes sir. We left on a Friday afternoon, and his parents came down there Saturday.

Q. Well what happened that Friday night when you got down there?

A. We just had the relation.

Q. Just tell in your own words how?

A. I don't know how to tell it. It's be - ah - just did.

Q. Well was it by homosexual act or ...

A. No.

Q. Masturbation?

A. Masturbation.

Q. Other words - whose camp were you in down there at Lake Bruin?

A. My father's.

Q. How many beds are in this camp?

A. Oh - three.

Q. Well how did the three of you all sleep? That night?

A. Two in one bed and one in the other. [REDACTED] was in the bed by himself and [REDACTED] and I was in the bed together.

Q. In other words you slept with - you started off sleeping with [REDACTED] in a double bed. Is that correct?

A. Yes sir.

Q. And [REDACTED] was in a more or less single bed?

A. Three quarter bed - yes sir. Single bed.

Q. How did you all sleep that night - in the nude or in your shorts or...

A. My underwear.

Q. Underwear. Did you play with [REDACTED]'s penis that night?

A. Yes sir.

Q. Did he reach a climax?

A. Yes sir.

Q. Did [REDACTED] play with your penis?

A. Yes sir.

Q. And as a results of that did you reach a climax?

A. Yes sir. I did.

Q. Was it after these acts had been going on between you and [REDACTED] after that you went over and got in the bed with [REDACTED]?

A. Yes sir. Guess so - after that.

Q. Well was it after that or before?

A. After that - we laid there and talked a while and then I got over in the bed with [REDACTED].

Q. Well what happened after you got in the bed with [REDACTED]?

A. He and I had the same thing except I stuck it up his rectum that night.

Q. Did you start off by playing with his penis and him playing with your penis?

A. Yes sir.

Q. Did you reach ejaculation at that - did either one of you reach ejaculation at that point?

A. No sir.

Q. You did play with each other and then after you had raised an erection you then put your penis into [REDACTED]'s rectum?

A. Yes sir.

Q. Did you reach a climax from the results?

A. No sir. If I remember right I did not.

Q. How many times have you had that type of - that kind of relationship with [REDACTED] by putting it in his rectum?

A. At the very most twice.

Q. Did both times ....

A. One that I remember - this one that we're speaking of now I remember, but if we had it before I don't remember. It's a possibility we did. I don't recall.

Q. That same night or the next day which was Saturday at any time did you put [REDACTED]'s penis in your mouth?

A. No sir.

Q. Did [REDACTED] put your penis in his mouth?

A. No sir.

Q. How about [REDACTED] did he have a homosexual with you?

A. No sir.

Q. Did you have a homosexual act with him?

A. No sir.

Q. When was the next time you were with [REDACTED], Tommy?

A. That was the last time I guess we went down there or went anywhere together. That I can remember -- last time except for swimming and stuff like that at home.

Q. Let's see if I can refresh your memory just a little. How many trips to Lake Bruin has [REDACTED] went with you?

A. Twice.

Q. Well the incident that occurred was that the last time or the first time this [REDACTED] went to Lake Bruin with you?

A. That was the - we went twice and we done it both times we were down there. He went with me twice to Lake Bruin.

Q. And each time that he went these acts were - you and [REDACTED] had these kind of relationships with each other. Is that correct?

Page 5. (Statement of Tommy Fletcher Young, Jr., wm)

A. Yes sir.
