Denied registration for following reasons:

1. Current criminal charge of felony theft. (11/3/89 Madison Police Dept.)
2. Falsifying information on his BSA Adult Application. He stated he was a member of tribe of Mic-O-Say in Heart of America Council - That Council denies this.
3. Publication of false information. He stated to a District Commissioner that he is an Eagle Scout. BSA denies any record of this. He stated to same District Commissioner that he is a Vigil Honor member of the Order of the Arrow, there appears to be no record of this. He wears insignia representing both of these awards.
4. We have been advised confidentially by reliable sources that Travis may have engaged in sexual abuse activities with younger boys some years ago.

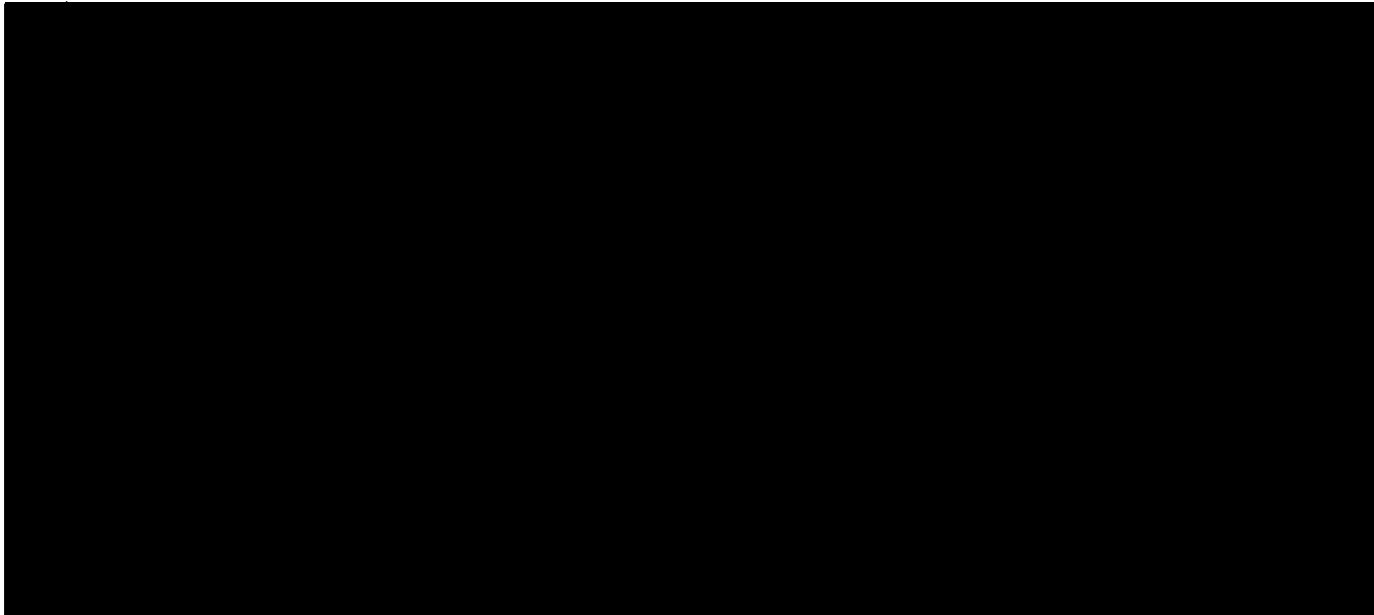

NOTES FOR FILE

Travis Ashmore
Madison, Wisconsin

Travis Ashmore gave a lengthy background in his defense regarding his participation with the Lisle Scout Troop.

He explained that he felt his membership denial applied only to the local troop that he had been involved in. This young man comes from an extremely troubled family. His mother is getting married for the seventh time and is pregnant at age forty-two.

Concerning criminal charges while working at Cub Foods, he was aware of, and observed, a fellow employee stealing Nintendo tapes valued at approximately \$500.00. Charges were dropped from grand larceny to petty theft. When interrogated he first denied knowledge. The employee involved skipped town. Ashmore was arrested and taken to jail. While there, he plea bargained, admitting criminal knowledge. He anticipates 2 months in jail and 2 years probation.

He is contrite but appears deceitful. In an interview one has an uneasy feeling of mistrust. In conversation with the Scout executive, he feels a sense of empathy for a person to whom Scouting has meant so much.

Chandler indicates a willingness to reconsider Ashmore's future registration.

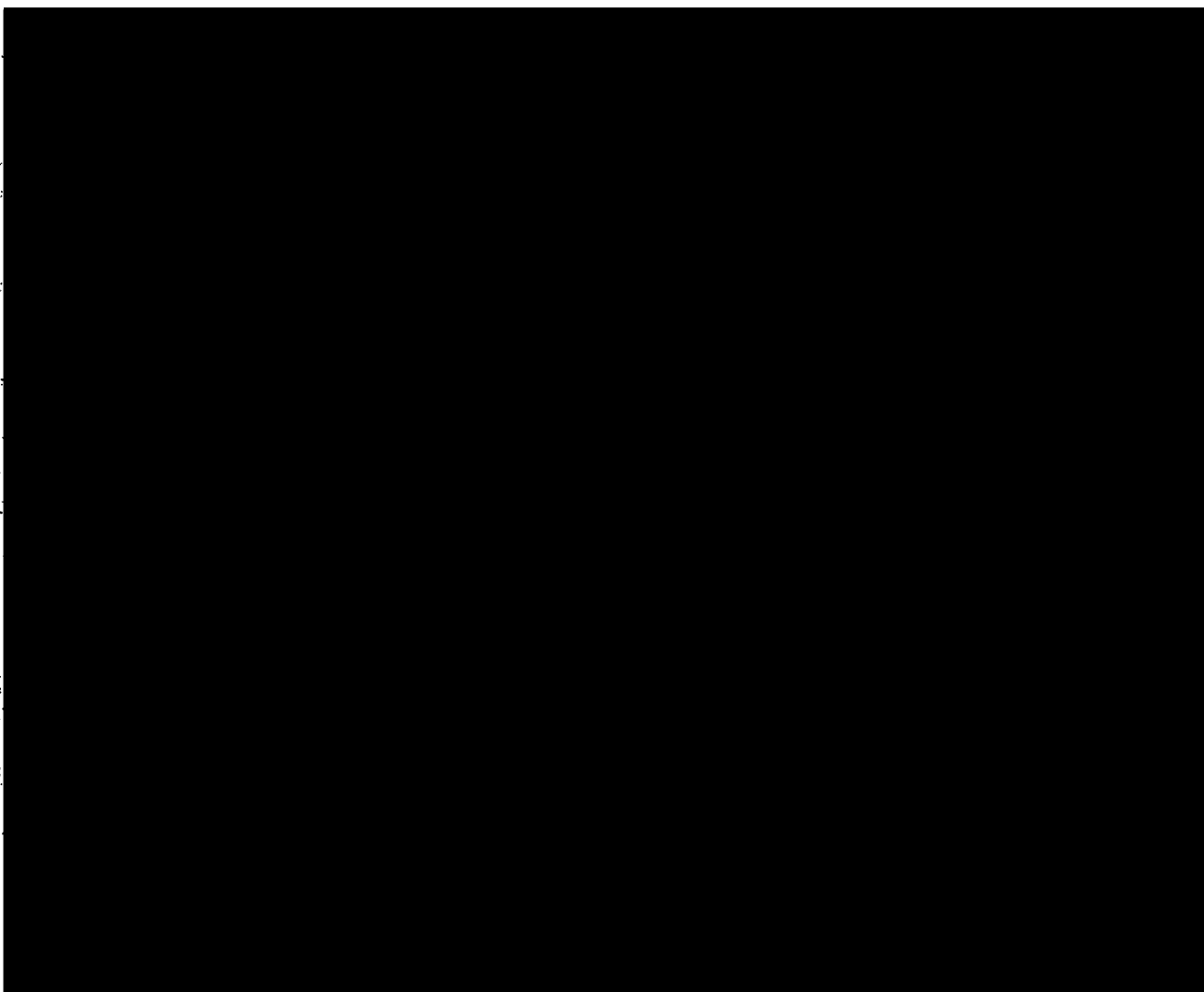

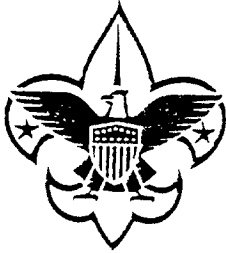


Dear Travis:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.
