



Vernan Kinney had been acting as a Scout leader of Pack 443 chartered by the Church of Jesus Christ of Latter-Day Saints. Was also abused by Eric Avant, Scoutmaster of the same troop.

Will be talking with our attorneys snortly.

By carbon copy of this letter I am advising Scout Executive Robert Cree of my recommendation that Vernan Kinney be placed on the Ineligible Volunteer File.
