Ex-Scout Leader Pleads Guilty To Sex Charges

CORVALLIS (AP) — A former Boy Scout leader who had been honored for his 21 years of volunteer service to the youth group has pleaded guilty to misdemeanor charges stemming from the sexual abuse of a 16-year-old boy. William E. Tobiassen, a 57-year-

William E. Tobiassen, a 57-yearold Corvallis insurance agent, pleaded guilty Wednesday to second-degree sexual abuse and contributing to the sexual delinquency of a minor. The pleas were entered in Benton County District Court.

Each charge is punishable by up to one year in jail and a \$2,500 fine. Sentencing was set for Oct. 31.

Tobiassen had pleaded innocent to the charges July 11 following an investigation that began May 21 when a parent of the boy complained to authorities. Tobiassen was released on his own recognizance and ordered to report to the Oregon State Hospital in Salem for evaluation to determine whether he is a sexually dangerous person.

Thomas L. Gallagher, Tobiassen's lawyer, said Tobiassen pleaded guilty to the charges on the condition that the state not file other charges of sexual misconduct against him.

Expert: Sexual abusers of children not curable

CORVALLIS (AP) — The director of the sexual offender program at the Oregon State Hospital says there is no cure for people who sexually abuse children.

"There are no cures," said Robert Freeman-Longo. "At any point in time, if they believe there's no longer a problem, they're prone to fall back into their deviancy."

Freeman-Long recently gathered data showing that the 35 men in the hospital's sex offender unit claimed. responsibility for a total of 20,276 sex crimes, ranging from obscene phone calls to exhibitionism to rape.

The 17 child molesters in the unit accepted responsibility for about 4,-000 sexual assaults on more than 1,-000 victims, with one offender claiming 500 female victims.

Like recovered alcoholics, a pedophile who has received treatment must avoid exposure to anything that might arouse his desire for children. The behavior is compulsive and addictive, Freeman-Longo said.

Of the 20 men released in the Salem area aftger undergoing at lest two years of the rigorous program for sex offenders, only two were involved in sexual crimes leading to re-arrest, Freeman-Longo said. Both involved the theft of women's ___underwear.

A sudden increase in reports of child sexual abuse and the need for better methods for teachers, parents and social workers to cope with the epidemic were the focus of a recent two-day sexual abuse conference at Oregon State University.

Social workers at the conference learned that unlike physical abuse, which often can be spotted by teachers and doctors because of physical evidence of the crime, sexual abuse is a covert crime in which the offender gradually gains the trust of a child, then exploits that trust.

Freeman-Longo said that data from child molesters he works with show that the most likely victims are boys between 6 and 12, which goes against most studies that indicate the most common victims are young girls. He said he suspect that's because boys have not yet overcome the taboo against talking about sexual crimes and, consequently, are not as open about asking for help.

This is to be attached to the letter from and become a permanent part of our inactive file.

A letter from **Sector and the sector and any information in our Confidential File and the answer was that no information existed.**

After more consulation I called Mr. Buford Hill, the Scout Executive of the Orange County Council, where Mr. Scott lives. Buford Hill immediately indicated that he was personally acquainted with the individual and that he had been an active volunteer in the council.

On July 31, I received a call from Mr. Hill indicating that he had done some investigation and that he had also talked to Mr. Walter D. Scott.

The indication was that Mr. Scott had never been in the hospital, which was indicated in the letter but that it was possible that the back had been. It seems there have been many problems within the family relationships and that the back which indicates was abused, eventually left his mother and will not allow visits to his children by their grandmother.

It seems that Mr. Scott has also maintained communications with both the daughter and the son over the years, and is presently an active volunteer with a long time marriage and has retired as a pilot.

Mr. Hill indicates that Mr. Scott would like a copy of the letter which had come to us for his attorney, so that further letters could be stopped. Mr. Park and I have refused this request based on the problems this could cause us in a potential liability related to releasing confidential information which would affect an individual's character.

Abusers need quick therapy

Dear Abby: This concerns the letter from the woman who wrote to say that her brother might be sexually molesting his stepdaughter. Asdistrict attorney, in the past seven years I have personally interviewed 140 men who have sexually molested

children in their family. While longterm intensive therapy may be successful in treating some offenders, roluntary or self-referrals are almost never successful. If the offender had the self-control and initiative to stay involved in longterm treatment necessary for rehabilitation, he would most likely not have molested the child in the first place.

I would urge you to tell your readers who suspect that a child is being molested to immediately contact their local child protective unit or the police department.

Some jurisdictions have programs. That provide treatment without incarceration for incest offenders and their families where evaluation indicates that treatment will be success ful. Specifically excluded from these programs, however, are pedophiles — individuals with a specific sexual

Don't you bother to check the backgrounds of your volunteer Scout-leaders before you let them work closely with young boys? How do the Boy Scouts of America happen to be issuing awards to a volunteer Scout-leader who has a criminal record, who spent time in Atascadero State Hospital for the Criminally Insane (California) for sexually abusing children?

The volunteer I refer to is Walter D. Scott. His address is 24951 El Caballo, El Toro, California 92630. I know of what I speak because I was his first wife and an eyewitness to the sexual abuse of the sexual when I walked in and caught him. He also sexually abused the second wife who pressed divorced him, and he remarried. It was his second wife who pressed charges against Scott for the sexual abuse of the second wife who pressed and Scott consequently spent time in Atascadero. At that time Scott's parole officer said that his kind rarely change.

So, what is Walter D. Scott doing as a Boy Scout leader now? How can the Boy Scouts be sure Scott isn't taking these boys out on camping trips and sexually molesting them when these offenses are so rarely reported by the victims? How many parents do you suppose would want Walter D. Scott working with their children -if they knew his background? I trust you will give this matter your prompt attention.

Two years ago I wrote to you concerning the criminal record and background of Scout-leader Walter D. Scott, copy attached. You evidentally did not believe me. Walter Scott is still a Scout-leader.

You evidentally gave Walter Scott a chance to clear his name, and he came up with a "release" from Atascadero State Hospital for the Criminally Insane. An expert on that program gave testimony, and T duote,"Treatment is almost universally unsuccessful." Please note that Freeman-Longo states that his studies show the most likely victims of these offenders to be boys between the ages of 6-12 -- because these are the most likely to avoid seeking help.
