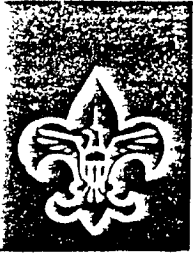



Enclosed please find the resignation letter of Walter Phipps per your inquiry of June 29, 1987.

I received a call on June 1, 1987 from [REDACTED] of McClare, Iowa telephone number [REDACTED] stating that he accuses Walt Phipps of child molestation and that he was pressing charges. Mr. Wakeman called me because he was aware of Walter Phipps involvement in Scouting within this Council.

I called Walt Phipps and spoke to him on the evening of June 1. I told him that "I have been informed of some alarming news about him and desired to visit with him " with no mention of the information or sources. He indicated that he knew what I was referring to and that he would resign immediately from Scouting and provide me with a letter within the week.

I will be informed if he attends a Troop meeting at which he was the Scoutmaster. I am aware of no other meeting he would have attended since June 1. A sizable number of Scouters are aware of his abrupt resignation and have inquired, but we have shared no information. I understand there was a warrant announced in the paper, but I did not see the item.

Walt Phipps was an active Scouting leader, having served on our Council's 1986 Camp Staff. I know the man, had no suspicion nor am I aware of anyone who did.

Please inform me if you would have me take further action.
