Gentlemen:

On Saturday, October 11, 1986, Mr. Walter Lee Godin, Scoutmaster of Troop 170 in Orlando, Florida was accused by a Scout in his troop by the name of [REDACTED] (legal name [REDACTED]) of "attempting to play with his private parts" and to "feel him in the crotch." This activity took place at the council camporee at the Mormon ranch in Osceola county.

Mr. Godin was notified both in person and in writing that he should refrain from participation in Scouting until the matter could be settled.

On October 12, 1986, I reported the alleged incident to the Osceola county sherrif's department and also to a special prosscutor for the state of Florida that specializes in child abuse cases. The special prosscutor "Richard Parkinson" is also an assistant council commissioner.

On October 15, 1986, I was notified by Richard Parkinson that a check of records has revealed that Walter Lee Godin, social security number [REDACTED] was convicted of child molestation in August 1981 in Orange County, Florida. Judication was withheld at that time. Mr. Godin was placed on probation and is still reporting to a probation officer. Mr. Godin is approximately 5'8" tall and weighs 190 lbs. He has brown hair and brown eyes and currently has a very thin beard. His address is [REDACTED], Orlando, FL 32807.

I have asked Mr. Godin for his Boy Scout membership card and he has informed me that it was lost several months ago along with the unit charter and all other membership cards. I have informed Mr. Godin that he is not to participate in any Scouting activities or to represent himself as a Scouter unless and until further notified by this office. I have also notified the scouting coordinator, the troop committee chairman and the executive officer of the chartered partner of this action.



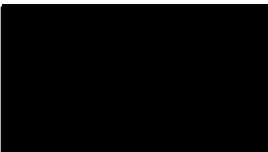
I respectfully request that this individual not be allowed to participate in Scouting anywhere else within our movement until and unless this matter has been cleared and notification of such clearance comes from this council office.
