Molestation suspect captured in Texas

Man to be returned to Clay next week

A Green Cove Springs fugitive captured Wednesday while crossing into Texas from Mexico is expected to be brought back next week to

face Clay County child molestation charges, officials said yesterday.

Wayne Eaton, 46, was arrested in Brownsville by U.S. Customs Service agents as he crossed the Rio Grande River bridge on foot from Matamoros, said Jorge Flores, port director for the U.S. Customs Service in Brownsville.

Eaton is wanted on Green Cove Springs charges of sexual battery on a child and two counts of lewd or lascivious act in the presence of a child, Police Chief Gail Russell said.

Eaton is being held in the Cameron County Jail in Brownsville. He has waived extradition and is scheduled for return to Clay County next Thursday or Friday, said Deputy R.C. Williams of the Cameron

County Sheriff's Office.

Eaton was arrested without incident after a customs service inspector became suspicious because Eaton was acting apprehensively. The inspector ran a routine warrant check, which revealed the Florida charges, Flores said.

During a search of Eaton's home on Idlewild Avenue, police seized hundreds of photographs of young boys and a videotape showing Eaton engaged in sex acts with several teenage boys, Russell said.

Eaton has been a fugitive since Sept. 19 when he failed to appear for a pretrial hearing in Circuit Court. He had been free awaiting court proceedings after posting a \$10,000 cash bond, court records show.

Russell said Eaton apparently has been living near the Mexican resort community of Veracruz since leaving Florida.

Eaton was crossing into Brownsville after his truck apparently broke down, Russell said.

He was carrying his Florida driver's license as well as his birth certificate and later told Texas authorities he was wanted in Florida, Russell said.

**Man who failed to appear
on sex charges sought**

GREEN COVE SPRINGS — A man who has missed two court appearances to answer charges of having sex with a child is being sought by police.

Police Chief Gail Russell said Wayne Eaton, 46, also is suspected in at least 10 other molestations, although he hasn't been charged in those cases.

Eaton, of Idlewild Avenue, has been missing since Sept. 19, when he failed to appear for a pretrial hearing on two counts of committing a lewd and lascivious act in the presence of a child under 6 in July, according to court records.

The hearing was rescheduled for Oct. 3, but Eaton again did not appear.

Russell said anyone who has seen Eaton or knows where he is should call the Green Cove Springs Police Department at 284-5636.

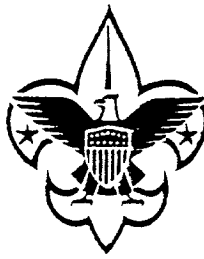

STEVE MOORE AT THE COUNCIL CALLED FRIDAY, MAY 24TH TO LET ME KNOW OF A RECENTLY REPORTED ABUSE SITUATION. PAYMENT FOR COUNSELING HAS BEEN OFFERED TO THREE SCOUTS.

1. LAST WEEKEND SCOUT [REDACTED] d/b [REDACTED] (12 YRS), WAS ATTENDING SCOUT WORLD AT THE NAVAL AIR STATION. WAYNE EATON WAS ALSO THERE AS SURROGATE PARENT FOR TWO BOYS ATTENDING. EATON IS NOT A REGISTERED ADULT VOLUNTEER. EATON WAS AT SCOUT WORLD WITH SOME OF THE BOYS IN PLACE OF THEIR FATHER. [REDACTED] REPORTED THAT HE WAS ABUSED BY EATON AT SCOUT WORLD. [REDACTED] IS ONE OF FIVE OR SIX ADOPTED CHILDREN OF [REDACTED]. ALL OF THE CHILDREN HAD BEEN SEXUALLY ABUSED PRIOR TO THEIR ADOPTION BY THE [REDACTED] AND WERE ALREADY IN COUNSELING. STEVE MOORE OFFERED TO ASSIST WITH THE PAYMENT OF COUNSELING NEEDED AS A RESULT OF THIS RECENT INCIDENT BUT THE PARENTS ADVISE THAT THE COUNSELING THE FAMILY IS CURRENTLY GOING THROUGH WILL SIMPLY CONTINUE WITH NO ADDITIONAL COST INVOLVED.

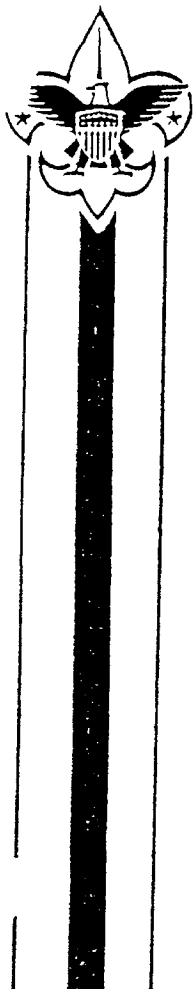

Subject: Wayne Eaton

Date: May 18, 1991

At 12:30 a.m. I was awakened by Mr. James Terry's phone call regarding the abuse of [REDACTED], a Scout in Troop 577 at Scout World 1991 held at the Naval Air Station at Jacksonville, Florida.

After arriving at the Council Camping Headquarters I met with Scoutmaster Paul Thacker and listened as he unfolded the events that had occurred after the boys in his area had gone to bed that evening. I told Mr. Thacker that it appeared to me that a criminal offense had occurred and that we needed to have [REDACTED] share this information with the proper authorities. At that time [REDACTED] and Mr. Thacker rode with me to the Security Headquarters for Scout World. People on Security Duty radioed for Lt. of the Naval Air Station Federal Police Department. Lt. heard what we had to say and we proceeded to the Police Headquarters on the Naval Air Station.

[REDACTED] was interviewed by Officer _ of the Federal Police Department and relayed the following information;

A man by the name of Wayne Eaton who came to Scout World as the surrogate father for [REDACTED] of Pack 146, for whom [REDACTED] had served as Den Chief, was sleeping in the same tent with [REDACTED]. After [REDACTED] had gone to sleep on his sleeping bag and under a blanket, he was awakened to find his Scout shorts and under pants pulled down around his ankles. Wayne Eaton was fondling his penis and [REDACTED] objected told him to stop and pulled his pants back up into normal position. At that time [REDACTED] did not know what to do and finally dosed off. After awhile he was again awakened with his Scout shorts and under pants being around his ankles while Wayne Eaton was fondling his penis, he moved his head to within about 5 inches of [REDACTED] groin area. At that point [REDACTED] pushed him away, objected and left the tent looking for one of the adult leaders. He found Mr. Paul Thacker and Mr. Thacker made contact with District Executive Mark Compton who brought the group to the Council Headquarters area and reported the incident to Scout Executive Jim Terry. Mr. Terry subsequently made the phone call to me as outlined in the first paragraph.

I called [REDACTED], the mother of [REDACTED] who were the brothers with whom Wayne Eaton came to Scout World as a surrogate father. I agreed to meet her at a McDonald's restaurant in Green Cove Springs about 5:30 p.m.

I found that she has dropped her formal married name following a recent divorce and is using the name [REDACTED]. I advised [REDACTED] of the situation with Wayne Eaton and discussed the question with her of the friendliness that Mr. Eaton had shown her sons for the past two years. She said she was not aware of any particular problems that existed in their relationship and the boys had not said anything to her out of the ordinary. I had offered to meet with her and her sons if she felt it would be of help and discuss the issue with them. We agreed to such a meeting at 1:30 in the afternoon on Monday May 20.

At 1:30 in the afternoon on May 20, I arrived at the residence of [REDACTED] and her boys at [REDACTED] in Green Cove Springs, Florida. I had brought a VCR with me and connected it to their television set and following an introductory discussion, we reviewed the video tape "A Time To Tell." Following the conclusion of the tape we advised the boys that Mr. Eaton was suspected of molesting young people as the tape depicted and surfaced the question if they felt any concerns about him and or would like to talk with one of us about that situation. They indicated they would like to talk with their mother and they excused themselves to another room in the house. Following this conversation [REDACTED] indicated to me as I was leaving that there had been some contact to a different degree with each of the boys.

After departing the [REDACTED] residence I went to the Green Cove Springs Police Department and met with Investigator Charles Jeff. Mr. Jeff had not yet heard from Mary Paul of NIS, so I brought him up to date on the events of the weekend. Mr. Jeff indicated that there had been a lot of questions for a great number of years about Wayne Eaton. Street talk had it that he had befriended a lot of low income or retarded people and rewarded them with various things including shoes for apparent sexual favors.

hearing the information that [REDACTED] related to the Police Officers, they met with Naval Investigator Mary Paul. Ms. Paul met us at the Police Department and we proceeded to her office on the Naval Air Station in Greenville. [REDACTED] repeated the information to Investigator Mary Paul who stated the formal complaint. She asked that [REDACTED] have his mother or father come to the base on Monday and be present as [REDACTED] signed the complaint. [REDACTED] agreed to do so.

At the conclusion of this interview we were aware that Wayne Eaton had been removed by Federal Police from the campsite and was in their custody in a room in the same building that we were in. We were also advised that Wayne would be removed from the Naval Air Station and that his Navy decal had been removed from his vehicle and he had received a letter saying he would not be allowed to come aboard the Naval Air Station at anytime in the future. I called [REDACTED] parents, [REDACTED] and [REDACTED] in Green Cove Springs. I explained to [REDACTED] what had occurred and assured her that [REDACTED] was fine and put [REDACTED] on the telephone to talk with [REDACTED]. [REDACTED] assured them that he was okay with the removal of Wayne Eaton from the Naval Air Station he felt fine about the balance of Scout World. [REDACTED] indicated that she would be at the Naval Air Station about 12:00 the next day and I arranged to meet her upon her arrival. At about 4:30 a.m., I returned Paul Thacker and [REDACTED] to their campsite.

At 3:30 p.m. on Saturday May 19, I met [REDACTED] and his mother [REDACTED] in the [REDACTED] area. We had a very pleasant discussion. She expressed appreciation for the way that the situation had been handled. She advised me that she and her husband had adopted five children and had discovered that all five of their children had been previously sexually abused and that they had been in the process of family counseling regarding these issues for quite some period of time. [REDACTED] indicated that although it was very unfortunate that these kinds of things would happen to anybody, that their family was probably better prepared to deal with it than anyone else that she knew of. I advised [REDACTED] of the counseling opportunities that the Boy Scouts have available in the area and they felt there was a need for this kind of attention and she said she would discuss that, and she would be in touch if they felt it was appropriate.

I called Risk Management in Dallas, Texas and talked with Debra Duhs -.

I outlined the circumstances regarding surrogate parent Wayne Eaton and the abuse of [REDACTED] at Scout World last weekend. I discussed with her the issue regarding [REDACTED] and indicated that counseling would probably be needed for [REDACTED]. Debra indicated that she approved counseling and would open a file regarding the issue. The North Florida Council is to pay bills regarding counseling and forward those bills to Dallas for reimbursement.

In conversation with Lt. Edward Mallow staff judge advocate for Captain Delaney at the Naval Air Station [REDACTED] indicates that they have an open file regarding the prosecution of Wayne Eaton.

They are interested in watching very closely and attending the trial of Eaton that will be effected by Green Cove Springs Police Department and using information obtained in the Green Cove Springs prosecution to support their case.

I agreed to contact Detective David Centers to make sure he was up to speed with this information and was advised that he is free to contact Lt. Mallow if he would like to do so.

July 15, 1991

I talked with Det. Centers of Green Cove Springs Police Department and provided him an up date of the U.S. Attorney and the Naval Air Station thoughts. I provided the phone number for Lt. Edward Mallow ([REDACTED]) and he said he would call.
I offered additional help if needed.

Man who failed to appear on sex charges sought

GREEN COVE SPRINGS — A man who has missed two court appearances to answer charges of having sex with a child is being sought by police.

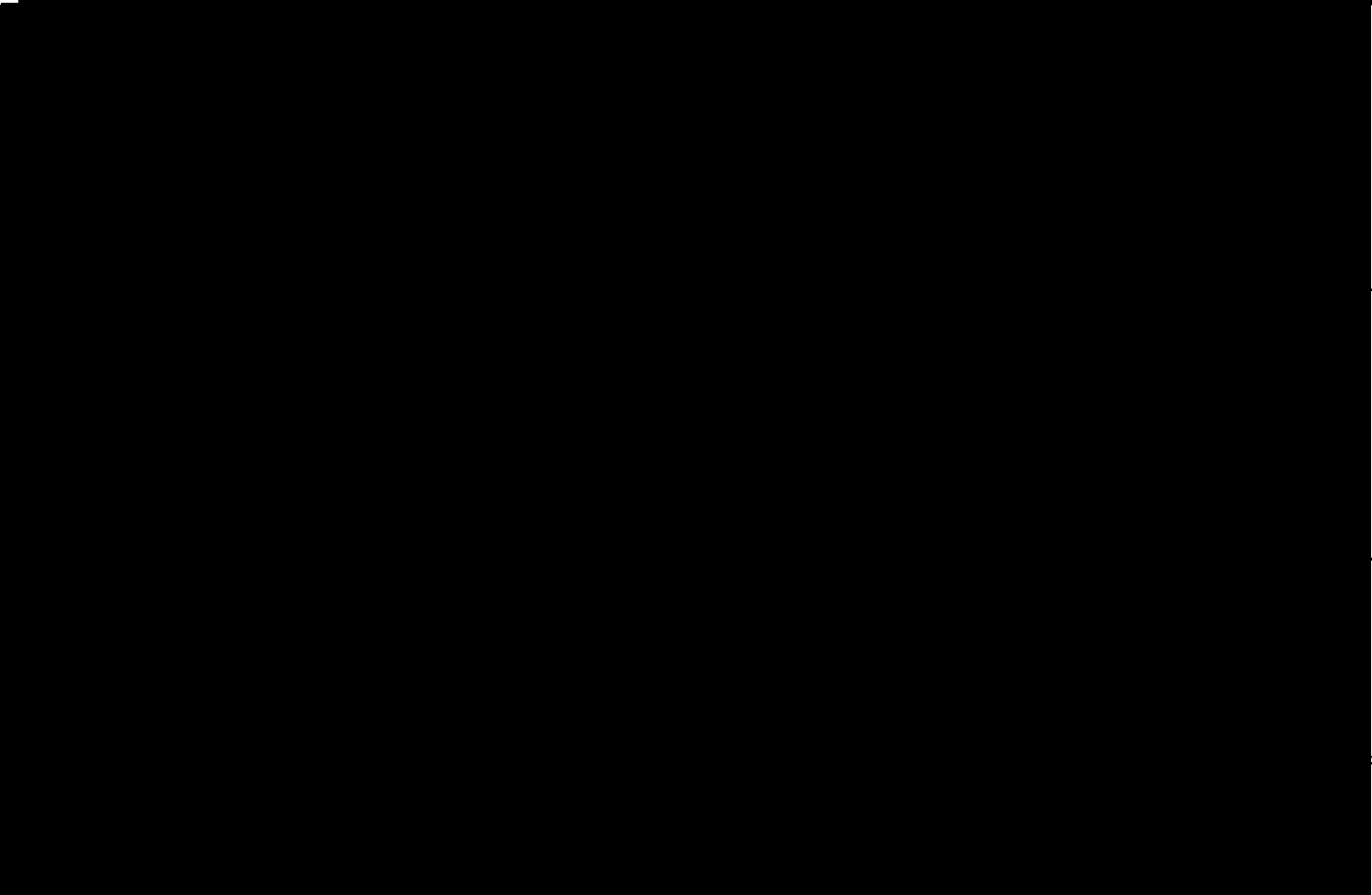
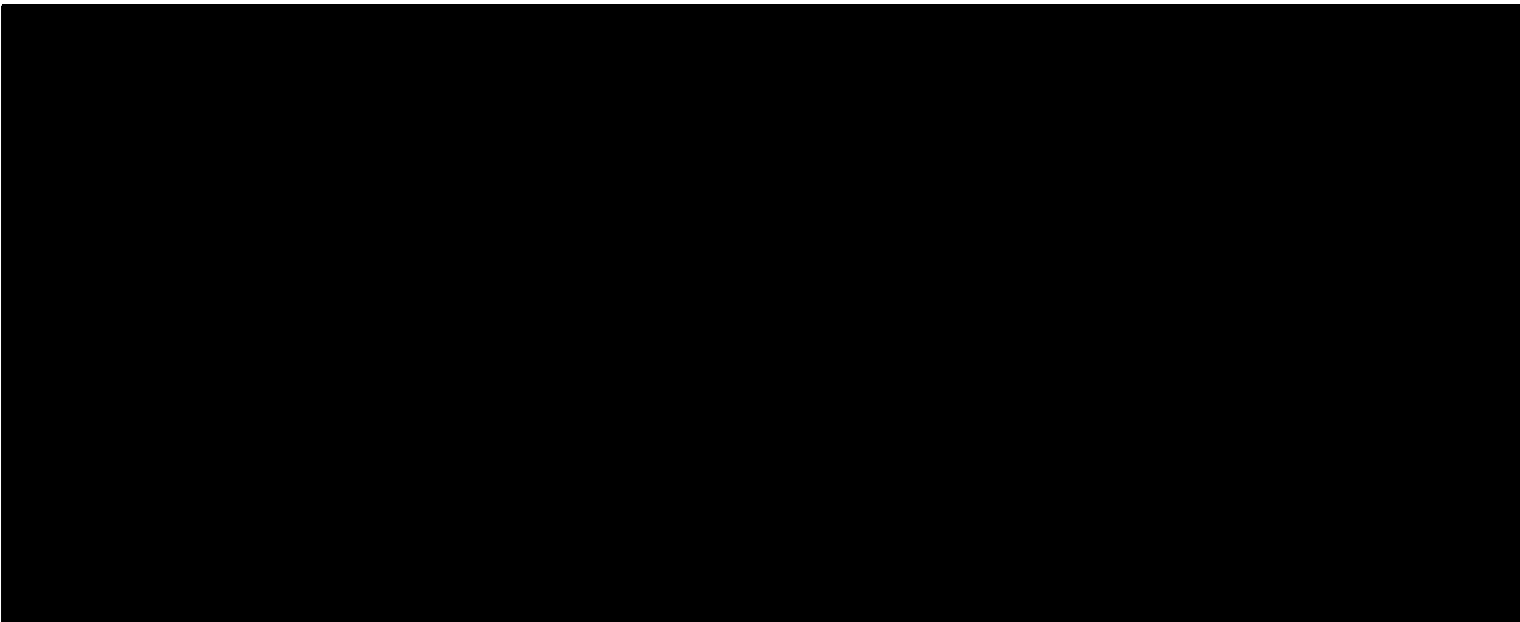

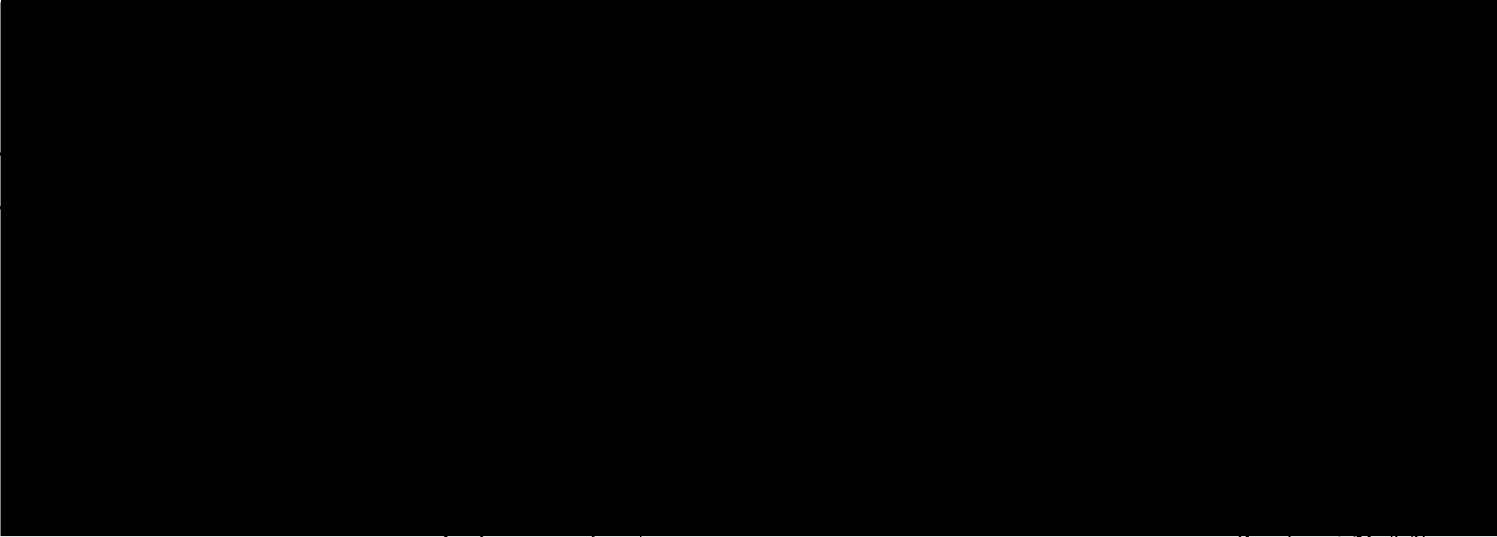
