Police Chief Gail Russell said Wayne Eaton, 46, also is suspected in at least 10 other molestations, although he hasn't been charged in those cases.

Eaton, of Idlewild Avenue, has been missing since Sept. 19, when he failed to appear for a pretrial hearing on two counts of committing a lewd and lascivious act in the presence of a child under 6 in July, according to court records.

The hearing was rescheduled for Oct. 3, but Eaton again did not appear.



Date: May 18,1991

At 12:30 a.m. I was awakened by Mr. James Terry's phone call regarding the abuse of _______, a Scout in Troop 577 at Scout World 1991 held at the Naval Air Station at Jacksonville, Florida.

After arriving at the Council Camping Headquarters I met with Scoutmaster Paul Thacker and listened as he unfolded the events that had occurred after the boys in his area had gone to bed that evening. I told Mr. Thacker that it appeared to me that a criminal offense had occurred and that we needed to have share this information with the proper authorities. At that time and Mr. Thacker rode with me to the Security Headquarters for Scout World. People on Security Duty radioed for Lt. of the Naval Air Station Federal Police Department. Lt. heard what we had to say and we proceeded to the Police Headquarters on the Naval Air Station.

was interviewed by Officer _ of the Federal Police Department and relayed the following information;

A man by the name of Wayne Eaton who came to Scout World as the surrogate of Pack 146, for whom had father for served as Den Chief, was sleeping in the same tent with . After had gone to sleep on his sleeping bag and under a blanket, he was awakened to find his Scout shorts and under pants pulled down around his ankles. Wayne Eaton was fondling his penis and objected told him to stop and pulled his pants back up into normal position. At that time did not know what to do and finally dosed off. After awhile he was again awakened with his Scout shorts and under pants being around his ankles while Wayne Eaton was fondling his penis, he moved his head to within about 5 inches of groin area. At that point pushed him away, objected and left the tent looking for one of the adult leaders. He found Mr. Paul Thacker and Mr. Thacker made contact with District Executive Mark Compton who brought the group to the Council Headquarters area and reported the incident to Scout Executive Jim Terry. Mr. Terry subsequently made the phone call to me as outlined in the first paragraph.

I called who were the brothers with whom Wayne Eaton came to Scout World as a surrogate father. I agreed to meet her at a McDonald's restaurant in Green Cove Springs about 5:30 p.m.

I found that she has dropped her formal married name following a recent divorce and is using the name . I advised of the situation with Wayne Eaton and discussed the question with her of the friendliness that Mr. Eaton had shown her sons for the past two years. She said she was not aware of any particular problems that existed in their relationship and the boys had not said anything to her out of the ordinary. I had offered to meet with her and her sons if she felt it would be of help and discuss the issue with them. We agreed to such a meeting at 1:30 in the afternoon on Monday May 20.

I had brought a VCR with me an connected it to their television set and following an introductory discussion, we reviewed the video tape "A Time To Tell." Following the conclusion of the tape we advised the boys that Mr. Eaton was suspected of molesting young people as the tape depicted and surfaced the question if they felt any concerns about him and or would like to talk with one of us about that situation. They indicated they would like to talk with their mother and they excused themselves to another room in the house.

Following this conversation indicated to me as I was leaving that there had been some contact to a different degree with each of the boys.

After departing the residence I went to the Green Cove Springs Police Department and met with Investigator Charles Jeff. Mr. Jeff had not yet heard from Mary Paul of NIS, so I brought him up to date on the events of the weekend. Mr. Jeff indicated that there had been a lot of questions for a great number of years about Wayne Eaton. Street talk had it that he had befriended a lot of low income or retarded people and rewarded them with various things including shoes for apparent sexual favors.

At about 4:30 a.m., I returned Paul Thacker and to their campsite.






