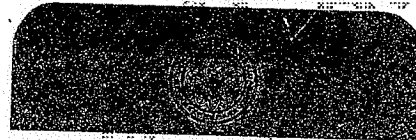

East Liverpool man is charged

William Caldwell, 25, of 506 Sugar St., East Liverpool, was charged with contributing to the delinquency of a minor Friday.

Four city policemen, including detective Capt. William Mooney and juvenile officer Kenneth Montgomery, with county investigator Ronald Gause, raided Caldwell's home at 4:40 p.m. They said they confiscated seven obscene movies and a large quantity of pornographic books and magazines.

The material had allegedly been shown to a local youth.

Bond was set at \$2,000 and Caldwell was released on the authority of Judge Louis Tobin of the county juvenile court.

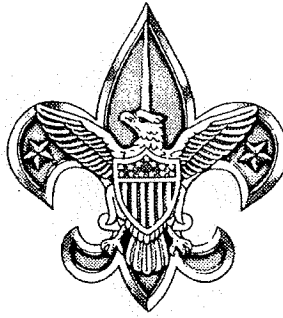
