
Dear Paul:

I am forwarding to you information concerning the above named individual. We have suspended his registration based upon a call concerning the individual's past. The report which I received mentioned abuse while the individual was a minor. I have confirmed with Dade County HRS that this individual is carried in their computer file of suspected abusers.

Based upon that information, we suspended Mr. Draher's registration. I have spoken to Mr. Draher and asked him to sign a release form which will allow HRS to release information concerning his record. To date, he has not complied.

I will let you know if further developments occur.
