I spent two weeks at Camp Towadena (spelling not certain) in August of 1966. At the end of this period Mr. Bill Donovan, the camp director, invited me to stay for an extra week. With my mother!s concurrence I accepted this invitation.

During this week some of the other house and menting with hyperson.

During this week some of the other boys and I were experimenting with hypnosis. On the next to last evening of this "Explorer Week" Mr. Donovan approached me and stated that he had heard about these experiments and wanted to know more about it. He said that he would come to my tent to talk to me about it. I assumed that he wanted to see somebody hypnotized and had one of the other boys there. When Mr. Donovan arrived and found the other boy there he seemed quite suprised.

He had me bring the other boy out of the x trance and we both escorted this boy back to his own tent. At this time he ordered everybody back to their own tents. He and I stood there for a time talking, I assumed that he wanted to bawl me out for having messed around with hypnosis. He then asked me to walk down to his tent with him to discuss the matter further.

When we arrived at his tent he sat down on one bunk and I sat down on the other and he proceeded to tell me that he had studied psychology at college and knew all about hypnosis and such other things and that he was working on the development of an electronic brainwave synchronizer to be used in hypnosis. We also discussed camp and it s History.

At this point I would like to mention that about three nights earlier Mr. Donovan had said to me "I'll bet that if I walked in to your tent and caught for masturbating you'd be embarassed" I said that I had never thought about it. He then told me that there is nothing really wrong with masturbating but that society frowns on it.

By this time it had sotten quite late and quite chilly. Mr. Donovan had a blanket on his bunk, he invited me to come over and share it. I declined. He said "don't worry I wont bite you" I said that I knew he wouldn't and then because he was insistent about It I finally joined him. We lay there for a while, under the blanket, talking. Then Mr. Donovan started to run his fingers up and down my leg and asked if he could "fool around a little bit". I said "I don't care". He put his hand inside my pants and reached for my penis. the pants were tight so he withdrew his hand opened my belt and unzipped my pants. He pulled my pants and my undershorts down and once again began to play with my penis and then masturbated me. When that was over he leaned over and xxx took my penis in his mouth and caused me to have another orgasm: When this was over he asked me not to say anything about it to anyone because it could affect his reputation and his job. T spent the remainder of that night in the other bunk in his tent. Nothing more was said about the incident from that time on. However later that winter he called me at frome of several occasions and asked me if we could get together for a movie or a camping trip. On each occasion I told him that I couldn't make it.

In the spring I received from him an application to return to camp as a CIT. I did not wish to return and face him again. At this point I contacted Mr. explained the circumstances and asked for his advice. This is the result.

This is by way of a progress report regarding William Donovan who was accused of immoral acts by a box.

I made arrangements for him to have an examination by Dr. Robert Garber at the Carrier Clinic, Belle Mead, N. J.

Dr. Garber talked to me on the phone, advised that there is no need to rush this case but that Bill Donovan should be employed by another organization. He suggested something like the Red Cross.

His case is not of the nature that he would be dangerous to anyone. However, for his good, and rehabilitation, he should be working in some other line than Scouting.

Dr. Garber also suggested that he re-enter the professional service of the Boy Scouts of America sometime in the future, if he wished.

Dr. Garber has also given Donovan the names of several psychiatrists who live in the vicinity of his home so that he could have psychiatric treatment.

During the hext several days I expect to get a statement from the boy involved and will give this to you for the file.

We have advised Dave Boshea, Scout Executive of the Alexander Hamilton Council, to help Donovan get a job in a normal way in some other line of work.




